ORGANIZATIONAL HISTORY

The Bowling Green Ministerial Association was re-organized on 8 September 1919; it is unclear when the organization was originally founded. The minutes for the 8 September 1919 meeting indicate: "It was decided to reorganize at once. Dr. Houze automatically retired as President, and Dr. Galloway automatically succeeded him as President." No articles of incorporation nor a constitution for the organization has survived. The 1960 revised membership form does indicate the two-fold purpose of the organization: "to provide an opportunity for ministerial fellowship and understanding and to consider and concert measures by which the ministers can cooperate effectively for the interests of the Kingdom, and the good of the community, in a spirit of brotherhood and under democratic forms and methods." The group was clearly ecumenical and included representatives from the Catholic Church as well as most of the mainline Protestant denominations.

The Association did meet after 1978 and continued to sponsor ecumenical holiday services, but the organization weakened and minutes were not kept. It is believed that the organization finally ceased to exist in the late-1990s.

COLLECTION NOTES

Box 1 contains record books of the Association in five year periods. These books contained all the Association records in a chronological format, including minutes, news clippings, reports, and financial records.

The items in Box 2 came at a later date and were not kept in record books as had the material in Box 1. This allowed the collection to be arranged in a more typical format by record type: membership information, minutes, correspondence, financial records, and miscellaneous. Within these record types, the materials are arranged chronologically. Of particular interest is the group's participation in a voluntary hospital chaplaincy program, its leadership role in conducting ecumenical Thanksgiving and Easter services, shared responsibility for a Sunday morning radio program, limited social work within the community, and its sponsorship of a summer Vespers program at Western Kentucky State College in the 1950s (Folder 11). The group also sponsored programming or advocated for alcohol and drug abuse counseling, removal of pinball machines,

cessation of gambling at the County Fair, prohibition of the sale of alcoholic beverages, improved religious television programming, decency and modesty in movies, and other social issues. The group's work can easily be traced through the minutes and the correspondence. The Vespers programs held in the 1950s were a popular summer activity. Although held on the campus of Western Kentucky State College, the entire meeting

The minutes indicate that the group met monthly, but enjoyed only sporadic meetings during the summer months. Minutes are occasionally missing, but there is a full run from 1919 to 1978
