#### **BIOGRAPHICAL NOTE**

Almon V. Butram was born on 24 March 1910, in Edmonson County, Kentucky, the son of Frank Almon and Lou (Hogan) Butram. He attended school at the Drippings Springs school in Edmonson County. Butram married Ruth Paxton (1909-1980) on June 8, 1930, and they operated a farm in northern Warren County. They are interred in the Rocky Hill Cemetery in Edmonson County.

### **COLLECTION NOTE**

This small collection contains information related to the operation of Butram's farm. Also included are sundry legal and financial papers for Butram. Receipts for Gladys Paxton's funeral are of particular interest.
