CALL TO ORDER

A regular meeting of the SGA was called to order at 5:00 p.m. by Administrative Vice-President Tara Higdon.

READING OF THE MINUTES

It was moved to suspend with the reading of the minutes. Motion passed.

OFFICER REPORTS

Brandon Rucker, Treasurer--Treasurer Rucker reported that expenditures for the week were \$100.00, which brings the account balance as of November 22 to \$31,180.49. Organizational Aid checks are being delayed because of problems with the Purchasing Department. Vice-President Higdon announced that any junior or senior interested in Golden Key National Honor Society should meet with


