Section 3. That the cost of construction of the project shall be payable solely and only from special obligation bonds to be hereinafter authorized by this Board of Regents, together with any funds received from the United States of America on account of the grant.

Section 4. The Board of Regents shall convene at its usual place of meeting at the time and place set forth in Section 2, hereof, for the purpose of receiving bids.

Section 5. All resolutions or parts thereof in conflict herewith are hereby repealed.

All bids shall be enclosed in an envelope, sealed and addressed, accompanied by a certified check amounting to 5 per cent of the proposal. In lieu of the foregoing the bidder may submit a Bidder's Bond. In the event the successful bidder fails to execute a contract, said check shall be forfeited to the Western Kentucky State Teachers College as liquidated damages. Contract shall be secured by a surety Bond, properly executed, for an amount equal to the contract price. Said Bond to be in same Surety Company, satisfactory to the State Director of P.W.A.; and delivered to the Western Kentucky State Teachers College within 7 days after notice of award of Contract, said Bond to be in accordance with the plans and specifications.

The award of this contract is contingent upon the securing of an acceptable bid which will fall within the amount of funds available for the construction of the project.

The Board of Regents of the Western Kentucky State Teachers College reserves the right to make such changes in the design and the extent of the works as may be necessary to reduce the cost of the project to within the limit of the funds available; provided such reduction does not affect the total estimate more than 20 per cent.

Pursuant to a resolution of the Board of Regents at a called meeting at Madisonville on November 29, 1935, there met in the office of President H. H. Cherry, Bowling Green, Kentucky, at 4:00 P.M., on the 14th day of December 1935, the following regents: Mr. Henry B. Hines, Bowling Green, Kentucky, Mr. Charles G. Franklin, Madisonville, Kentucky, and Mr. Clarence Bartlett, Hartford, Kentucky. Of the members of the Board who could not be present there were Mr. M. O. Hughes, who was too ill to appear, and Superintendent James H. Richmond, who expressed his regret at not being able to come.

In addition to the individuals mentioned, there were in attendance representatives of Mr. George H. Sager, Jr., Louisville, Kentucky, State Director of P.W.A. of the United States of America.

A quorum being present, upon motion made, duly seconded, and unanimously passed, Mr. Charles Franklin was elected chairman and presided.
