BIOGRAPHICAL NOTE

Henry Larmon was born on 20 October 1809 at the Logan County, Kentucky home of his parents, Edward and Susannah (Myers) Larmon. He married Elizabeth Ackerman in Logan County, Kentucky, on 27 December 1836, and they had four children together in Logan County. Elizabeth died in 1846 and one of their children, Ruphinah, died in Logan County; they are buried on the old Larmon homeplace. In the mid-1840s, Larmon moved to Bowling Green with his three older children: Conley, Sardenia and Mary Vashti. He married his wife's sister, Mary Ackerman, on 14 February 1849. Henry built a large two-story white frame house out of yellow poplar overlooking Trammel Creek. He operated a grist and saw mill on Trammel Creek and farmed a large tract of land in the vicinity of Alvaton. When Henry's second wife died, he married Mary J. Thomas on 7 October 1875. Henry died on 12 May 1882 and is interred at Bethany Baptist Church in southern Warren County, Kentucky.

COLLECTION NOTE

This collection consists of financial records—receipts, promissory notes, leases, etc.—connected to Henry Larmon of Warren County, Kentucky. Many of the items relate to timber purchases (particularly poplar and oak logs), land leases, and purchases of household goods.
