Members present in addition to Mr. Spragens and Dr. McCormack were Mr. Bemis Lawrence, Mr. Sheridan Barnes, and Dr. Robert R. Martin, Chairman. There were also present President Kelly Thompson, Miss Florence Schneider, Bursar, Mr. Robert G. Cochran, Public Felations Director, Mr. Jerry Miller, Division of Budget, Frankfort, and Miss Etta J. Runner, Secretary.

The Chairman called the meeting to order and presided. He welcomed the two new members of the Board.

President Thompson also expressed appreciation, on behalf of the college, to Mr. Spragens and Dr. McCormack for their willingness to serve Western in its great work.

Upon motion of Mr. Barnes with a second by Mr. Lawrence the minutes of the meeting of the Board held on March 9, 1956, were unanimously approved.

President Thompson presented the budget for 1956-57 stating this budget was the largest in the history of Western. He stated they had made a thorough study of the budget and that both he and they believed it is a sound document.

The President then asked Mr. Miller to make a few statements concerning the budget.

President Thompson explained the new salary schedule which the college was attempting to put into operation, and reported that the objective would be reached in approximately 90% of the cases in the 1956-57 budget.

The next item of business presented by President Thompson was new personnel as set up in the budget. After a discussion Mr. Lawrence moved that the Board direct President Thompson to continue in the direction outlined to get new members of the faculty. Dr. McCormack seconded the motion which was unanimously adopted.

The Chairman read a letter addressed to the Board of Regents from Mr. Herbert J. Smith, Acting Regent and Trustee of Ogden College. Mr. Lawrence moved that the letter be incorporated in the minutes of the Board and that President Thompson be authorized to write a letter of appreciation to Mr. Smith on behalf of the Board of Regents for the interest as manifested in his letter. With a second by Mr. Barnes the motion was unanimously adopted. Mr. Smith's letter follows:

LETTER

June 21, 1956

Board of Regents Western Kentucky State College

Gentlemen:

I am indeed sorry that I am not able to be with you on this occasion, however other business prevents me from attending. But it is with a great

deal of pleasure and confidence that as representative of the Ogden Board of Trustees that we are able to renew the Ogden College contract with Western Kentucky State College for the third time since 1928 when the two schools were merged. As in the past lease, we anticipate giving more scholarships than were available at the time that Ogden College was operating.

We were deeply grateful to President Thompson and the Western Board of Regents for renewing this lease with the Ogden Board of Trustees. We feel that this arrangement is of great value in furthering the educational opportunities for the youth of Bowling. Green, Warren County and the State of Kentucky, as was foreseen by the wills of Robert W. Ogden and R. C. P. Thomas. We are looking forward with great confidence that the education of Kentucky youth will be enhanced by the renewal of this contract.

The Ogden Board of Trustees wishes at this time to state its complete confidence in the administration of President Kelly Thompson, and pledges its unqualified support of President Thompson and his operation of Western.

President Thompson presented a copy of the proposed lease contract between Ogden College and Western, stating that the present lease contract does not expire until December 31, 1957. After a discussion Mr. Spragens moved the adoption of the following resolution:

BE IT RESOLVED By the Board of Regents of Western Kentucky State College that President Kelly Thompson, be authorized to sign and acknowledge on behalf of the Board of Regents of Western Kentucky State College a contract and agreement of lease by and between Cooper R. Smith, Jr., Regent and Trustee under the will of Robert W. Ogden, Trustee under the will of John E. Robinson, and Trustee under the will of R. C. P. Thomas, acting by and through his duly authorized and constituted Attorney-in-Fact, Hervert J. Smith, and Herbert J. Smith, Acting

regent and Trustee of Ogden College, by the terms of which the Western Kentucky State College leases the following described real estate located in Bowling Green, Warren County, Kentucky:

The Ogden campus located on State and Fourteenth Streets and the Nashville Boulevard, containing seven or eight acres of ground, and being the same property purchased by the Board of Trustees of Ogden College from the Methodist Episcopal Church, South, together with all buildings on same and all equipment belonging to said college.

The motion was seconded by Mr. Lawrence and unanimously adopted.

The Contract and Agreement of Lease follows:

CONTRACT AND AGREEMENT OF LEASE

THIS CONTRACT AND AGREEMENT OF LEASE made and entered into this June 25, 1956, by and between Cooper R. Smith, Jr., Regent and Trustee under the will of Robert W. Ogden, Trustee under the will of John B. Robinson, and Trustee under the will of R. C. P. Thomas, acting by and through his duly authorized and constituted Attorney-in-Fact, Herbert J. Smith, Acting Regent and Trustee of Ogden College, parties of the first part, and Western Kentucky State College, acting by and through E. Kelly Thompson, President thereof, party of the second part,

WITNESSETH: That Whereas a contract made on the 19th day of November, 1927, by and between the Trustees of Ogden College and the Regents of Western Kentucky State Teachers College expired on January 1, 1948; and whereas, a supplemental or renewal contract was entered into on December 19, 1947, between the same parties and will expire on December 31, 1957; and

WHEREAS, Ogden College operated as a collegiate educational institution in Warren County, for more than fifty years and furnished and provided education for many young men in Warren County and the State of Kentucky; and whereas, the real estate constituting the campus of Ogden College constitutes an improved collegiate campus with buildings on same for college and scholastic purposes; and whereas, Ogden College,

due to increasing expenses and lack of sufficient endowment, is not now able to meet the standards required for a junior or senior college; and whereas, Western Kentucky State College has been for many years established in Bowling Green, Kentucky, wherein it maintains a collegiate institution and is successful in providing education for both boys and girls from Warren County and the State of Kentucky, and meets all standards required for a collegiate educational institution; and

WHEREAS, the college campus of Ogden adjoins and lies in close proximity to the plant and property of Western Kentucky State College; and whereas, Western Kentucky State College is open to young men from Warren County and the State of Kentucky and is performing a service similar to that required under the Will of Robert W. Ogden with complete and adequate facilities therefore

NOW THEREFORE, the said party of the first part does hereby lease unto the party of the second part for a period of ten years beginning on January 1, 1958, and ending on December 31, 1967, and under the conditions herein set forth, the following described real estate located in Bowling Green, warren County, Kentucky:

The Ogden campus located on State and Fourteenth Streets and the Nashville Boulevard, containing seven or eight acres of ground, and being the same property purchased by the Board of Trustees of Ogden College from the Methodist Episcopal Church, South, together with all buildings on same and all equipment belonging to said college.

The conditions of this agreement are as follows:

(1) The Ogden Campus and the college buildings thereon are to be used for college and scholastic purposes by the party of the second part during the term of this lease, and during the term hereof the first party shall maintain the exterior of said buildings and the second party shall maintain and keep in good repair the interior thereof, and shall lkiewise maintain the campus and grounds, and same shall be returned at the end of this lease in as good condition as when received, less natural and unavoidable depreciation, and excepting injuries and destruction by Act of God or other unavoidable casualties. The Regent of Ogden College shall keep the buildings on said property insured for the benefit of

the Ogden College during the term of this lease. Any material or major change in the grounds or buildings during the term of this lease shall be approved by the first party. All street assessments against the property now existing and hereafter made shall be paid by the party of the second part.

- (2) The Ogden campus and the school conducted thereon shall be known and designated as the Ogden Department of Science of Western Kentucky State College, thus continuing the name and purpose of the original endowment.
- (3) During the term of this lease, the net annual income of the John . Robinson Estate shall be utilized for a professor-ship in the Ogden Department of Science of Western Kentucky State College, which professor-ship shall be agreed upon from time to time by the President of Western Kentucky State College and the Regent and Trustee of Ogden College.
- (4) All students of Warren County and the State of Kentucky shall be admitted to the Western Kentucky State College and receive instruction therein without charge, unless otherwise required by law, provided, however, that said students may be required to pay such fees and incidental charges as are charged to all students attending the institution. This restriction shall not include tuition fees for special courses, such as music, not included in the courses offered free to all students, and shall not extend to students attending the training school maintained and operated by the second party.
- (5) In order to carry out the spirit and the purpose of the wills of Robert W. Ogden, John B. Robinson and R. C. P. Thomas, it is agreed between the parties hereto that the first party may set aside and designate each year such income from the estates and properties controlled by the first party as is deemed advisable, and may therefrom with said funds provide scholarships for deserving students from Warren County, which students shall be selected and designated by the first party and the Board of Trustees of Ogden College which shall each year certify to the second party the name and address of each student to whom any such scholarship may be granted, together with the amount thereof. The funds provided for said scholarship shall be used at Western Kentucky State College for the payment of incidental, laboratory or other fees as the Regent and Trustee of Ogden College may determine or direct, it being understood that tuition at said Western Kentucky State College shall be free to all students of the State of Kentucky unless otherwise provided by law.

- (7) The first party hereto and the Trustees of Ogden College may during the term of this contract provide for honors in the form of medals or other emoluments to students at Western Kentucky State College in accordance with the terms and the spirit of the wills of Robert W. Ogden, John E. Robinson and R. C. P. Thomas.
- (8) The building known as Perry Snell Hall on the campus of Ogden College, and the building known as Ogden Hall on the Ogden Campus shall during the term of this contract retain the names PERRY SNALL HALL AND OGDEN HALL.

Mr. Thompson reported that the cellege had received the securities from the National Newark and Essex Banking Company, Trustees under the will of Ella Porter McKinney; that he had Coleman, Harlin & Orendorf, attorneys, go over the securities to ascertain if all were sound. At this point he read the fellowing letter from Coleman, Harlin & Orendorf:

Dear Mr. Thompson:

Judge Coleman and I have gone over the port-folio of securities forwarded to you by the National Newark and Essex Banking Company, Trustees under the will of Ella Porter McKinney and to be administered by the school as a trust fund for scholarships to be used by students of Butler County.

It appears from the examination of these securities and from the trustee's report which we have reconciled with the original report and inventory at the time the Trust was created that all securities to which the college is entitled were inclosed and that all are either made to bearer or have properly been transferred to "Western Kentucky State Teachers College."

We specifically wish to call your attention to the letter from George Barker, Jr., Trust Officer of the National Newark and Essex Banking Company, to the effect that a Series G.U.S. Saving Bond due March 1, 1958, and a part of the corpus of this estate to which Western is entitled is in process of redemption at par and accordingly an additional \$1,000 in cash will be forthcoming to you during the month of June.

Included from the Trustee were checks on the
National Newark and Essex Banking Company in the sum of
\$2,132.30 and in the sum of \$1506.46. The latter check
represents receipts from sale of securities and is a portion
of the corpus of the Trust Fund and should be reinvested.
The former check is a distribution of net income and this
\$2,132.30 is therefore available for use as directed under
the terms of Ella Porter McKinney's will. The \$1,000 te

be received from the sale of Government Bond above mentioned will also be a portion of the corpus and should be reinvested.

We have made a rather summary analysis of the investments on hand and the possible income to be expected therefrom and it appears that as the investments now stand and including net income of \$62.50 per month from Western's share of the building in Jackson, Tennessee, that you may expect an annual income of approximately \$1,700.00 for scholarship purposes. This figure, of course, is based upon the anticipation that the earnings from the corporate stocks will in the future years be approximately the same as in the past two years.

Since we have gone over these securities we believe it will now be in order for you to execute the original receipt and to send it to the National Newark and Essex Banking Company. This receipt should be accompanied by a letter from you pointing out the fact that you are expecting the \$1,000 from the sale of the Series G Bond when it is received at which time you can execute an additional receipt for that sum.

After a discussion of needed buildings, Mr. Lawrence moved that the Board authorize President Thompson to secure the services of

an architect to work on future construction plans at a fee not to exceed \$5,000. With a second by Mr. Barnes the motion was unanimously adopted.

Motion to adjourn was unanimously passed on motion of Mr. Lawrence with a second by Mr. Barnes.

A delicious steak dinner was served at 5 o'clock following the Board meeting.

Minutes of Board Meeting

The Board of Regents of Western Kentucky State College met in Louisville, Kentucky, at the home of Mr. Bemis Lawrence, at 4 p.m. Wednesday, December 19, 1956.

The meeting was called to order and there were present Dr. Robert R. Martin, chairman, Mr. Bemis Lawrence, Mr. Robert Spragens, and Mr. Sheridan Barnes; also President Kelly Thompson. Dr. W. H. McCormack was unable to attend.

Mr. Lawrence moved that the reading of the minutes of the last meeting of the Board held on June 25, 1956, be dispensed with and adopted since each member had previously received a copy of the minutes. Mr. Barnes seconded the motion which was unanimously passed.

President Thompson reported to the Board that as far as he could determine the college was in fine shape and that excellent progress was being made. He stated the enrollment was the largest it has been since the early thirties and the general welfare of the college was good.
