ORGANIZATIONAL HISTORY

Barren County lies in south-central Kentucky, midway between Louisville and Nashville, and covers an area of 482 square miles. It is bounded by Hart, Edmonson, Warren, Allen, Monroe and Metcalfe counties. The Kentucky General Assembly created Barren County on 20 December 1798 from parts of Warren and Green counties. Glasgow is the county seat of Barren County.

COLLECTION NOTE

This collection consists of three indices generated by the Barren County Quarterly Court. Two of the indices are not dated; the third is dated 1916. All three indexes were loose from the original bindings which were severely warped; the bindings were removed and the indices placed in acid-free folders. The Kentucky Building was given only the indices; the actual court records are assumed to still be in the Barren County courthouse. These indices were purchased at an estate auction in Petros, Kentucky in the early-1980s.
