President Garrett next submitted a Lease Agreement executed between the City Board of Education of Bowling Green and the Board of Regents of Western Kentucky State Teachers College covering the use of the college athletic field by the City Board of Education in return for the erection of lights on said field by the City Board of Education as drawn by Judge John Rodes pursuant to the action of the Board of Regents at its meeting on May 25, 1946. The lease as drawn follows:

CONTRACT

This contract by and between the Board of Regents of the Western Kentucky State Teachers College (hereinafter called the College), party of the first part, and the Bowling Green Board of Education (hereinafter called the City Board), party of the second part,

WITNESSETH

That the College does hereby lease to the City Board its athletic field known as the stadium under the terms and for the purposes hereinafter set out for a period of twenty (20) years beginning July 1, 1946, and ending June 30, 1966.

Eupl.cyapat.

It is agreed that during the period above mentioned the City Board shall be permitted to use the athletic field and stadium of the College for its regularly scheduled Senior High School football games. It is understood, however, that this does not include the use of such field and stadium for football practice by the football teams of the Senior City High School.

In lieu of rent for the use of the above mentioned premises as set out above, it is agreed that at the end of the period of the lease, the lighting equipment installed as hereinafter provided shall become the property of the College.

It is further agreed that the City Board shall equip and install the above mentioned athletic field with good and sufficient electric lighting, such lighting system to be Class A and to be approved by the College authorities; and the City Board shall pay all expenses of such lighting equipment and its installation, and shall see to it that the same shall be maintained in good condition and not be encumbered by any mechanics, material mens or other liens.

The College agrees to provide during the term of the lease a dressing room for visiting teams contesting with the Senior High School teams and also facilities for shower baths for such visiting teams, and shall provide a conference room for the local high school teams, both before the game and during the intermission. The City Board shall be responsible for any and all damages beyond ordinary wear and tear done to the College property because of or during the use of the above mentioned field and stadium for football games, and shall further be responsible for all expenses incurred in connection with such games.

It is further agreed that during the period while such games are being played and including the time required for the admission and seating of spectators, the City Board shall provide for the proper supervision of parking, the handling of the crowd and the conduct of the game, having full authority to do so, the same being granted to them by the College.

It is further agreed that either party to this contract shall have the option at the end of any five year period, beginning with the date of this lease, to cancel the same. If the same is thus cancelled by either party, then the College shall have the option to buy the lighting fixtures and equipment installed and maintained by the City Board at their original cost, including the cost of installation, less, however, 1/20 of such amount for each year during which the agreement has been in force. If the

College does not care to exercise this option, then the City Board shall remove the said equipment at its own expense on condition that the grounds of the College be restored to their original condition.

During the period of this lease, the College shall have the right to use the above mentioned lighting equipment installed by the City Board for its own games and other activities of the College with no charge except the payment of the actual expense of its operation of such lighting equipment, together with any damage that might occur to same during their use of it and because of their use of it.

The schedule of regular games to be played by the Senior High School of the City Board shall be submitted to the College and determined after conference by mutual agreement.

This contract shall take effect when signed by the.

Superintendent of Public Instruction of the State of Kentucky and the President of the College and by the Chairman of the City Board of Education and its Secretary.

An objection was raised to the Lease by members of the Board on the ground that no provision was made for the City Board of Education to assume liability for damage to persons and property during the time they were using the College grounds. It was recognized that the College has such liability for Vesper Services and its own public activities, including athletic contests, to which the public has access both as to the public and its student body but that in case of damage or injury it is necessary to secure permission of the State Legislature to sue for damages and that such damages if awarded are a charge not against the college budget but against the State's General Fund. The members of the Board however felt the additional liability for those occasions when the college grounds were used by the City Board of Education should be incurred by the City Board of Education and not by the College. Judge Dawson moved therefore that the following paragraph be incorporated into

the Lease Agreement and submitted to the City Board of Education for its consideration with the request that it be added to the Lease Agreement.
