Katie Dawson appointed Josh Collins to LRC chair. There was no discussion or debate. *Collins was approved with a unanimous vote.*

### **Unfinished Business**

#### **Bill 02-05-F Documentary Event Funding**

Lindsey Lilly was recognized as the author, explaining that this legislation should be fairly self-explanatory, and that the topic is important to think about and it adds to Civic Engagement that we supported last year, and that it hopefully will be similar to last year's Debate Watch. During questions, Ericka Johannes asked what time this would take place. Lilly said that there was no time set yet, and the date of October 17<sup>th</sup> would be changing also. Jessica Williams asked why it was so expensive to rent the wall of Academic Complex. Lilly said that this was for the area as well as the set up. During debate, Lilly proposed a friendly amendment omitting "on October 17, 2005" in the PURPOSE clause. Lilly also proposed the friendly amendments to add the word "the" before "Student Government Association" in the 6<sup>th</sup> WHEREAS clause and to omit "on October 17, 2005" in the THEREFORE clause, ending this clause with "Cancer documentary". Lilly proposed the friendly amendment to add the Student Affairs Committee as a sponsor. *There was a motion and second to accept. The legislation was passed unanimously.*
