MINUTES OF MEETING OF BOARD OF REGENTS WESTERN KENTUCKY UNIVERSITY April 13, 1967

A regular quarterly meeting of the Board of Regents of Western Kentucky University was held on Thursday, April 13, 1967, at 11 a.m., EST, at the Kentucky Hotel in Louisville, Kentucky, pursuant to KRS 164.340.

The meeting was called to order by the Chairman, Dr. Harry M. Sparks.

Other members present were Mr. Douglas Keen, Dr. W. Gerald Edds, Dr.

J. T. Gilbert, and Dr. Chalmer P. Embry.

Absent were Mr. Hugh Poland and Mr. Maxey B. Harlin, both of whom were out of the state.

Also present were Dr. Kelly Thompson, President; Mr. Dero G. Downing, Vice President for Administrative Affairs and Treasurer; Miss Georgia Bates, Assistant to the President and Secretary; and Dr. Raymond L. Cravens, Vice President for Academic Affairs and Dean of the Faculties.

The meeting opened with a prayer of invocation by Dean Downing.

Dr. Gilbert, having been reappointed for a four-year term on the Board by Governor Edward T. Breathitt, qualified as a member of the Board of Regents by taking the Constitutional Oath, which was administered by Miss Bates, a Notary Public for the State of Kentucky.

The reorganization of the Board followed, necessitated by the reappointment of Dr. Gilbert. Following discussion, the motion was made by Dr. Gilbert that the same officers be re-elected; namely, Mr. Keen, Vice Chairman; Mr. Downing,

Treasurer; and Miss Bates, Secretary. The motion was seconded by Dr. Edds and carried unanimously.

The minutes of the meeting held on February 23, 1967, were presented by the Chairman. Mr. Keen moved, with a second by Dr. Embry, that the minutes be adopted without a reading inasmuch as each member had previously received a copy. The motion carried.

Copies of the 1967-68 Operating Budget were distributed. In presenting it, President Thompson stated that he was doing so with great pride because it was the most thorough and comprehensive budget presented during his presidency. He expressed appreciation to Dean Cravens, to the College Deans, and to the Department Heads for their contribution in its preparation and paid special tribute to Dean Downing, to Harry Largen, and to members of the Business Office staff for the excellence of the document.

In conjunction with the budget, the proposed 1967-68 salary schedule was presented as a separate exhibit. Mr. Keen, noting in its review that no charge had been reflected in the President's salary, requested that Dr. Thompson absent himself from the meeting so that the Board might discuss his salary and other matters pertinent to his position. Following discussion, Dr. Edds moved that Dr. Thompson be re-elected for another four-year term as President of Western; that his annual salary be increased from \$28,000 to \$30,000, effective July 1. 1967; that he be requested and directed to spend more time away from the campus for the purpose of relaxation and recreation; and that consideration be given to the purpose of a University vehicle with a member of the staff to be made available and drive him to his appointments. The motion was seconded by Mr. Keen; and soon a call of the roll, the vote was as follows:

In graciously acknowledging the action of the Board, President Thomson expressed "my sincere appreciation to you as a Board and to you individual"."

Following full discussion, Mr. Keen moved the adoption of the 1967-68

Operating Budget as recommended by the President, including the amended salary schedule and personnel changes. The motion was seconded by Dr. Gilbert; and upon a call of the roll, the vote was as follows:

The next item on the agenda was the presentation of a series of recommendations to the President from the Vice President for Academic Affairs—the results of studies, conferences, etc., with other deans, Department Heads, the Academic Council, and the President. The full report, having been distributed to the Board members, follows in condensed form:

- 1. Establishment of a major in dietetics and institution administration to be offered through the Department of Home Economics.
- 2. Establishment of a basic structure for Master's degrees to be offered through the Graduate School.

GUIDELINES THAT MUST BE CONSIDERED BY A DEPARTMENT IN DEVELOPING A GRADUATE PROGRAM

- I. The quality of graduate instruction should be of great concern to the department desiring to offer graduate work. The initiation of a graduate program is of vital concern to the Department Head, the Dean of the College, the Dean of the Graduate School, and the Dean of the Faculties. These four individuals must be involved in initiating and planning a graduate program. The normal procedure is for a proposed graduate program to move through the college curriculum committee for information and comments prior to its submission to the Graduate Council.
- II. A thorough analysis of the undergraduate program should be made. Graduate programs should not be undertaken unless the academic integrity of the undergraduate program can be maintained. A department planning a graduate program should appraise critically the resources at its disposal and study the effect that graduate work will have on its undergraduate program.
- III. Departments offering graduate work shall have library and laboratory resources adequate for the curricula offered and for the introduction of the student to research in the subjects offered in the program. The Library should contain books and periodicals sufficient to provide the students with means of attaining mastery of the literature, history, and research materials of their subjects.
- IV. The faculty of the department offering graduate work shall have an avowed interest in graduate instruction and shall have experience in teaching advanced subjects. It is expected that a department would have sufficient members on the graduate faculty to support the program.
- V. A well organized and balanced program meeting accreditation standards must be presented.
- VI. The formal request to the Graduate Council for appraisal of a new graduate program must include a report which explains and demonstrates that these guidelines have been considered and substantially met.
- 3. Establishment of a graduate major in physical education for students pursuing the Master of Arts in Education degree.
 - 4. Establishment of professional education sequence under the College of Education for the training of teachers in the area of early childhood education.
 - 5. The adoption of a plan under which graduating seniors in 1968 would be requested to take the area test of the graduate record examination.
 - 6. Affiliation with the Methodist Evangelical Hospital to permit medical technology students to pursue their senior year of clinical work at the Louisville hospital.

- 7. Nominations for department headships and academic directors:
 - a. Director of Counseling Services Center, Dr. George Lair
 - b. Acting Head, Department of Art, Mr. Verne Shelton (Second year in this capacity)
 - c. Head, Department of Biology, Dr. Ernest O. Beal, effective January 1, 1968. Special permission is requested to retain the services of Dr. H. L. Stephens as head of the department until Dr. Beal reports.
 - d. Director of Reading Services, Dr. Curtis Englebright
- 8. Recommendations for faculty promotions in rank:

Following full discussion and upon the recommendation of Dr. Thompson, Dr. Gilbert moved for approval of the report in its entirety. The motion was seconded by Dr. Embry, and the roll call vote was as follows:

The Board heard a proposal from Dr. Thompson regarding the establishment of the Sarah Ellen Jeffries Professorship of Geography. Named in honor of the late Miss Jeffries, who served the institution from 1913 to 1942 as an instructor and later as head of the Department of Geography, the new position would become effective with the 1967-68 school year. The President further recommended that Dr. R. Paul Terrell, who had indicated a receptiveness to the idea, be named as the first Jeffries Professor of Geography at an annual salary of \$14,700. In accepting this new responsibility, he would relinquish the headship of the Department of Geography and Géology effective with the close of the current school year, or at such time as his successor is named. After discussion, Dr. Gilbert moved approval for the establishment of the Sarah Ellen Jeffries Professorship of Geography and the naming of Dr. R. Paul Terrell for the special position. The motion was seconded by Dr. Embry, and the roll call vote was as follows:

The noon hour having arrived, the meeting recessed for luncheon, followed by a preview of "This is Western Kentucky University." The 30-minute production in color was described by the President as a multipurpose film "that will not only serve as a valuable teaching aid in the mass media program, but will carry the message of Western to so many people in so many places." The film was well received by the Board.

Upon the recommendation of Dr. Thompson, adoption of the following procedure regarding the adjustment of salaries for faculty members who receive the doctoral degree during the academic year was moved by Dr. Gilbert:

Salary adjustments for faculty members who complete their doctoral requirements during the academic year shall be made only at the beginning of the first or second semesters, September 1 and February 1. If the requirements are completed prior to October 1 or March 1, the salary adjustment may be made retroactive to September 1 or February 1.

The motion was seconded by Dr. Embry; and upon a call of the roll, the vote was as follows:

A proposal for fringe benefit life insurance coverage for members of the Western faculty and staff was presented by the President, as follows:

PROPOSED PLAN

There have been intermittent discussions and periodic conferences by the Faculty Insurance Committee and members of the administrative staff regarding a group life insurance plan for the faculty and staff. Study has been given to the possibility and the desirability of the University providing a fringe benefit in the form of life insurance. The Committee has studied proposals from several insurance companies. They have also investigated what is being done in other institutions, particularly at the University of Kentucky, Eastern, and Morehead.

The plan recommended for consideration at this time has the following major points:

- 1. A basic fringe benefit to be extended to each member of the faculty and staff that will provide coverage in the amount of \$2,500 for each person—the cost to be paid by the University. At the present time, the cost to the University would be \$12,726.
- 2. The individual faculty-staff member will be eligible to purchase additional insurance as a part of the group plan in an amount equivalent to his annual contract salary.

If the proposal is adopted, it will be well to allow sufficient flexibility for adjustments to be made at the end of the first year so that maximum encouragement can be given to wide participation in the optional portion of the plan.

Following discussion, Dr. Embry moved, with a second by Dr. Edds, for adoption of the plan as recommended by Dr. Thompson. The roll call vote was as follows:

The next item on the agenda was the presentation of a draft of University policies regarding faculty involvement in sponsored research, special projects, and consulting activities. After discussion and upon the recommendation of the President, Dr. Gilbert moved adoption of the following proposal:

DRAFT OF UNIVERSITY POLICIES ON FACULTY INVOLVEMENT IN SPONSORED RESEARCH SPECIAL PROJECTS AND CONSULTING ACTIVITIES

The primary responsibilities of a faculty member include the assigned classroom teaching, advising of students, research and writing, work on faculty committees, and other duties which may be assigned by the Department Head, the Dean of the College, the Vice-President for Academic Affairs, or the President. Additional work load, above and beyond these responsibilities, may be assumed by a faculty member—with the approval of the administration. It is assumed that the preparation for such over-time work, and in most cases the performance thereof, will be at times other than when a faculty member is expected to be attending to his primary duties.

Faculty members who desire to become involved in remunerative consulting and/or sponsored projects must obtain prior approval for such involvement. A standard university form is provided for submission of requests for such approval. At all times care must be taken to insure that the individual's primary responsibility to the University will be fulfilled.

I. Paid Consulting:

With prior approval of the University, a faculty member may serve as a paid consultant to outside organizations. Such activities engaged in during periods when the faculty member is not attending to his principle responsibilities, should not exceed four days per month and will be approved only when such consulting is deemed to supplement or enhance the professional competency of the faculty member.

II. Sponsored Research:

A faculty member may engage in sponsored research activities in his field of specialization, in addition to his teaching responsibilities when such research activities, in the opinion of the Department Head and the Dean of the College do not require so much time as to interfere with the primary assignment. An appropriate reduction of teaching load will be made when approved research requires more than one-fifth of the faculty member's time. Research activities should be related to the professional competency of the faculty member. Research which requires the cooperation of a governmental agency or outside organization must be approved by the University and the agency or organization.

III. Directorships of Special Projects, Institutes, or Direct Involvement in such Activities as Assistants, Internal Consultants, Etc.:

With prior approval of the University a faculty member may engage in the above-mentioned activities in addition to his full-time faculty responsibilities, when such involvement as determined by the Department Head and the Dean of the College does not interfere with the primary assignment. An appropriate reduction of the teaching load will be made when such activities require more than one-fifth of the faculty member's time.

IV. Additional Faculty Compensation:

Faculty members who are involved in sponsored research, projects, institutes, and internal consulting may receive compensation from the University in addition to their regular salary when:

- 1. The services of the faculty member are performed in addition to his regular assignment; or
- 2. A sponsored activity in which the faculty member is engaged requires more time and a higher level of productivity than is normally expected of a faculty member.

If the activity falls in one of the two categories above, the additional compensation, authorized for a project which runs for the academic year (9 or 10 months), may range up to a maximum of one-fifth of the salary for the academic year.

If the project is to be carried out during the summer session, the faculty member may receive up to one-fifth of his base salary for the involvement in the sponsored project during the eight weeks' summer session.

The motion was seconded by Mr. Keen and carried unanimously.

Following discussion, Dr. Embry moved adoption of the following

resolution:

RESOLUTION

WHEREAS, the Board of Regents has officially adopted and enthuiastically approved the long-range Master Plan for the future development of Western Kentucky University; and

WHEREAS, this Master Plan includes a thoroughfare designated as the University Boulevard which is designed to extend from U. S. Highway 31-W in a westerly direction across the southern end of the University campus, intersecting U. S. Highway 68, and extending in a fashion adjacent to the Louisville and Nashville Railroad to a point connecting with Adams Street; and

WHEREAS, the Kentucky Department of Highways has engineered this project to best facilitate the anticipated traffic with maximum safety; and

WHEREAS, the President of Western has previous authorization from the Board of Regents in the form of a Resolution adopted in meeting on October 30, 1964, to establish and designate rights-of-way for thoroughfares and/or streets;

NOW THEREFORE BE IT HEREBY REAFFIRMED that the President of Western be authorized and requested to execute such documents and carry out other necessary action to implement the construction of the University Boulevard; and

BE IT FURTHER RESOLVED that the Board of Regents in meeting on April 13, 1967, authorizes the transfer of the land required for construction of the University Boulevard in accordance with Department of Highway plans and in keeping with the center line descriptions herewith attached.

CONVEYANCE OF RIGHT OF WAY FROM WESTERN KENTUCKY STATE COLLEGE TO THE DEPT. OF HIGHWAYS FOR ACCESS ROAD CONNECTING U.S. 68 WITH U.S. 31-W IN BOWLING GREEN - LANDS SOLD FILE NO. 595

WHEREAS, the Department of Highways proposes construction of a four-lane connecting road from U. S. 68 across the southern portion of the Western Kentucky State College Campus to Normal Drive and thence to U. S. 31-W and,

WHEREAS, Officials of the College having been consulted on the proposed taking and plans for construction, have approved the project, and,

WHEREAS, the Department of Highways and the College have requested conveyance of sufficient College land to the Department of Highways for the required right-of-way, and

WHEREAS, it is considered that the proposed new road will benefit the College by improvement in the traffic flow and the appearance of that part of the campus, now

THEREFORE, the Commissioner of Finance being so advised, and after considering all the facts does, in the interest of the public good, hereby order and direct that the property lying in Warren County and more particularly described on the separate sheet attached hereto and made a part hereof be, and the same is withdrawn from the use of Western Kentucky State College and transferred to the Department of Highways; and he further grants to the Department of Highways, its employees, agents and contractors, the right to enter upon said Western Kentucky State College property at the places designated on the plans for the subject, project.
