Judicial Council Report

April 18 at 6:30 we are going to have our judicial forum with Judge John Minton who will probably be on the KY Supreme Court come and speak in MMTH. He is an SAE alumna. We are going to try to get pre-law and different types of students to come.

Scott Broadbent talked about doubling the amount of organizational aid money and increasing the limit of money to \$1000 and allowing specific halls to file for money rather than just RHA as a whole. It will boost involvement, student awareness. Melissa Paris said she does not disagree and that she wishes there was more money to be given out. However, some of the organizations that did get money never even came to pick up their checks.

Leah Keys made a motion to amend Bill 07-06-S to increase the total amount from \$686 to \$715.98 because it ended up costing more than expected. There were no questions or debate. *Bill 07-06-S was amended with unanimous consent.*

Johnathon Boles made a motion to rescind Resolution 04-06-S. There were no questions or debate. *Resolution 04-06-S was rescinded with unanimous consent.*

Resolution 05-06-S Election Forum

Johnathon Boles was recognized as the author explaining that this is a programming resolution on an election forum to describe the election process across the Commonwealth. During debate, Scott Broadbent made an amendment to strike the entire

1st WHEREAS clause. Josh Collins made an amendment to omit "shall" and add "to" in the PURPOSE clause, and to omit "for" and capitalize the "T" in the THEREFORE clause. *Resolution 05-06-S was passed with unanimous consent.*
