**RESOLUTION 92-01-F**  
**TWO-WEEK DEADLINE FOR DROPPING A CLASS**  
INTRODUCED: September 8, 1992

- PURPOSE:** For Western Kentucky University, in upcoming semesters, to allow at least two-weeks for students to drop a class without a grade designation.
- WHEREAS:** Due to the fact that many students cannot get a clear understanding of the commitments of their schedules after only a week, and
- WHEREAS:** The existence of odd-numbered school weeks may limit a student to only two class visits, or in the case of a night class, only one, and
- WHEREAS:** The teachers involved may not be able to adequately convey to their students the expected responsibilities in such limited class visits, and
- WHEREAS:** A minimal two-week extension of the period to drop a class without a grade designation would address these constraints.
- THEREFORE:** Be it resolved that we, the members of the Student Government Association, in the interest of Western Kentucky University's present and future students, do hereby recommend that the semester deadline for dropping a course without a grade designation be no sooner than two weeks after the official first day of that semester.
