Required statutory notice having been given, a special meeting of the Board of Regents of Western Kentucky University was held Monday, December 9, 1985, through Wednesday, December 11, 1985. The meeting was called to order at 9:15 a.m, CST, Monday, December 9, in the Regents Conference Room of the Wetherby Administration Building. Mr. Joseph Iracane, Chairman, presided.

AGENDA ITEM 1 - The meeting opened with a prayer of invocation by Dr. John Minton, Vice President for Student Affairs.

AGENDA ITEM 3 - Chairman Iracane had received, on behalf of the Board, the final report from Mr. Joe Bill Campbell on the work of the Advisory Committee on the Presidential Search which resulted in the recommendation of five individuals to be considered by the Board as finalists for the position. Arrangements have been made for the Board to interview the finalist at this meeting. (A copy of the report is attached and retained in the permanent files of the Board of Regents)

Mr. Clark made a motion that the Board of Regents go into closed session for discussion which might lead to the appointment of an individual to a position. The purpose of the closed session discussion is to protect the reputation of individuals being considered. Mr. Clark indicated that the Board would reconvene in open session Wednesday, December 11, at 11:00 a.m. The motion was seconded by Judge Palmore and passed unanimously by voice vote.

The Board went into closed session at approximately 9:18 a.m, and Mrs. Esters, Secretary to the Board, accompanied the Board in the closed session.
