AGENDA ITEMS 9 - Action Items:

9.1 Approval of \$1,287,500 for submission to the Council on Postsecondary Education for matching funds from the Regional University Excellence Trust Fund

BACKGROUND:

Pursuant to guidelines approved by the Council on Postsecondary Education, the Board of Regents has primary responsibility for the implementation of the Endowment Match Program. Specifically, the Board of Regents is responsible for providing oversight of all these endowment funds.

By approving this recommendation, the Board notifies the Council of the receipt of gifts and pledges to be endowed in the amount of \$1,287,500 and the university's intention to submit requests for matching state funds. This is in addition to the \$3,056,000 in matching funds approved by the Board at its May 9, 2003, meeting. This approval is for WKU's share of \$4.6 million of the third round of endowment matching money authorized in HB1-the Higher Education Reform Act. The Board also acknowledges responsibility for oversight of the endowments established with these funds in accordance with council guidelines and procedures.

Mr. Martin made a motion, seconded by Ms. Bale, to approve for submission to the Council on Postsecondary Education for \$1,287,500 in matching funds from the Regional University Excellence Trust Fund for the donors, gifts and pledge commitments and endowment designations identified below:

AGENDA ITEM 9.2 - Approval of the bond resolution and authorize the bond sales of Consolidated Educational Revenue Buildings Revenue Bonds (CEBRB), Series P in the approximate principal amount of \$11,125,000 that may be increased or decreased by

\$1,100,000; and authorize President Ransdell to accept the lowest bid and award the bonds

FACTS: In the interest of addressing the student parking problem, Western Kentucky University gained legislative authorization to issue bonds for student parking improvements including a potential add on to the existing parking structure. The legislative authorization is for agency bonds with construction authorization of up to \$10 million. The Board of Regents has authorized a new mandatory student fee, the Parking and Transportation Fee, as the revenue stream to cover the debt payments for 20 years. A 20-year bond issue is common practice of the State for construction projects. The State Office of Financial Management has been notified of the University's intent to proceed with the agency bonds.

The bond resolution has been prepared by Peck, Shaffer & Williams LLP who is serving as bond counsel for the University on this issuance. The bond resolution permits the University to initiate steps to sell the bonds, subject to the University accepting the lowest and best bid for the Series P bonds and establishing the final principal amount and maturities for the Series P bonds. A tentative schedule is attached. Results of the final sale of bonds will be reported to the Board of Regents at its next quarterly meeting.

RECOMMENDATION: President Gary A. Ransdell recommends that (1) the Board of Regents approve the bond resolution and authorize the bond sales of Consolidated Educational Revenue Buildings Revenue Bonds (CEBRB), Series P in the approximate principal amount of \$11,125,000 that may be increased or decreased by \$1,100,000; and (2) authorize President Ransdell to accept the lowest bid and award the bonds.

AGENDA ITEM 9.3 - Approval to name the Colonnade the W. L. "Gander" Terry Colonnade

FACTS: Dr. W. L. "Gander" Terry not only contributed to Western's athletic history as a player, but made a mark as a Hilltopper coach as well. Terry played football for the 1928 squad which finished with an 8-1-0 mark and a state championship. The Marion, Kentucky, native remained on the Hill as an assistant coach for the 1929 team, returned as an assistant for the 1934 and '35 squads, then was named head coach for the Hilltoppers in 1938, a post he held for four seasons. During his head coaching tenure, Terry's teams racked up 25 wins with marks of 7-2, 7-1-1, 7-1-1 and 4-5-1. The eleven Western teams he played or coached for were a collective 67-31-7. Terry left Western following the 1941 season to join the U.S. Navy in World War II. After the war, he earned his doctoral degree from Indiana and later served as head of the physical education department at San Jose State. Terry died in 1991 in Rapid City, South Dakota at the age of 83.

The daughter of Coach Terry is Mrs. Barbara Terry-Porter, a resident of Rapid City, South Dakota. Gifts to the University through the years from Mrs. Terry-Porter now total \$650,000 which includes a \$100,000 gift on June 7, 2001, and another major gift in the form of a Charitable Gift Annuity in the amount of \$500,000. In addition, she has designated the College Heights Foundation as the recipient of the remainder of her estate.

Dr. Terry was among the students who worked in the summers to convert an old rock quarry into the Western Stadium that served the University from 1927 until 1967. The Colonnade is the campus location most clearly and meaningfully associated with the career of Coach Terry at Western where he was an outstanding student, a great athlete, Director of Athletics,

and Head Football Coach.

RECOMMENDATION:

President Gary A. Ransdell recommends approval to name the Colonnade the W. L. "Gander" Terry Colonnade.
