### WKU LIVESTOCK JUDGING TEAM TAKES TOP HONORS AT COMPETITION

Bowling Green, Ky.--Western Kentucky University's Livestock Judging team have returned from the Southeastern Conference Intercollegiate Livestock Evaluation and Judging contests at Virginia Tech University in Blacksburg, Va. with a first place trophy and ribbons representing their successes there.

The Western team won first place in beef cattle judging and Stanley Boone of Leitchfield finished second high in individual of oral reasoning in cattle judging.

In oral reasons, the team finished second and Stanley Boone finished fourth, Lynn Graham of Bowling Green finished fifth and Al Pedigo of Hendersonville, Tenn. placed eighth.

The team also placed second in sheep evaluation and fourth in swine evaluation. Boone again placed second high in individual of the swine evaluation and Lynn Graham finished fifth.

In the overall high individual contest, Al Pedigo placed fifth and Stanley Boone finished seventh.

WKU's team was among fourteen universities that represented 25 teams in the competition.
