MINUTES

UNIVERSITY CENTER BOARD

September 17, 1986

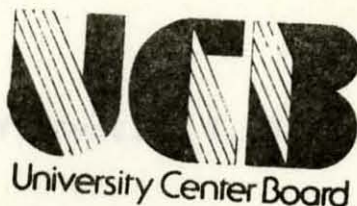
