ANNOUNCEMENTS

Academic Council Action

At its meeting on Wednesday, February 18, the Academic Council approved the following new programs: a Master of Arts in Child Development and Family Living, a Master of Public Service option in the same area, and an undergraduate minor in Child Development and Family Living. New courses in School Libraries (Education 541), Humanities (500), Social Change (Sociology 572), Family Theory and Analysis (Sociology 635) and Adult Education (Education 404) were approved. In further action the Council approved changes in the sequence of courses required of Mathematics majors and adopted two amendments to the rules providing procedures for filing vacancies on the Council. A proposal for an Associate Degree Program in Dental Hygiene was given its first reading and will be considered for second reading and approval at the next meeting of the Council on Wednesday, March 11, at 3:00 p.m. in the Regents Conference Room, Wetherby Administration Building.

Diagnostic Speech Clinic

A diagnostic speech clinic will be conducted in Room 311 of Gordon Wilson Hall at 5:10-7:40 p.m. on April 20, April 27, May 4, and May 18. The clinic will be conducted by Dr. O. J. WILSON (Speech and Theatre) in connection with his course in Speech Correction, and members of the faculty are requested to refer students with suspected speech defects to this clinic for examination, diagnosis, and recommended therapy. It will be helpful if students are referred to Dr. WILSON for a preliminary examination in Room 102, Van Meter Hall, prior to reporting to the clinic. Names of students recommended for the clinic should be forwarded to Dr. WILSON at the earliest practicable date.

Distinguished Service Awards

Nominations for Distinguished Service to the University Awards are invited. Alumni, faculty, and junior, senior and graduate students are encouraged to submit their nominations for these awards prior to April 15. Two awards, one for excellence in productive teaching and one for significant contribution in basic research, creative production, or scholarly investigation, are offered. The paper will be published in the symposium proceedings. These two students presented the results of their undergraduate research "Thermoluminescence and Emission Spectra of X-irradiated Ruby and Sapphire" at the meeting of the Society of Physics Students in Gainesville, Florida, in November, 1969. Dr. BUCKMAN supervised their investigation which was supported by a grant from the Environmental Control Administration, U.S. Public Health Service.

SIX, Dr. N. Frank (Head, Department of Physics and Astronomy) and Mr. V. M. ROBINSON (Physics and Astronomy) were among twelve professors from other universities who explained the joint effort to resolve the sources of radio emission on or near Jupiter at the Southeastern Section of the American Physical Society meeting in Gainesville, Florida, in November, 1969. The data collected by Western's Radio Observatory was crucial to this investigation. Mr. ROBINSON and Dr. SIX were co-authors of a study entitled: 'Time Delay in the Arrival of Jovian Pulses at the Opposite Ends of a Fringe Synthesis Interferometer' and Mr. Roger L. SCOTT (Graduate Assistant, Physics and Astronomy) discussed results of a recent radio investigation of the planet Jupiter at the Astronomy section.

WILSON, Dr. O. J. (Speech and Theatre) spoke to two seminars in International Economics at Brescia College, Owensboro, Kentucky, on "The Mechanics of Production and Distribution in the U.S.S.R." on February 12.

WOOD, Drs. Willson E. (Head, Department of English) and Bardhyl POGONI (English) attended the meeting of the Nashville Linguistic Circle on February 10. Dr. POGONI's student, Mrs. Mary Anne Reiss, wife of John REISS (English), presented the program on: A Graphemic Analysis of an Old English Text: The Parker Manuscript, The Laws of Alfred and Ena.
