Keeling lectured on "Environmental Challenges to Latin America in the 21st Century" and discussed the Doctrine of Preemptive Resolution. The lecture at West Point was part of the Department of Geography and Geology's Leadership in Geoscience program, designed to link Western's geoscience students and faculty with institutions and research partners around the country and across the globe.

**Chris Groves** (Geography & Geology) was elected as the new President of the Cave Research Foundation in November 2004. Groves joined the Cave Research Foundation in 1982 and has participated

in and led many Mammoth Cave expeditions, served on the Board of Directors, and administered the Foundation's Karst Fellowship Program.

On November 6, a team of 34 people took on the task of cleaning up materials illegally dumped for years on property that is now part of the Upper Green River Biological Preserve of Western Kentucky University in Hart County, KY. The clean-up day lead to the disposal of items from two lawnmowers to three sets of washers and dryers. The items and waste found were disposed into a 20-cubic-yard dumpster donated by Jerry Matera from Hart County Solid Waste. The dumpster was filled and had a volume of waste comparable to over 5,000 gallon containers of water.
