#### Family Bible of Andrew and Winneford (Jackson) Jackson

The Holy Bible Containing the Old and New Testaments (New York: American Bible Society, 1883). Original in the possession of Betty Adcock [600 Walnut Street, Dawson Springs, Kentucky]. Original Bible photocopied by Gail (Jackson) Miller 1 November 1994. Transcription by Gail Jackson Miller from the photocopy of the Bible was done 9 April 2020.

The Bible was in very poor condition. Edges of several pages were damaged to the point that either the first part of a name or the last part of a date were gone. All of the notations below with [?] represent parts missing due to page damage.

Andrew Jackson [Jr.] was the youngest son of Andrew Jackson [Sr.] and Telitha (Dunn) Jackson. His birth date on his death certificate was listed as 15 April 1846 but his declaration for pension resulting from his service in the Civil War listed 15 April 1847. He was born in Hopkins County, Kentucky.

His father, Andrew Jackson [Sr.] was born in Caldwell County, Kentucky in 1816, son of Burrell Jackson and Winney (Cook) Jackson. Andrew Jackson [Sr.] married Telitha Dunn on 29 December 1834 in Caldwell County, Kentucky. The 1850 Hopkins County, Kentucky census shows Telitha as Eliza Jackson probably suggesting that her name was pronounced with a long "T". The family lived in the area along the Tradewater River near Dawson Springs in Hopkins County, Kentucky. Andrew Jackson [Sr.] has been confused in some family trees with Andrew Jackson born 24 December 1818 in Hopkins County, Kentucky and died 26 July 1841, who was the son of Beckley Jackson and Martha (Brown) Jackson.

Telitha (Dunn) Jackson died on 17 September 1853 at the age of 35 in Hopkins County, Kentucky. Telitha and Andrew Jackson [Sr.] had three known children: Bradley, born about 1841; Phillip, born about 1843; and Andrew [Jr.], born about 1846-1847. After Telitha's death, Andrew married Sarah Yandell on 31 May 1854 in Hopkins County, Kentucky. They had a daughter, Frances Jane Jackson, born on 26 December 1855.

Andrew Jackson, [Sr.] was evidently a subsistence level farmer also involved in cutting timber for sale. Examination of Hopkins County, Kentucky Circuit Court suits show numerous suits involving non-payment of debt, personal injury brought by some of his wife's relatives, and cutting timber on land he did not own. The final suit was brought originally against Andrew Jackson by W. R. Baker in 1855 for debt. Evidently, sometime after the suit was filed Andrew Jackson [Sr.] died. The suit reports that he died intestate in March 1857. The suit was revised to include his wife and heirs as defendants. Bradley Jackson was living with William Wills and Philip Jackson was living with A. C. Thomson in 1858. Andrew Jackson [Jr.] was living with his uncle, Thomas Jackson, his father's brother. Frances was living with her mother.

Family stories claim that Andrew Jackson [Sr.] drowned in the River. Interestingly, the wording of the suit suggests that not everyone involved in the suit believed that Andrew Jackson [Sr.] had died. Interestingly, the older children and wife of Andrew Jackson [Sr.] seemed to have left the area soon after 1860. Some family members had already moved to Arkansas and there is some speculation that family members, possibly even including Andrew Jackson [Sr.] moved to Arkansas. Andrew Jackson [Jr.] was raised to adulthood by his uncle, Thomas Jackson, in Caldwell County, Kentucky.

Winneford Jackson was the daughter of Thomas Jackson and Winneford [Creekmur] Jackson. She and Andrew Jackson [Jr.] were first cousins. Winneford married William Perry 21 September 1864 in Caldwell County, Kentucky. Winneford and William Perry had one child, Jacob Archway Perry, born 13 March 1865. The couple divorced in 1866. The Caldwell County Circuit Court granted the divorce to Winneford on the grounds of physical cruelty. She was

restored to her maiden name. She married her first cousin, Andrew Jackson [Jr.] on 31 January 1868 in Caldwell County, Kentucky. They raised her son, Jake, with their own children.

The children of Andrew Jackson [Jr.] and Winneford (Jackson) Perry Jackson included the following:


- Charlie H. Jackson, born 6 August 1869, died 28 August 1954. Married Ella Elizabeth Robertson, 1 November 1890 in Hopkins County, Kentucky.
- ii. Roenia Jackson, born 4 April 1871, died 1 April 1898.
- Enos Moses Jackson, born 19 November 1872, died 6 May 1969. Married Mary Elizabeth Fields 1 February 1893 in Hopkins County, Kentuck.
- iv. Ann Jackson, born 10 April 1874, died 25 July 1885. She was listed as "Ann" in birth record and "Bird" on her death record in the Bible above.
- John H. Jackson, born 26 September 1875, died 19 May 1943. Married Abbie Miller in 1907.
- vi. Fred Jackson, born 14 April 1878, died 2 July 1959. Married Etta Vanosdale.
- vii. Daniel B. Jackson, born 25 September 1881, died 25 July 1882.
- viii. David Mack Jackson, born 19 June 1884, died 2 July 1972. Never married.
- Ivah May Jackson, born 19 June 1884, died 6 June 1957. Married Thomas D. Gosnell.


The child of William Perry and Winneford (Jackson) Perry Jackson was:


 Jacob Archway Perry, born 13 March 1865, died 4 November 1945. Married Ellen Rosena Harland about 1902.
























Charlie Jackson & wife, Ella Elizabeth (Robertson) Jackson
