





HYDEN, KENTUCKY - A RESOURCE PROFILE

Location

Hyden, the county seat of Leslie County is located in the southeastern part of the Commonwealth.

Geographically, Hyden is positioned in the Eastern Coal Fields Region, 210 miles from Louisville, Kentucky; 130 miles from Lexington, Kentucky; and 150 miles from Knoxville, Tennessee.

The population of Hyden was 348 in 1960 and the population of Leslie County is 11, 383 in 1970.

The Economic Framework.

Total employment in Leslie County averaged 900 in 1968 with manufacturing providing 48 of these jobs, trade and services 100 jobs, government 800 jobs, and mining and quarrying 240 jobs. The major industrial product is lumber.

Per capita income in the county in 1968 was \$630.

The Leslie County labor market area includes Leslie and the four surrounding counties. Area employment totals 26,220 including 1,030 in agriculture. Manufacturing furnishes 2,180 jobs, trade and services 7,900 jobs, government 6,520 jobs, and mining and quarrying 5,170 jobs. Area industrial employment has increased since 1959 with sharpest gains in the apparel, leather, and machinery and metal products industries.

Despite important industrial gains in recent years the area still has a deficit of 9,853 manufacturing jobs when measured against the national industrial employment-population ratio. This indicates an area where the potential for additional manufacturing production is excellent.

Resources for Growth

1. There is a current estimated labor supply of 5, 612 men and 9, 257 women available for industrial jobs in the labor market area. In addition, 9,840 young men and 9,245 young women will become 18 years of age by 1976 and potentially available for work.

2. Transportation - Rail service is 21 miles away at Hazard or 28 miles away at Manchester. U. S. 421 and Kentucky Highway 80 serve Hyden. Also, the Daniel Boone Parkway will run just north of Hyden. The London-Corbin War Memorial Airport, 55 miles distant, has commercial air service.

3. Electricity is available in large quantity from Kentucky Power Company. The raw water supply from the Middle Fork of the Kentucky River is more than adequate for continued growth.

4. Industrial sites - Hyden has one industrial site.

5. Education - One senior and four junior colleges are located within 50 miles of Hyden. Two area vocational schools and one vocational extension school are located within 35 miles of Hyden. A new vocational extension school is under construction at Hyden.

Community Programs for Improvement

Hyden has just completed a new public library. There is a new 30-room motel and restaurant.

Recreation, Entertainment and Livability

Hyden is located in the northeastern section of the Redbird Purchase Unit of the Daniel Boone National Forest. Daniel Boone National Forest covers 460,000 acres of timberland in eastern Kentucky. Facilities include scenic hiking trails, rivers and creeks stocked with rainbow trout, special hunting preserves, and many camping and fishing facilities.

Buckhorn Lake State Resort Park, approximately 35 miles distant, is a 750-acre resort park with lodge. The facilities include fishing, boating and swimming in the 1,200-acre Buckhorn Lake.

Levi Jackson Wilderness Road State Park, 52 miles distant, is an 815-acre park. The facilities include: riding, hiking, shuffleboard, picnicking, and archery.

Pine Mountain State Resort Park, 50 miles distant, is a 2,500-acre park. Facilities include a 20-room lodge, lodge pool, cottages and camp grounds. Recreational facilities include: swimming, riding, hiking, shuffleboard, and golfing.

Kingdom Come State Park, 30 miles distant, is a 1,000-acre park. Facilities include: camping, hiking and picnicking.

Mary Breckinridge Festival honoring the founder of the Frontier Nursing Service is held in Hyden the first Saturday in October, featuring a parade and Handicraft Fair.

HISTORY

Leslie County, the one hundred seventeenth county formed in the state, dates from 1878. It was taken from Clay, Harlan and Perry Counties and lies in the largest coal producing area in the state. Its land surface is rugged. Ninety-two percent of the total acreage of the county is classified as forested land, thus it is unsuitable for agricultural production.

The first settlers in Leslie County were John Sizemore and his family who came from North Carolina in 1817 and settled at the present site of Hyden. No wagon road connected this settlement with the outside world until the 1880's. Before that time goods were brought by canoe up the Middle Fork of the Kentucky River.

The county was named for Preston Hopkins Leslie, who was Governor of Kentucky from 1871 to 1875.

Hyden, the county seat, is situated on the Middle Fork of the Kentucky River and is 870 feet above sea level. It was named for Judge Hyden who was the first county judge. It was incorporated in 1947.

In 1898 a weekly newspaper, <u>Thousandsticks</u>, was established. It continues today and has subscribers in many parts of the United States.

Mary Breckinridge founded and directed the Frontier Nursing Service for many years. A two-story hospital was built in 1928 and eight nursing centers were maintained in isolated, almost inaccessible areas in cooperation with Federal and State health authorities. Each center contained a clinic and living quarters for two nurse-midwives. Each team of two nurses gave service to the people who lived in an area of about eighty square miles. Their work was gradually accepted by the people whose only medical resources had been charm and home remedies since there were no resident physicians in the area. Midwifery was only partially recognized in the United States which made it necessary to import midwives trained in Europe or to send American nurses abroad for training. Equally important to nursing was the training program by which the people were taught to care for their sick between the nurses' visits. Mary Breckinridge built a directing center and residence at Wendover, about 4 miles from Hyden.

Today there is a modern hospital in Hyden and three resident physicians for the county.
