

SCOTTSVILLE, KENTUCKY - A RESOURCE PROFILE

Location

Scottsville, the county seat of Allen County, is located in south-central Kentucky, on the Kentucky-Tennessee border. Nashville, Tennessee, only 52 miles south, is the nearest major city. Louisville, Kentucky, is 114 miles north and Lexington, Kentucky, is 160 miles northeast. The population of Scottsville was 3,584 in 1970 and the population of Allen County was 12,598.

The Economic Framework

Total employment in Allen County averaged 4,400 in 1970, with agriculture providing 1,100 jobs, manufacturing 900 jobs, government 500 jobs, and trade and services 860 jobs. Between 250 and 300 jobs are provided in Allen County by Dollar General Stores Corporation, which has its home office in Scottsville. Since 1961, manufacturing employment has increased by 253 jobs, or 39.5 percent. Major industrial products are lumber and wood products, drapery hardware accessories, men's and boys' trousers, and knit shirts.

Per capita income in 1969 was \$1,910, or \$937 below the Kentucky average.

The Scottsville labor market area includes Allen County, the adjoining Kentucky counties of Barren, Monroe, Simpson, and Warren, and the adjoining Tennessee counties of Sumner and Macon. Employment in the Kentucky portion of the labor market area totaled 53,000 in 1970, including 8,100 in agriculture, 12,300 in trade and services, and 7,000 in government. Manufacturing provided 13,200 jobs. Area industrial employment has more than doubled since 1961, with sharpest gains in the machinery and metal products, lumber and wood products, apparel, and rubber products industries.

Resources for Growth

1. Labor supply - There is a current estimated labor supply of 3,670 men and 1,710 women available for jobs in Allen and the surrounding Kentucky counties. In addition, 5,970 young men and 5,620 young women will become 18 years of age by 1978 and potentially available for work. Also the current labor supply would be increased by the number of men and women in the adjoining Tennessee counties who are available for industrial jobs.

- 2. Transportation The local transportation capability is good. The Louisville & Nashville Railroad serves Scottsville with a variety of services. Piggyback service is available at Glasgow, 25 miles distant. Scottsville is located on U. S. 31-E and U. S. 231, and there is easy access to Interstate 65, located 21 miles west of Scottsville.
- 3. Energy Electricity is distributed by Tri-County Membership Corporation, whose source of power is the Tennessee Valley Authority. The Scottsville Gas Department provides natural gas service for the community and is supplied by Texas Gas Transmission Corporation.
- 4. Industrial sites Scottsville has seven sites available for industrial use.
- 5. Education Western Kentucky University is located 25 miles from Scottsville in Bowling Green, which is also the location of the Bowling Green Area Vocational School. A vocational extension center is located in Scottsville and offers training in seven different courses.

Community Programs for Improvement

A new branch bank was recently constructed.

The Dollar General Stores Corporation maintains approximately 250,000 square feet of warehouse space, and is planning to construct a new 100,000 square foot warehouse in the near future.

A business center is under construction and firms are moving into the center as units are completed. Four businesses have already located and space will be available for two additional firms.

Automatic number identification for direct distance dialing is being made available in Scottsville and will be in service by April 1, 1972.

An expansion project at the Allen County War Memorial Hospital will increase services and improve facilities. A new wing is under construction and will provide space for 17 additional beds. New construction will also provide space for an additional operating room, fully-equipped emergency room, office and storage. Present hospital facilities being renovated include the laboratory and X-ray departments, which will also have new equipment. A new service to be provided is an intensive cardiac area with all new equipment.

The new Allen County High School was completed in 1971 at an approximate cost of \$1,500,000. The air conditioned building contains an auditorium, 31 classrooms, a library, and a 4,000-seat gymnasium. A new football field has enabled the students to participate in football competition.

Scottsville High School recently completed a renovation and new construction project which provided five new classrooms, a chemistry laboratory, band and choral room, materials center, science lecture room, and distributive education center.

Scotscraft, Inc., is planning the construction of a 60,000 square foot addition to its present building.

The city recently purchased a new 1,000 gpm pumper for the fire department.

Upgrading of the police department has included an increase in personnel, a new patrol car, and additional radio equipment.

Two housing projects, a 56-unit low income complex and a 40-unit complex which will include both low and middle income housing, are under construction.

The city plans to extend sewerage service to the south side of Scottsville and to two new subdivisions - north and south of town.

A 300,000 gpd water treatment plant is planned for construction. This project will provide an additional water intake and a new 12-inch line coming into Scottsville.

The residents are served by a new natural gas system which includes new meters and new lines.

The new Allen County Vocational Extension Center, adjacent to the county high school, was constructed in 1970.

Recreation, Entertainment and Livability

Barren River Lake State Resort Park is located 12 miles northeast of Scottsville with a 10,050-acre lake, providing fishing, swimming, boating, camping, hiking, hunting, golfing, a restaurant and grocery store.

Beech Bend Park, the world's largest campground with 6,500 camping sites, is located at Bowling Green, 25 miles northwest of Scottsville.

Western Kentucky University, at Bowling Green, provides nine months of intercollegiate sports, featuring the Hilltoppers as a perennial national basketball power, along with music and drama productions sponsored each semester and summer session by Western's music and speech-theatre departments.

CURRENT AND FUTURE LABOR SUPPLY - SCOTTSVILLE LABOR MARKET AREA



HISTORY

Allen County is situated in southcentral Kentucky and has an area of 364 square miles. Its surface is predominantly hilly, its soil fairly fertile, and timber grows throughout its area. The Barren River forms about one-half of its eastern and all of its northern border, and several creeks flowing into the Barren furnish a good drainage system for the county.

The county was first settled in 1797 in the vicinity of Scottsville by Joseph Ficklin, Toliver Craig, Henry Collins, Daniel Moore, and Abram Wood. Daniel Boone had passed through the area earlier as evidenced by his initials found carved on a tree with the date 1777. In 1815 Allen County became the fifty-seventh county established in Kentucky, taking its name from Colonel John Allen, who migrated from Virginia to Kentucky in 1776 and settled near Danville. A military leader of considerable courage, Allen's practice of law put him among the first men of his profession.

Scottsville, the county seat, is named for General Charles Scott, who served on a military advisory board in Kentucky for President George Washington during the troubled period of the 1790's and was elected Kentucky's fourth governor in 1808. The city is scenically located on a central hill surrounded by other hills, and a red brick courthouse stands in the middle of its town square.

Allen County's population has increased from the first recorded figure of 5,327 in 1820 to a high of 13,787 in 1950. There was a decline to 12,269 in 1960, but due to industrial growth, the population was up to 12,598 in 1970.

Until the mid-1800's the entire population of Allen County made its livelihood on farms, and livestock became an important factor in the county's economy. By 1850 there were several flour mills, boot and shoe makers, a few furniture makers, wool carders, and leather workers among the manufacturing groups of the county. Oil wells had been drilled by 1870, making petroleum one of the county's principal natural resources to the day. Since 1961 manufacturing employment has increased to 890, and in 1970, 3,300 of the county's 4,400 workers were employed nonagriculturally. Major industrial products are lumber, wood products and apparel. Largest among Scottsville's industrial plants are: Washington Overall Manufacturing Company, Scotscraft, Incorporated, which makes draperies, hardware accessories; and Woodmaster, Inc. McLellan Stone Company produces crushed limestone for railroad ballast and other uses. Primary agricultural products of Allen County are corn, hay, tobacco, poultry, cattle, and hogs.

The area is serviced by U. S. 31-E and U. S. 231 and offers easy access to Interstate 65. Presently under development is the Barren River Reservoir State Park, part of whose 1,800 acres will be in Allen County, offering unlimited possibilities for recreation and hydroelectric power.

Among the distinguished citizens of Allen County is J. William Bryant, who was elected president of the Reserve Mining Company of Minnesota and became head of the Armco Steel Corporation.
