

BALLARD COUNTY, KENTUCKY - A RESOURCE PROFILE

Ballard County, with a 1988 estimated population of 8,000, has a land area of 254 square miles. Wickliffe, the county seat of Ballard County, is located in western Kentucky's Jackson Purchase region. In 1988, Wickliffe had an estimated population of 830. Wickliffe is located 166 miles northwest of Nashville, Tennessee; 174 miles southeast of St. Louis, Missouri; and 250 miles southwest of Louisville, Kentucky.

Barlow, located seven miles northeast of Wickliffe, had a 1988 estimated population of 620. Kevil, located 16 miles northeast of Wickliffe, had a 1988 estimated population of 370. LaCenter, located 11 miles northeast of Wickliffe, had a 1988 estimated population of 910.


The Economic Framework - The total number of Ballard County residents employed in 1989 averaged 2,920. In 1988, manufacturing firms in the county reported 870 employees; wholesale and retail trade provided 310 jobs; 300 people were employed in service occupations; state and local government accounted for 320 employees; and contract construction firms provided 75 jobs.

Labor Supply - There is a current estimated labor supply of 9,600 persons available for industrial jobs in the labor market area. In addition, from 1990 through 1994, 5,370 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major "AAA"-rated (80,000-pound gross load limit) trucking highways serving Ballard County include U.S. Highways 51, 60, and 62, and Kentucky Routes 121, 286, and 358. Sixteen common carrier trucking companies provide interstate and/or intrastate service to Ballard County. Illinois Central Railroad provides main line rail access to Wickliffe. Barkley Regional Airport provides the nearest scheduled airline service near Paducah, 25 miles northeast of Wickliffe. Scheduled commercial airline service is also available at Evansville Dress Regional Airport near Evansville, Indiana, 163 miles northeast of Wickliffe; and at the Nashville Metropolitan Airport near Nashville, Tennessee; 172 miles southeast of Wickliffe. Public port facilities are available at the Paducah-McCracken County Riverport, 35 miles east of Wickliffe.

Power and Fuel - Kentucky Utilities Company provides electric power to Barlow, Kevil, LaCenter, and Wickliffe. Ballard County is also provided electric power by the Jackson Purchase Electric Cooperative Corporation. Commonwealth Service Corporation provides natural gas service to Barlow, Kevil, LaCenter, and Wickliffe.

Education - Primary and secondary education is provided to Ballard County by the Ballard County School System. Six institutions of higher learning are located within 75 miles of Wickliffe. Vocational training is provided by the Ballard County Area Vocational Education Center in Barlow, Kentucky, seven miles northeast of Wickliffe, and by the West Kentucky State Vocational-Technical School in Paducah, Kentucky, 33 miles east of Wickliffe.



LABOR MARKET STATISTICS

The Ballard County Labor Market Area includes Ballard County and the adjoining Kentucky counties of Carlisle and McCracken. The Northern and western boundaries of Ballard County is formed by the Ohio and Mississippi Rivers. The labor market area is supplemented by Alexander and Pulaski Counties, Illinois and Mississippi County, Missouri.



UNEMPLOYMENT RATES 1989





PER CAPITA PERSONAL INCOME 1987




AVERAGE PLACEMENT WAGES

Ballard County is served by the Paducah local office of the Kentucky Department for Employment Services. The focus of the following data is on job placements made by the Paducah local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1989, the local employment office filled 3,017 job openings in various occupational categories. TRANSPORTATION

Highways

Major "AAA"-rated (80,000-pound gross load limit) trucking highways serving Ballard County include U.S. Highways 51, 60, and 62, and Kentucky Routes 121, 286, and 358. Ballard County is located near several multilane highways including Interstate 24, 55, and 57, and the Purchase Parkway. Interstate 24 is accessible via U.S. 60, 28 miles east of Wickliffe, while Interstate 57 is located 10 miles northwest of the city via U.S. 51 and 62. Interstate 55, which connects with Interstate 57, is located 31 miles west of Wickliffe. Access to the Purchase Parkway is available near Mayfield, Kentucky 29 miles southeast of Wickliffe.



The Paducah-McCracken County Riverport Authority operates an ice-free, deep water inland waterways port located at Mile 1 on the Tennessee River, at the confluence of the Ohio and Tennessee Rivers, 48 river miles east of where the Ohio River flows into the Mississippi River, and at the head of the Tennessee-Tombigbee Waterway.

LOCAL GOVERNMENT

Structure

The Cities of Barlow, Kevil, LaCenter, and Wickliffe are each governed by a mayor and six council members. The mayor serves a four-year term, while the council members each serve two-year terms. Ballard County is governed by a county judge/executive and five magistrates. Each county official serves a four-year term.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

Ballard County provides numerous recreational opportunities in its communities. The LaCenter Park contains tennis courts, a playground, and a picnic area. A joint effort between the Ballard County School System and Ballard County Fiscal Court provided funding for four ball fields, several tennis courts, a running track, a grandstand, and a physical fitness center. A nine-hole golf course is also available in LaCenter.

The Wickliffe Mounds, an ancient buried city in Wickliffe provides the whole family a cultural and historical learning experience. Overlooking the Mississippi River, this ceremonial site and trade center was occupied for 300 years by people of the Mississippian period, 800-1350 A.D. Artifacts and relics are on display in the museum.

Ballard County offers one of the prime goose and duck hunting areas in the United States. Nearly 200,000 geese winter at the 8,200-acre Ballard County Wildlife Management Area and at the 2,400-acre public hunting area nearby. Swan Lake Wildlife Management Area and Ballard County Wildlife Refuge provide additional hunting opportunities. The county also offers some of the finest whitetail deer hunting anywhere. Private hunting lodges are available locally.

Area (Within 55 miles)

A Confederate cannon, a network of earthen trenches, and a massive chain and anchor give the feeling of being transported back to the Civil War. All of this and more can be discovered at Columbus-Belmont Battlefield State Park at Columbus, 22 miles south of Wickliffe. Other attractions at the 156-acre park include a 38-site campground, a gift shop, a historical hiking trail, miniature golf, a picnic area, and a playground. A visit to the museum at the park, which is housed in a building that served as a Civil War infirmary, offers a display of Civil War relics and early Indian artifacts and an audiovisual slide program on the Battle of Belmont.

Paducah is located 33 miles east of Wickliffe. As Kentucky's seventh largest city, Paducah provides many recreational opportunities. Points of interest include the Alben W. Barkley Monument, Barkley Museum, historic Whitehaven Mansion, and many other attractions.

Kentucky Dam Village State Resort Park, located 52 miles east of Wickliffe near Gilbertsville, is one of the largest and most popular vacation resorts in Kentucky. A modern lodge with 72 rooms, 67 cottages, and a 221-site campground make up the accommodations. The park includes a 4,000-foot lighted airstrip. There is also a dining room overlooking Kentucky Lake, a coffee shop a snack bar, two gift shops, a meeting room, an activities center, and a recreation room. Recreational activities to choose from include boating and fishing at the largest docking facility in the Kentucky parks system, golf at the 18-hole Village Green Course, fishing, hiking, horseback riding, picknicking, swimming at the lodge pool or off the sand beach, and tennis.

COMMUNITY IMPROVEMENTS

LaCenter Municipal Sewer Department recently completed an expansion of its existing wastewater treatment system. The \$1 million project doubled its capacity.

A joint effort between the Ballard County School System and Ballard County Fiscal Court provided funding for a park at the school in LaCenter. Recreation facilities include four ball fields, several tennis courts, a running track, a grandstand, and a physical fitness center. Total cost of the project approximated \$450,000.

The Wickliffe Community Park recently opened. This 10-acre development features tennis courts, basketball courts, picnic shelters, and a playground. Total cost of construction was \$250,000.

The Kevil Community Park recently opened. Facilities include a picnic shelter and a playground.
