LAGRANGE AND BUCKNER, KENTUCKY -A RESOURCE PROFILE

LaGrange, the county seat of Oldham County, is situated in the Outer Bluegrass Physiographic Region of Kentucky. It is bordered on the northwest by the Ohio River. Buckner is a small, unincorporated community located 3 miles southwest of LaGrange. LaGrange is located 14 miles northeast of Louisville, 194 miles northeast of Nashville, and 99 miles southwest of Cincinnati, Ohio.

The 1970 population of LaGrange was 1,713. The 1970 population of Oldham County, which consists of 184 square miles, was 14,687.

The Economic Framework

Total employment in Oldham County averaged 3,270 in 1971 with agriculture providing 660 jobs, manufacturing 580, government 820, and trade and services 700 jobs. Major industrial products are copper magnet wire, storage silos, grain bins, swimming pools and grain dryers.

Per capita income in the county in 1970 was \$2,337. Since 1960 per capita income in the county has increased approximately 135 percent.

Total employment in the LaGrange and Buckner labor market area, which includes Oldham and its four surrounding Kentucky counties, averaged 349,060 in 1971 with agriculture providing 5,500 of these jobs, manufacturing 95,000, government 37,250 and trade and services 111,635. Jefferson County, the primary economic center of the area, provides 334,880 of these jobs including 93,140 manufacturing jobs.

That part of the LaGrange and Buckner labor market area which includes Oldham, Henry, Shelby, and Trimble Counties has a deficit of 2,595 manufacturing jobs when measured against the national industrial employment-population ratio. This indicates an area with a potential for additional manufacturing production.

Resources for Growth

1. There is a current estimated labor supply of 35,380 men and 44,350 women available for industrial jobs in the labor market area. In addition, 40,735 young men and 39,545 young women will become 18 years of age by 1979 and potentially available for work.

2. Highway transportation is provided by Kentucky Highways 146 and 53. Also there is an Interstate 71 interchange approximately 1 mile from LaGrange. LaGrange is served by five truck lines, and a United Parcel shipping center located 14 miles away at Louisville. Rail transportation is provided by the Louisville & Nashville Railroad. Commercial air service is available at Standiford Field in Louisville, 14 miles away.

3. Electricity for Oldham County is provided by Kentucky Utilities, Louisville Gas and Electric, and Shelby RECC. LaGrange is served by Kentucky Utilities Company and Buckner by Louisville Gas and Electric. Natural gas for LaGrange and Buckner is provided by Louisville Gas and Electric Company. There are over 20 distributors of propane and butane and over 30 distributors of distillate fuel oil that serve the LaGrange area.

4. Two sites at LaGrange and three sites at Buckner are available for industrial use.

5. LaGrange is served by the Oldham County School System. There are five universities, three senior colleges, one community college, one junior college and one technical institute within 70 miles of LaGrange. The nearest state vocational-technical school is located at Louisville, 14 miles away.

6. Nearby metropolitan Louisville offers complete industrial and commercial services.

Community Programs for Improvement

Recent:

A new boat dock located on the Ohio River.

Major city streets have been resurfaced.

Improvements in the Oldham County School System include: a new vocational school with six units, a phase elective social studies program at the senior high school, and renovation of the basement of Liberty Elementary School.

Planned:

A new motel by spring of 1974.

A truck stop and restaurant by end of 1974.

Bank of Oldham County is constructing a new main office.

2.

Planned improvements in the Oldham County School System include: complete renovation of the senior high school, pilot kindergarten program, and a curriculum study with a view toward the non-graded concept and individualized instruction.

Recreation, Entertainment and Livability

Oldham County is located on the Ohio River which provides many types of water recreation.

General Butler State Resort Park is located near Carrollton, approximately 30 miles away. This park offers lodge, camping, cottages, swimming pool, beach, bathhouse, boats, dock, fishing, winter ice skating, picnic area, playground, horseback riding, hiking, shuffleboard, miniature train ride, and golf course.

Louisville, only 14 miles away, offers a wide variety of sophisticated entertainment, cultural and sporting events. Some of the finest thoroughbred and harness racing in the world can be seen at Churchill Downs -home of the Kentucky Derby, Miles Park, and Louisville Downs. The University of Louisville offers year around sporting, cultural and educational events. In addition Louisville is also the home of the Kentucky Colonels professional basketball team.



WAGES

Occupational wage rates for specific industries are usually not available to most government agencies, and wage data furnished to state employment agencies by industrial employers is protected from disclosure by federal law. The most reliable up-to-date wage information can be obtained by direct contact with local employers.

Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data is compiled for over 130 clearly defined office, production, and service occupations. Tabulations are published for eight regions of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Commerce, Frankfort, Kentucky 40601.

HISTORY

Oldham County was formed in 1832 as the 74th Kentucky county. The territory was taken from Jefferson, Shelby, and Henry Counties. Later, Oldham County gave part of the territory that formed Trimble County. The county was named for Colonel William Oldham, a native of Virginia who served during the Revolutionary War and made his residence in Louisville.

LaGrange, the county seat, was named for the French estate of General Lafayette. When the town was chosen as the site for the county seat, it was called Lick Branch, but soon renamed LaGrange. It was incorporated in 1840.

In 1840 the population of Oldham County was 7,380. The population increased steadily until 1870 when it reached 9,027. In 1880 the population was shown at 7,667. The decline is attributed to the formation of Trimble County from part of Oldham County. Since then the population has gained steadily with the 1970 population reaching 14,687. Oldham County is composed of 184 square miles.

The 1970 population of LaGrange was 1,713.

Total employment in Oldham County averaged 3,270 in 1971 with agriculture providing 660 jobs, manufacturing 580, government 820, and trade and services 700 jobs. Major industrial products are copper magnet wire, storage silos, grain bins, swimming pools, and grain dryers.
