



LABOR ORGANIZATIONS:

There are no unions representing manufacturing workers in Taylorsville or Spencer County at this time.

TRANSPORTATION:

Rail: The nearest rail service is the Southern Railway System, at Shelbyville, with two through freights daily.

Highways: I-64 is 16 miles north via Kentucky 55, a "AAA" 80,000 pounds gross load limit road. I-65 is 22 miles west on Kentucky 44, a "AAA" rated road. The Bluegrass Parkway is 13 miles south via Kentucky 55.

Truck: Taylorsville Transfer Line serves Taylorsville and provides intrastate motor carrier service.

Water: The nearest navigable river is the Ohio River at Louisville, 31 miles away.

Air: Commercial air service is available at Standiford Field in Louisville, 27 miles away. TWA, American, Eastern, Delta, Piedmont, Ozark, Allegheny and Air Kentucky (commuter service) serve the area.

UTILITIES:

Electricity: Taylorsville is served by Kentucky Utilities Company. Salt River RECC and Fox Creek RECC serve Spencer County.

Natural Gas: There is no natural gas service in Taylorsville.

Other Fuels: There are two propane dealers in Taylorsville and one in Mt. Washington. Distillate fuel oil is available from two dealers in Bloomfield and one in Bardstown. Dealers are also located in Shelbyville, 20 miles away, and in Louisville, 31 miles away.

WATER AND SEWERAGE:

Water: The City of Taylorsville Water Works serves the city and Spencer County with a treatment plant capacity of 487,000 gallons per day. Average daily consumption is 475,000 gallons. The source of raw water is Salt River. Storage capacity is 805,000 gallons.

Sewerage: The Taylorsville Sewage Treatment Plant serves the city and has a design capacity of 114,000 gallons per day. Average daily flow is 68,000 gallons and treatment is secondary.

GOVERNMENT STRUCTURE:

City: 5-member Board of Trustees - 2-year terms

County: County judge - 4-year term; 6 magistrates - 4-year terms

COMMUNICATIONS:

Telephone Company: South Central Bell Telephone Company serves Taylorsville.

Newspaper: The Spencer Magnet is published weekly and has a circulation of 2,000.

Radio Station: Stations are received from Louisville, Bardstown and Shelbyville.

Television: Four Louisville stations are received.

OTHER LOCAL FACILITIES:

Hospitals: King's Daughters' Hospital at Shelbyville, 20 miles away, has 76 beds.

Churches: There are 18 churches in Taylorsville. Denominations are Assembly of God, Baptist, Christian, Methodist, Pentecostal and Roman Catholic.

Financial Institutions: The Peoples Bank provides financial services to Taylorsville.
