FLEMINGSBURG, KENTUCKY - A RESOURCE PROFILE

Flemingsburg, the county seat of Fleming County, is located in the Outer Blue Grass Region in northeastern Kentucky. Flemingsburg is located 57 miles northeast of Lexington, Kentucky; 81 miles southeast of Cincinnati, Ohio; and 228 miles north of Knoxville, Tennessee. In 1984, the city had an estimated population of 2,721.

Fleming County, with a total land area of 351 square miles, is characterized by gently rolling terrain. In 1985, the county had an estimated population of 12,433.

The Economic Framework - The total number of Fleming County residents employed in 1986 averaged 5,590. In 1985, manufacturing firms in the county reported 555 employees; wholesale and retail trade provided 640 jobs; 210 people were employed in service occupations; state and local government accounted for 710 employees; and contract construction firms provided 65 jobs.

Labor Supply - There is a current estimated labor supply of 5,845 men and 7,490 women available for industrial jobs in the labor market area. In addition, from 1987 through 1991, 3,370 young men and 3,240 young women in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Rail service is provided by T.T.I. Systems, Inc. at Flemingsburg Junction, five miles northwest of Flemingsburg. Major highways directly serving Flemingsburg are Kentucky Routes 11 and 32. Both are "AAA"-rated trucking highways and provide access to Interstate 64. Nine trucking companies provide interstate and/or intrastate service to the city. The Fleming-Mason Airport, seven miles north of Flemingsburg, has a paved 5,000-foot runway. The nearest scheduled commercial airline service is available at the Blue Grass Airport near Lexington, 62 miles southwest of Flemingsburg.

Power and Fuel - Electric power is provided to Flemingsburg and parts of Fleming County by the Kentucky Utilities Company. Fleming County also is served electric power by the Fleming-Mason Rural Electric Cooperative Corporation. Flemingsburg is provided natural gas service by the Flemingsburg Utilities System. Five distributors of propane and three distributors of distillate fuel oil serve Flemingsburg.

Education - Primary and secondary education is provided to Flemingsburg and Fleming County by the Fleming County School System. Eight colleges and universities are located within 60 miles of Flemingsburg. The Rowan State Vocational-Technical School in Morehead, 27 miles southeast, provides vocational training in 18 courses. The Maysville Area Vocational Education Center in Maysville, 17 miles north, offers training in nine courses.

LABOR MARKET STATISTICS

The Flemingsburg Labor Market Area includes Fleming County and the adjoining Kentucky counties of Bath, Lewis, Mason, Nicholas, Robertson and Rowan.



Occupational wage rates for specific industries are usually not available to most government agencies, and wage data furnished to state employment agencies by individual industrial employers are protected from disclosure by federal law. The most reliable up-to-date wage information can be obtained by direct contact with local employers.

Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data are compiled for over 127 clearly defined office, production, and service occupations. Tabulations are published for nine geographical areas of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Economic Development, Frankfort, Kentucky 40601.

TRANSPORTATION

Rail

Flemingsburg is not served directly by a rail line; however, rail service is available at Flemingsburg Junction, 5 miles northwest.

Line serving Flemingsburg Junction - T.T.I. Systems, Inc.

Services - Connecting rail line between the CSX system at Maysville and the CSX system at Paris; three local freights operate daily from Paris to Maysville and return; switching services; weighing services; various team track and siding space available. Highways

Major highways serving Flemingsburg are Kentucky Highways 11 and 32, both "AAA"-rated trucking highways (80,000-pound gross load limit). Kentucky Route 57 is also "AAA"-rated north of Flemingsburg. U. S. Highway 68, which provides access to Lexington, is located 25 miles southwest via Kentucky Routes 32 and 36.

Interchanges of Interstate 64, a major east-west route, are located 24 miles southeast of Flemingsburg via Kentucky 32, and 30 miles southwest via Kentucky 11.

The Flemingsburg Bypass extends from Kentucky 32 East around the west side of the city and connects with Kentucky 11 North.

The AA Highway, which is presently under construction, will be accessible 12 miles north of Flemingsburg via Kentucky 11. The AA Highway will extend from the Interstate 275/Kentucky Route 9 interchange near Cincinnati east to Interstate 64 near Grayson, Kentucky.

Local Fees and Licenses

The city of Flemingsburg levies a one percent occupational license tax on the gross wages of individuals employed within the city. A business license fee of 9/20 of one percent of annual gross income is levied on professions, with a minimum annual fee of \$200. Business license fees for firms with annual gross receipts of \$200,000 or less range from \$80 to \$160 per year, depending on the type of business. Firms with annual gross receipts more than \$200,000 are assessed a flat fee based on gross receipts.

A 3 percent tax is levied on utilities receipts for schools in Fleming County. Tax is paid by all consumers of utilities as an add-on to the utilities bills. Exempted are receipts from utilities services that are resold and the receipts from the sale of energy or energy producing fuels that exceed 3 percent of the cost of production in manufacturing, processing, mining or refining.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

RECREATION

Local

Flemingsburg offers a variety of public recreation facilities which include a city park. Facilities at the park include a lighted baseball field, two basketball courts, a tennis court, playground equipment, and a shelter.

The city and county governments have jointly funded a 124-acre industrial park, which includes a 23-acre recreational park. Facilities at this park include: three lighted softball and baseball fields, two basketball courts, volleyball, three lighted tennis courts, swimming pool, horse ring, playground, and a shelter with kitchen facilities, stage, and dressing rooms.

Private recreation facilities include a country club, golf course, a health and fitness center, and a drive-in movie theater.

Court Day is held in Flemingsburg every year on the second Sunday and Monday of October and is one of the area's most popular events. During this time, items of every description are sold and traded.

Other attractions in Fleming County include three of the state's fifteen covered bridges and a recently renovated railroad depot.

Area (Within 50 miles)

Fox Valley Recreation Area, 7 miles southeast of Flemingsburg, is a 225-acre park and lake with facilities for camping, fishing, picnicking, and hiking.

Blue Licks Battlefield State Park is located near Mt. Olivet, 15 miles west of Flemingsburg. The 100-acre park is on the site of the last Revolutionary War battle in Kentucky. A museum features Indian and pioneer artifacts, an audiovisual program, and prehistoric bones from animals trapped at Blue Licks. Facilities include 51 campsites, a gift shop, picnic shelters and grills, miniature golf, a snack bar, and an Olympic-size swimming pool. Fishing is available at the Licking River which runs through the park.

Cave Run Lake, constructed by the U.S. Army Corps of Engineers, is located 33 miles southeast of Flemingsburg within the 640,000-acre Daniel Boone National Forest. The lake area offers everything for the camper, the boatsman, the hunter, the fisherman, and "the lover of leisure."

Carter Caves State Resort Park, 50 miles east of Flemingsburg, provides a restful atmosphere with its mountain wildflowers, a rippling stream, the underground wonders of three caves, a 28-room lodge, a restaurant, and a gift shop. Recreational facilities available include something for the whole family with playgrounds, two swimming pools (one Olympic-size), tennis courts, shuffleboard, a 9-hole golf course, miniature golf, boating, fishing, hiking, horseback riding, picnicking, and cave tours.

COMMUNITY IMPROVEMENTS

Recent

Flemingsburg Utilities System completed a \$5 million expansion project to the sewage treatment plant in September 1986. The expansion increased the design capacity to 1.2 million gallons per day.

A new 500-watt radio station, WFLE-AM, recently began operation. The station is located in the industrial park.

Fleming Homes began operations at its 60,000-square-foot facility in March 1986. Fleming Homes presently employs approximately 150 people and manufactures mobile homes.

The Flemingsburg Bypass, which connects Kentucky 11 North and Kentucky 32 East, was completed in 1986.

Randall-Textron recently completed a 15,000-square-foot expansion project at its Flemingsburg plant. The \$200,000 expansion is expected to provide a 7% to 10% increase in employment in 1987

The Fleming-Mason Airport recently completed a project which extended the runway to 5,000 feet.

Flemcote, Inc., recently began operations in Flemingsburg. Services performed at the facility are: reworking hydraulic cylinders, sandblasting, welding, steam cleaning, and chemical sales. Flemcote presently employs seven persons.

The Fleming County School System recently completed construction of a \$152,000 gymnasium at an elementary school and a track at the high school. A television production studio was also constructed to be used by media classes and the community to tape, edit, and produce programs. Many of the programs are broadcast over a local access channel.


Under Way

The Farmers Deposit Bank is currently constructing an 8,000-square-foot addition to its Flemingsburg facility. The \$800,000 project is scheduled to be completed in the summer of 1987.

An eight-mile segment of Kentucky 11 North from Flemingsburg to Lewisburg is planned to be reconstructed. The project will consist of rerouting portions of the highway and adding passing lanes. Construction is scheduled to begin in the summer of 1987.

A downtown revitalization project is planned for Flemingsburg and is scheduled to be initiated in 1988. The project will include improvements to landscapes, store fronts, and streets and sidewalks.

A neighborhood redevelopment project is planned for the "Bottom" Neighborhood section of Flemingsburg. The \$780,000 project will consist of replacing substandard housing with new housing, drainage construction, and street improvements.
