

WARSAW, SPARTA AND GLENCOE, KENTUCKY A RESOURCE PROFILE

Warsaw, the county seat of Gallatin County, is a small river community situated in a beautiful and highly productive valley. Located in the north central portion of the county, Warsaw is 39 miles southwest of Cincinnati, Ohio; 61 miles northeast of Louisville, Kentucky; 228 miles northeast of Nashville, Tennessee; and 325 miles east of St. Louis, Missouri. In 1973, Warsaw had an estimated population of 1,323.

Sparta, located in the southwestern part of the county, had a 1973 estimated population of 214. Glencoe is located in the south central part of the county and had a 1973 estimated population of 256.

Gallatin County, with a land area of 100 square miles, is located in the north central portion of Kentucky. The Ohio River forms the entire northern boundary of the county. In 1975, Gallatin County's population was estimated to be 4,400.

The Economic Framework

The total number of Gallatin County residents employed in 1974 averaged 1,260, including 235 in agriculture and 200 in government. Manufacturing employers in the county reported 40 workers; trade and services firms employed 200. The major industrial product is wood household furniture.

Total unemployment in Gallatin County averaged 4.3 percent of the labor force in 1974.

Per capita personal income in the county in 1974 was \$3,767, an increase of 55.7 percent since 1970.

The Warsaw, Sparta and Glencoe labor market area includes Gallatin and the four adjoining counties. The total number of residents of the labor market area employed in 1974 averaged 25,760, including 3,080 in agriculture and 3,880 in government. Manufacturing employers in the labor market area reported 6,145 workers; trade and services firms employed 6,150.

Resources for Growth

- 1. Labor Supply There is a current labor supply of 1,690 men and 2,290 women available for industrial jobs in the labor market area. In addition, 3,440 young men and 3,250 young women in the area will become 18 years of age before 1982 and potentially available for work.
- 2. Transportation The Louisville and Nashville Railroad serves Sparta and Glencoe. Interstate 71 is routed through Gallatin County with two interchanges located in the county. This major highway extends from Louisville to Cincinnati and connects with the north-south Interstate 75 in Boone County, Kentucky. U. S. Highways 42 and 127 and Kentucky Highways 16, 35, 184, 455, and 465 also serve Gallatin County. Two truck lines serve Gallatin County. Commercial air service is available at the Greater Cincinnati Airport, 35 miles from Warsaw. The Ohio River forms the northern boundary of Gallatin County and affords the county with water transportation capabilities.
- 3. Utilities and Fuel Warsaw, Sparta, and Glencoe are supplied electric power by the Kentucky Utilities Company. Owen County RECC serves most of Gallatin County, with the Kentucky Utilities Company serving the remaining part of the county. Union Light, Heat and Power Company provides natural gas service to Warsaw and Glencoe. Natural gas service is not available in Sparta. There are four distributors of propane and seven distributors of distillate fuel oil serving Gallatin County.
- 4. Education One public school system the Gallatin County School System operates in the county. Four universities, nine senior colleges, and one community college are located within 60 miles of Warsaw. The Northern Kentucky State Vocational-Technical School, 37 miles from Warsaw, offers training in twenty course areas. The Carroll County Area Vocational Education Center, 17 miles from Warsaw, offers six courses.



WAGES

Occupational wage rates for specific industries are usually not available to most government agencies, and wage data furnished to state employment agencies by individual industrial employers is protected from disclosure by federal law. The most reliable up-to-date wage information can be obtained by direct contact with local employers.

Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data is compiled for over 127 clearly defined office, production, and service occupations. Tabulations are published for seven regions of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Commerce, Frankfort, Kentucky 40601.

Gallatin County's location places it within easy access to four major interstate highways. Interstate 71 is routed through Gallatin County with two interchanges located in the county. This major highway extends from Louisville to Cincinnati and connects with the north-south Interstate 75 in Boone County, Kentucky. Interstate 71 also connects with Interstate 64 and Interstate 65 at Louisville.

Gallatin County is also served by U. S. Highway 42 and 127 and Kentucky Highways 16, 35, 184, 455, and 465.

A bridge is under construction over the Ohio River at the site of the Markland Dam. The bridge will connect U. S. 42 in Kentucky with state highway 156 in Indiana and is scheduled for completion in June 1978.

Property Taxes

Land and buildings are taxed by the state and may be taxed by local jurisdictions. The state rate is \$0.015 per \$100 of assessed valuation.

Tangible personal property owned by manufacturers (automobiles, trucks, finished goods, office furniture, office equipment) is taxed by the state at \$0.15 per \$100 and may be taxed by local jurisdictions.

Manufacturing machinery, raw materials inventories, pollution control equipment, and goods in process inventories are not subject to local taxation. The state rate is \$0.15 per \$100.

RECREATION

Local

Public recreational facilities in Warsaw include two baseball diamonds, a tennis court, a playground, a volleyball court, and a horseshoe pitching complex. Four boat docks and ramps are located on the Ohio River in Gallatin County. Warsaw has several supervised baseball leagues including T-ball, Little League, and Youth League. In addition, the Junior and Senior Youth Softball Tournaments and the Women's District Softball Tournament are held in Warsaw. Sparta and Glencoe each have a basketball court, a baseball diamond, and supervised ball leagues.

Tourist attractions in Gallatin County include the Regional United Powerboat Association races each August, the Annual Water Festival, the Markland Dam, and ferry rides across the Ohio River.

Area (Within 60 miles)

General Butler State Resort Park, 17 miles from Warsaw, is an 809-acre park located near the confluence of the Ohio and Kentucky Rivers. The park offers lodge and cottage accommodations and camping sites. Recreational facilities include a 25-acre lake, a swimming pool, a dock, riding stables, hiking trails, a miniature golf course, and a 9-hole golf course. A main attraction at the park is the Butler Mansion, a museum of Ohio River lore.

Big Bone Lick State Park, 15 miles from Warsaw, is the site of an ancient salt sulphur spring used by prehistoric animals. The park museum has exhibits of many bones and teeth of mammoth elephant and mastodon. Facilities are available for camping, swimming, and picnicking.

Kincaid Lake State Park, near Falmouth, is a 446-acre park located on the 175-acre Kincaid Lake. The park provides facilities for camping, boating, swimming, hiking, shuffleboard, badminton, and miniature golf.

With easy access to Interstate 71, Louisville, Kentucky, and Cincinnati, Ohio, can be reached in less than an hour's driving time. These metropolitan areas offer the full spectrum of sophisticated entertainment, cultural and sporting events.

COMMUNITY IMPROVEMENTS

Warsaw

In 1975, Warsaw was named an ''All-Kentucky City, '' an award granted for outstanding achievement in community development.

Warsaw received a grant from the U. S. Environmental Protection Agency to conduct a 201 Facilities Plan. The study, which is designed to determine what improvements are needed to upgrade the sewerage system, is to begin in September of 1976.

The storm sewer system in the downtown area has been upgraded.

A \$14,000 street resurfacing project has been completed.

The city purchased a new radio-patrol car and two walkie-talkies for the police department and new service truck for the water department.

Local merchants participated in a facelifting project to improve the storefronts in the downtown business district.

The Gallatin County News purchased new compugraphic equipment to set headlines and columns.

Two new subdivisions are being developed.

Sparta

A volunteer fire department has been organized and a pumper and other fire equipment has been purchased. There are plans to construct a fire station.

The Sparta-Sanders State Bank built a new board room which is also used for civic functions.

The Baptist Church constructed a new building.

The city plans to apply for funds for the development of a recreation area.

Glencoe

Two residential streets are being upgraded and additional street lighting is being installed.

There are plans to develop a community Little League ball field.

The city plans to purchase a police cruiser.

Gallatin County

Cleanco Terminals, a facility which transfers coal from rail cars to barges, is now in operation.

Beatty, Inc., a river salvage operation, recently located in Gallatin County.

The Kentucky Utilities Company power plant near Gallatin County will have a new 511 MW unit on line early in 1977.

The Gallatin County High School has been remodeled at a cost of \$700,000. Phase Elective English and Social Studies have been incorporated into the high school curriculum and plans are underway to include career education and consumer education in the high school program. The school system plans to build a vocational agricultural shop, an elementary library, an elementary physical education area, and five to seven additional classrooms.

A bridge is under construction over the Ohio River at the site of the Markland Dam. When completed in June, 1978, the bridge will connect U. S. 42 in Kentucky with state highway 156 in Indiana.

The Gallatin County Fire Department has a new 1,000 gpm pumper.

HISTORY

Gallatin County, the thirty-third county formed in the state, dates from 1798. It was taken from Franklin and Shelby Counties. Several years after its establishment portions of Gallatin County were given up to help form three additional counties: Owen in 1819, Trimble in 1836, and Carroll in 1838. Gallatin borders on the Ohio River for several miles on its northwestern side. Since the Kentucky state line follows the northern or Indiana shore line of the river, there have been slight fluctuations in Gallatin County's size caused by sand bars filling in or by washing away.

The surface of Gallatin County is generally hilly, and is influenced by the escarpment which separates the higher ground from the Ohio River Flood Plain. The soil is usually productive, especially in the river and creek bottoms.

Gallatin County was named for Albert Gallatin, American statesman and financier who became a member of the United States Senate before he reached his fortieth birthday. Gallatin also served as Secretary of the Treasury under Thomas Jefferson and as minister to France and Great Britain.

Warsaw, the county seat is located on the Ohio River in a beautiful and highly productive valley. It was settled around 1800 and was called "The Ohio River Landing." Later, it was called Fredericksburg in honor of the most energetic and enterprising townsman, Adolph Frederick. In 1831, the name was changed again because another town had a similar name. Captain John Blair Summons suggested the name "Warsaw" after the book entitled, Thaddeus Warsaw.

Warsaw was once a prominent river port. Today it depends on its position as the county seat and a rural trading center for a livelihood.

Other towns in the county include Sparta, Glencoe, and Napoleon. Sparta was once famous for fine beverages. Glencoe prospered as a railroad town, and Napoleon, once prosperous to the degree of being incorporated by the state legislature in 1841, reached the peak of its importance a hundred years ago, then slowly declined.

Gallatin County reached its peak in population in 1820, with 7,075 people. The population then fluccuated over the next eight decades and had declined to 5,163 by 1900. By 1960, the population showed a further decline to 3,867 with a slight increase to 4,134 by 1970. In 1975, the population was estimated to be 4,400.

In 1973, Warsaw had an estimated population of 1,323, Sparta had 214, and Glencoe had 256.

The total number of Gallatin County residents employed in 1974 averaged 1,260, including 235 in agriculture and 200 in government. Manufacturing employers in the county reported 40 workers and trade and services firms employed 200. The major industrial product is wood household furniture.
