UNION COUNTY, KENTUCKY - A RESOURCE PROFILE

Location

Union County, located in the Western Coal Fields Region of northwestern Kentucky, is 236 miles west of Louisville, 185 miles northwest of Nashville, Tennessee, 174 miles southeast of St. Louis, Missouri, and 30 miles southwest of Evansville, Indiana. Union County ranks ninth among the counties in the total amount of coal produced in Kentucky, and has the most modern mine in the United States. The Ohio River forms the northern and western boundaries of the county. The 1970 county population was 15,882.

Morganfield, the county seat and an "All Kentucky City," had a 1970 population of 3,563.

Sturgis, 11 miles southwest of Morganfield, had a 1970 population of 2,210.

Uniontown, 7 miles north of Morganfield, had a 1970 population of 1,255.

The Economic Framework

Total employment in Union County averaged 5,400 in 1969 with manufacturing providing 400 jobs, trade and services 1,580 jobs, and government 300 jobs. Since 1960 manufacturing employment has increased by approximately 40 percent. Major industrial products are wire display equipment, vacuum metallizing, metallescent spray, men's clothing, and baseball and tennis caps.

Per capita personal income in the county in 1969 was \$2,870. Between 1959 and 1969, per capita personal income in the county increased 97 percent.

The Union County labor market area includes Union County and the three adjoining Kentucky counties; Posey County, Indiana; and Gallatin and Hardin Counties, Illinois. In 1969, employment in the Kentucky portion of the labor market area totaled 25,200 with manufacturing providing 4,800 jobs, trade and services 5,585 jobs, and government 2,300 jobs. Industrial employment in this area has increased approximately 31 percent since 1960, with the sharpest gains in machinery and metal products industries, rubber and plastics industries, and printing, publishing and paper industries.

Despite industrial gains in recent years, this area still has a deficit of 2,837 manufacturing jobs when measured against the national industrial employment-population ratio. This indicates an area where potential for additional manufacturing production is good.

Resources for Growth

1. There is a current estimated labor supply of 1,685 men and 2,290 women available for industrial jobs in Union County and the surrounding Kentucky counties. In addition, 3,830 young men and 3,745 young women in this area will become 18 years of age by 1977 and potentially available for employment. Also, the current labor supply would be increased by the number of men and women in the adjoining Indiana and Illinois counties who are available for industrial jobs.

2. The Illinois Central Railroad serves Union County. Major highway access is by U. S. Highways 60 and 641 and nine Kentucky highways. The Sturgis Airport has three paved 5,000-foot runways which can accommodate jet aircraft. The newly opened airport at Camp Breckinridge has a 3,000-foot runway and can accommodate light aircraft. Commercial air service is available at Dress Memorial Airport, Evansville, Indiana, only 30 miles from Morganfield.

3. Electrical power is available in large quantity from the Kentucky Utilities Company and Henderson-Union RECC. The Morganfield Gas Company and the Sturgis Gas Company are supplied by the Texas Gas Transmission Corporation. The raw water supply is adequate for continued growth.

4. Industrial sites - There are two industrial sites in Morganfield, one in Sturgis, and one in Uniontown.

5. Education is an important part of Union County's future development. One new consolidated school system operates in Union County. Four senior colleges and one community college are within a 50-mile radius.

The Union County Vocational-Extension Center is located midway between Morganfield and Sturgis and offers four different courses. The Daviess County Area Vocational School at Owensboro is only 52 miles away and offers 21 different courses.

Community Programs for Improvement

The communities of Union County, by pooling their resources, have made major civic strides. These achievements include a new ultramodern hospital, consolidated high school, and vocational school. Some of the other

county improvement projects include: an extensive enlarging and remodeling of Morganfield's public library, completion of the Union County Rural Water System, a new youth center, and the inauguration of an adult education class at Union County High School.

In 1970, Morganfield was designated as an "All Kentucky City." The award was the result of successful community programs. The city is actively continuing its programs for community improvement. Projects which have been beneficial in the city's growth include: acquisition of a 4,000,000 gpd water treatment plant and distribution system at Camp Breckinridge, nine new businesses during 1970, extensive remodeling of fourteen buildings, the installation of attractive metal litter containers in the downtown district by the Jaycees, the installation of planters and flower gardens by several businesses, the opening of a new music studio, extensive additions and improvements to elementary and junior high schools, the development of three new subdivisions plus one in the planning stage, a contract let for construction of a country club and clubhouse, and bids let for the construction of a swimming pool.

Recent community improvements in Sturgis include: a flood protection wall, a new sewerage and water system, a new municipal building, a new subdivision, a new recreation area and lake, a new marina on the Ohio River, a new rest home, several new churches, a new low-rent housing project, a clean-up campaign for the city, the organization of a planning commission, a FHA Economic Planning Commission, and radio equipment and lights for the airport.

Uniontown's community improvements include the imminent construction of a new sewerage system.

Recreation, Entertainment and Livability

1. John James Audubon State Park, 30 miles distant, has cottages and camping accommodations, a 28-acre recreational lake, beach, bathhouse, paddle boats, dock, and art museum. Recreational facilities include swimming, fishing, hiking, picnicking and golfing.

2. Ellis Park provides Thoroughbred racing and Audubon Raceway provides harness racing.

3. Pennyryle Forest State Park, 50 miles distant, is a 436-acre resort park with lodge, lake, cottages and camping accommodations. The park facilities include: forest, lodge, swimming pool, fishing, golfing, horseback riding, hiking, and picnicking.

4. Lake Barkley, 55 miles distant, has 1,004 miles of shoreline. Its reservoir covers 93,000 acres. Recreation includes fishing, boating, camping, swimming, hunting and picnicking. The dam near Grand Rivers is 157 feet high and 10,180 feet long.

5. Kentucky Lake, 60 miles distant, with 2,380 miles of shoreline, is the longest of any man-made lake in the world. Recreation includes fine fishing and water sports, swimming, boating, and water skiing. The huge dam is TVA's largest and controls the waters of the Tennessee River near its junction with the Ohio River at Paducah. The dam is 206 feet high, 8,422 feet long, and cost \$115 million.

6. Land Between the Lakes National Recreation Area is a 170,000-acre wooded peninsula formed by Kentucky and Barkley Lakes. Recreation includes fishing, water sports, hunting, and camping.

7. Theatrical productions are presented at Henderson Community College.

8. Excellent musical entertainment is provided by the Evansville Philharmonic Orchestra.

HISTORY

Union County, the fifty-fifth county established in Kentucky, dates from 1811. Its territory was taken from Henderson County. Later it gave up lands to help form Webster County (1860). Highland Creek forms a portion of its eastern boundary, Tradewater River flows along its southern side, and the Ohio skirts its entire western and northern edges for a distance of forty-one miles. It lies across the Ohio River from the mouth of the Wabash, hence it has a common boundary with Illinois and Indiana.

It is believed that Union County was so named because of the overwhelming sentiment on the part of the people in Henderson County, the parent county, for a new governmental unit to be organized. It became the only county in Kentucky whose name cannot be definitely pinpointed regarding its origin.

The first settlers came to Union County in 1805 from other areas in Kentucky and from Virginia and North Carolina. They were lured by the abundance of natural resources, fertile lands, and the ease by which land claims could be obtained. They also were attracted to the area because of its mild climate and comparative safety from the Indians who usually bypassed it on their hunting expeditions, and who, by the beginning of the nineteenth century, were moving westward as a result of defeats and treaties at the hands of the whites. The first town established was Morganfield, the county seat, whose site was chosen in 1811 on land that belonged to Presley O'Bannon. The survey was made by James Townsend. James Riddle became the first resident due to the fact that he lived on that part of O'Bannon's land which was given to the town. A few months later Ephraim Sellars came from North Carolina and settled in the village. James Holloway built the first brick house, and Aquilla Doris taught the first school, a short term session paid for by subscription in 1813, in a log house built for that purpose. Saint Vincent's Academy, a boarding school for girls, was erected in 1820. This was one of the first institutions of its kind in the state and is still in use.

Union County had a normal growth through the years with no one thing to distinguish it from many other healthy, prosperous counties until 1942 when the United States Government purchased 38,000 acres of land a few miles east of Morganfield and established an army installation known as Camp Breckinridge. As many as 40,000 men in armored units were trained there during the Second World War. The impact of this camp upon Morganfield and the county was tremendous. Housing became a problem, overcrowded schools demanded more attention than could be given to them, and churches and family life conditions experienced revolutionary changes. At the end of

the war the camp was closed. The effects on the physical and social conditions of the community were too great for sudden readjustment. While the people were struggling with readjustment problems, the camp was reopened on a temporary basis and the people were forced to adjust to "army life" again.

Morganfield, the county seat, is 439 feet above sea level. It was named for General Daniel Morgan of the Revolutionary period who defeated the British under General Sir Banastre Tarleton at the Battle of Cowpens on January 17, 1781. He was awarded a gold medal by Congress. Morgan originally owned the land on which Morganfield stands before he sold it to Presley O'Bannon. Morganfield is built on rolling uplands whose farmers early pioneered in growing soil-enriching Korean lespedeza. The town has a 26-acre combined city park, playground, and athletic field. It was the scene of some Civil War fighting. On September 1, 1862, Colonel Shackelford's Eighth Kentucky Cavalry defeated Adam R. Johnson's troops in a sharp engagement east of the town.

Sturgis, located in the southern end of the county, was incorporated on May 3, 1890, and named for a prominent family named Sturgis who lived there. The town grew up with the demand for coal.

Ormsby McKnight Mitchell has been called the "Pioneer Astronomer of America" by some due to his establishment of the Harvard University Observatory and the Naval Observatory at Washington. The Cincinnati Observatory, later named the Mitchell Observatory, was built in his honor. Charles John O'Malley was known as the "Farmer Poet" of Kentucky. Nancy Huston Banks had a wide reputation as a writer. Among her novels were Stairs of Sand and The Little Hills. Earle C. Clements served as Governor of Kentucky from 1947 to 1950 and has been given credit for the organization of Kentucky's parks into a system in 1948. His administration also improved the public school system, state highways, and made steps to conserve the natural resources in the state. He resigned from the Governorship to become United States Senator in 1950.
