

ALBANY, KENTUCKY - A RESOURCE PROFILE

Albany, the county seat of Clinton County, is located in south-central Kentucky. In 1988, Albany had an estimated population of 2,170. Albany is located 133 miles southwest of Lexington, Kentucky; 127 miles northeast of Nashville, Tennessee; 136 miles northwest of Knoxville, Tennessee; and 152 miles southeast of Louisville, Kentucky. Clinton County, with a 1988 estimated population of 9,600, is bordered to the south by the Kentucky-Tennessee state line.


The Economic Framework - The total number of Clinton County residents employed in 1988 averaged 3,840. Manufacturing firms in the county reported 870 employees; wholesale and retail trade provided 350 jobs; 280 people were employed in service occupations; state and local government accounted for 400 employees; and contract construction firms provided 80 jobs.

Labor Supply - There is a current estimated labor supply of 7,140 persons available for industrial jobs in the labor market area. In addition, from 1990 through 1994, 3,580 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Albany is served by U.S. Highway 127 and Kentucky Route 1590, both "AAA"-rated trucking highways. Clinton County is served by Kentucky Route 90, also a "AAA"-rated trucking highway. The Cumberland Parkway is located 35 miles north of Albany, while Interstate 40 is located 49 miles south of Albany. Interstate 65 and Interstate 75 are located 70 miles northwest and 79 miles east, respectively. Seven trucking companies provide Albany with interstate and/or intrastate service. Nashville Metropolitan Airport provides the nearest scheduled commercial airline service, six miles southeast of Nashville, Tennessee, 133 miles southwest of Albany. The Spring Creek Airport, four miles south of Albany, has a 2,400-foot paved runway. The Monticello-Wayne County Airport, one and one-half miles north of Monticello, 27 miles northeast of Albany, maintains a 4,000-foot paved runway. The nearest rail service is provided by Southern Railway System at Burnside, 46 miles northeast of Albany.

Power and Fuel - Electric power is provided to Albany and Clinton County by South Kentucky Rural Electric Cooperative Corporation. Natural gas service is provided by Albany Gas Utility Company.

Education - Primary and secondary education is provided to Albany and Clinton County by the Clinton County School System. Twelve institutions of higher learning are located within 110 miles of Albany. Vocational training is available at the Clinton County Area Vocational Education Center in Albany, and the Somerset State Vocational-Technical School in Somerset, 54 miles northeast.



LABOR MARKET STATISTICS

The Albany Labor Market Area includes Clinton County and the adjoining Kentucky counties of Cumberland, Russell, and Wayne. In addition, the Labor Market Area is supplemented by Pickett County in Tennessee, which forms the southern boundary of Clinton County.



UNEMPLOYMENT RATES 1988






PER CAPITA PERSONAL INCOME

PER CAPITA PERSONAL INCOME 1987




AVERAGE PLACEMENT WAGES

Clinton County is served by the Somerset local office of the Kentucky Department for Employment Services. The focus of the following data is on job placements made by the Somerset local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1989, the local employment office filled 5,504 job openings in various occupational categories. 

LOCAL GOVERNMENT

Structure

Albany is governed by a mayor and six council members. The mayor is elected to a four-year term, while the council members each serve two-year terms. Clinton County is governed by a county judge/executive and five magistrates. Each county official is elected to a four-year term.

Planning and Zoning

Albany and Clinton County are not served by a planning and zoning commission at the present time.

Local Fees and Licenses

The City of Albany levies business license fees ranging from \$15 to \$300 annually, depending on the type of business.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

Local recreational facilities in Clinton County include a VFW ball park, 76 Falls Country Club which offers a nine-hole golf course, and a community center.

The fiscal court of Clinton County purchased a 14-acre tract of land for the purposes of developing a recreational park.

The Foothills Festival is an annual week-long event held in October. Activities include: dances, horseshoe pitching, a beauty pageant, Old Fashioned Days, a parade, music, a 5K run, a dog show, a clown show, sky divers, a bike-a-thon, square dancers, crafts sales, displays, and many more exciting events.

Dale Hollow Lake State Park is located alongside 48 square miles of surface water in southeastern Cumberland and Clinton Counties. Park facilities include a marina, a picnic area, and 144 sites for tent and trailer camping. Dale Hollow Lake straddles the Kentucky-Tennessee state line. Several private recreation facilities are located near the lake.

Lake Cumberland State Resort Park near Jamestown, 16 miles north of Albany, is a 3,000-acre park located on the 50,000-acre Lake Cumberland, which sports excellent bass, bluegill, and crappie fishing. The park features a modern 76-room resort lodge which is perched on a high bluff above the lake. The lodge offers an indoor and outdoor swimming pool, a dining room, a gift shop, and a multi-purpose activities center. Other park facilities include an additional swimming pool, riding stables, tennis courts, hiking trails, a 9-hole golf course, miniature golf, a nature center, a picnic area, and a playground. A marina offers houseboats and fishing boats and motors for rent plus year-round launching ramps.

National Manufacturing and Design Corporation recently located a plant in Albany. The 35-employee operation produces ladies' blouses.

Mountain Cheese Products, Inc. re-opened the former Eagle Pass Cheese Company. Under this new ownership, the facility will process cheddar cheese. The company plans to expand soon, which will include the introduction of a new product line of cheese and an increase of employment by ten persons.

The Clinton County Fiscal Court recently constructed a 12,000-square-foot "spec" building with access to utilities on its 57-acre industrial site.

The Albany Municipal Sewer System recently completed a \$2 million project, which included the installation of collector lines and new pump stations throughout the city.

The fire insurance rating in Albany was recently reduced from eight to seven.

The Clinton County School System recently instituted several new programs including advanced placement course offerings at the high school, dual-credit courses offered in cooperation with area colleges, and KET Distant Learning by satellite.

Lindsey Wilson College in Columbia, Kentucky recently opened a branch campus at Albany.


Planned

Contingent upon funding appropriations, the water plant in Albany will be upgraded to a capacity of two million gallons per day.

The Albany Municipal Sewer System is planning to construct a four-inch force main, an eight-inch collector main, and two pumping stations to serve industrial customers on the west side of Albany at Kentucky Highway 1590. The \$46,000 project is scheduled for completion by March 1990
