CAMPBELLSVILLE, KENTUCKY - A RESOURCE PROFILE

Location

Campbellsville is an attractive college town located in the Mississippi Plateau region of southcentral Kentucky. The city is 82 miles southeast of Louisville, Kentucky, 83 miles southwest of Lexington, Kentucky, 149 miles northeast of Nashville, Tennessee, and 164 miles southwest of Cincinnati, Ohio.

Campbellsville, the county seat of Taylor County, had a 1970 population of 7,598. Taylor County had a 1970 population of 17,138.

The Economic Framework

Total employment in Taylor County in 1970 averaged 8,100 with agriculture providing 1,100 jobs, manufacturing 3,540, trade and services 500, and government 1,235. Since 1961 manufacturing employment has increased by approximately 83 percent or 1,753 jobs. The major industrial product is apparel.

Per capita income in the county in 1969 was \$2,950. Between 1959 and 1969 per capita personal income in the county increased 124 percent.

The Campbellsville labor market area includes Taylor, Adair, Casey, Green, Larue, and Marion Counties. Area employment in 1970 totaled 26,600, with agriculture providing 7,700 jobs, manufacturing 6,144, trade and services 2,500, and government 4,025. Industrial employment has increased approximately 88 percent since 1961, with sharpest gains in the apparel, machinery, and metal products industries.

Despite important industrial gains in recent years, the area still has a deficit of 1,116 manufacturing jobs when measured against the national employment-population ratio. This indicates an area where the potential for additional manufacturing production is excellent.

Resources for Growth

1. There is a current estimated labor supply of 3,920 men and 2,640 women available for industrial jobs in the labor market area. In addition, 4,315 young men and 4,145 young women will become 18 years of age by 1978 and potentially available for work.

- 2. The local transportation capability is good. The Louisville & Nashville Railroad provides a variety of services. U. S. Highway 68 crosses the county and adequate trucking service is available. Taylor County Airport, with a 3,000-foot runway, is capable of accommodating light aircraft. Commercial air service is available at Standiford Field, Louisville, 82 miles away, and at Blue Grass Field, Lexington, 83 miles distant.
- 3. Kentucky Utilities Company, Taylor County RECC, and Nolin RECC provide electric power to Campbellsville and Taylor County. Natural gas is furnished in Campbellsville by Western Kentucky Gas Company, whose source of supply is Tennessee Gas Pipeline Company.
- 4. Industrial sites Campbellsville has a 180-acre industrial park available for industrial use.
- 5. Education is an important growth asset for Taylor County. Two school systems operate within the county.

Two senior colleges, two junior colleges and one community college are located within 50 miles of the county with Campbellsville College located in Campbellsville. Campbellsville College is a coeducational, church affiliated, liberal arts college founded in 1906.

The Green County Vocational Extension Center, 11 miles distant, offers training in six different courses. The Somerset Area Vocational School is only 69 miles from Campbellsville and offers training in twelve course areas.

Community Programs for Improvement

Recent community improvements include: 11 new commercial buildings, 7 new businesses, a new city park and golf course, major improvements in city school system facilities, a new athletic field for the county school system, a 500,000-gallon water tower constructed on industrial property, and new 6-to 18-inch water lines installed in the city.

Under construction is a new \$1,600,000, 60-bed hospital; an extension of the airport runway to 4,000 feet at a cost of \$341,500; and a new \$1,500,000 junior high school. Campbellsville College is entering the first phase of a three-phase, \$9,350,000 expansion program.

Recreation, Entertainment and Livability

Green River Lake State Park, Campbellsville, covers a 1,300-acre area and provides facilities for fishing, boating, swimming, picnicking, and primitive camping. The Green River Reservoir, a dirt and rock fill dam 141 feet high and 2,350 feet long, impounds an 8,200-acre lake. The lake is stocked with rock fish, striped bass and walleye, in addition to native Green River fish. Parking areas and boat ramps are available at several sites.

Lake Cumberland State Resort Park, 30 miles away, is a 3,000-acre resort park with lodge, cottages and camping facilities. Recreation includes: swimming, boating, riding, hiking, golfing, picnicking, fishing, and tennis.

Abraham Lincoln Birthplace National Historic Site, located 30 miles away at Hodgenville, Kentucky, includes 100 acres of the original Thomas Lincoln farm where Abe was born and lived until he was 2 1/2 years old.

Mammoth Cave National Park, located 50 miles distant, provides the visitor with more than 150 miles of charted caverns occurring on five distinct levels. Guided tours are conducted daily the year-round. There are many interesting attractions in the park. Accommodations available all year include a motel-type lodge, a hotel, and cottages. Camping facilities, picnic areas, and trailer parks are excellent. Recreation includes tennis, shuffleboard, and boat trips.

HISTORY

Taylor County is located in the central part of Kentucky, its roughly triangular-shaped area covering 284 square miles. Green River Reservoir, an 8,200-acre lake, lies in the southern part of the county, and Pitman Creek flows across its western side. Its surface is level in some areas and hilly in others, with Muldrow's Hills and the Knobs in the northern and eastern sections. The soil ranges from fertile in the river and creek bottoms to thin on the knobs, and more than 45 percent of its area is forested.

The first settlers in Taylor County were Virginians and North Carolinians, many of whom came to claim land in return for Revolutionary War services. The Reverend David Rice, an early Presbyterian leader known in history as Father Rice, established the first church in Kentucky in what is now Taylor County, and led an early fight against legalized slavery in the state.

Taylor was made Kentucky's one-hundredth county in 1848. Taken from Green County, it was named for General Zachary Taylor, who grew up in Kentucky and was elected President the year of the county's formation. In 1869 a group of some 150 Pennsylvania Dutch (German) families migrated to the area, making considerable impact on community life.

The historic Battle of Tebbs Bend, also known as the Battle of Green River, occurred 10 miles south of Campbellsville on July 4, 1863. Federal forces commanded by Colonel Orlando H. Moore decisively defeated Brigadier General John Hunt Morgan's raiding forces. The defeat had a devastating and demoralizing effect on Morgan's raiders, rendering them ineffective until Morgan's capture at New Lisbon, Ohio.

Campbellsville, the county seat, was named for one of the early settlers in the area, Adam Campbell. During the Civil War the courthouse was burned. Incorporated in 1817, more than thirty years before the county was formed, Campbellsville is a progressive community which was named an All Kentucky City in 1969. Campbellsville College, a four-year institution, had an enrollment of 856 in 1971.

In 1850, two years after its formation, Taylor County had 7,250 inhabitants. The population grew steadily to 14,403 in 1950, 15,285 in 1960, and 17,138 in 1970. Campbellsville had a 1970 population of 7,598.

Agriculture provided 1,100 of the county's 8,100 jobs in 1970, with burley tobacco, corn, cattle, milk, and hogs the principal products. Manufacturing employment grew approximately 83 percent between 1961-1971, reaching 3,850 in 1971. Union Underwear Company, which makes men's and boys' underwear, and infants' wear, is the county's largest industry, employing 3,300 workers.

Green River Reservoir, already an attraction for water sports, provides extensive recreational facilities.
