






MONTICELLO, KENTUCKY - A RESOURCE PROFILE

Monticello, the county seat of Wayne County, is located in south central Kentucky. Monticello, with a population of 5,876 in 1984, is located 105 miles southwest of Lexington, Kentucky; 121 miles northwest of Knoxville, Tennessee; 159 miles southeast of Louisville, Kentucky; 156 miles northeast of Nashville, Tennessee; and 188 miles south of Cincinnati, Ohio.

Wayne County, with a total land area of 446 square miles, covers portions of both the Mississippian Plateaus and the Eastern Kentucky Coal Fields Regions of the state. Lake Cumberland runs along or near the northern boundary of Wayne County and the Tennessee state line forms the southern boundary. Wayne County had a 1986 population of 17,700.

The Economic Framework - The total number of Wayne County residents employed in 1986 averaged 5,971. Manufacturing firms in the county reported 1,462 employees; wholesale and retail trade provided 662 jobs; 331 people were employed in service occupations; state and local government accounted for 604 employees; contract construction firms provided 74 jobs; and 38 people were employed by mining and quarrying operations.

Labor Supply - There is a current estimated labor supply of 10,023 men and 10,770 women available for industrial jobs in the labor market area. In addition, from 1987 through 1991, 4,472 young men and 4,248 young women in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - The Norfolk Southern Corporation provides main line rail service at Burnside, 21 miles northeast of Monticello. Monticello is served directly by Kentucky Highway 90, a "AAA"-rated trucking highway, and by Kentucky Highway 92, a "AA"-rated trucking highway. In addition, the Cumberland Parkway, a multi-lane toll road, is located just 30 miles north of Monticello. Eight trucking companies provide interstate and/or intrastate service to Monticello. The Monticello-Wayne County Airport, a local airport located just north of Monticello, has as 4,000-foot paved runway. The nearest scheduled commercial airline service is available at Bluegrass Airport, 110 miles northeast of Monticello. The nearest navigable waterway is the Cumberland River near Celina, Tennessee, approximately 40 miles southwest of Monticello.

Power and Fuel - Electric power is provided to Monticello by the City of Monticello Electric Plant Board, which is supplied by the Tennessee Valley Authority. Wayne County is served by the South Kentucky Rural Electric Cooperative Corporation, which is supplied by the East Kentucky Power Cooperative. Natural gas service is not available in Monticello. There are two distributors of propane and two distributors of distillate fuel oil that serve Monticello.

Education - Primary and secondary education is provided to Monticello by the Monticello Independent School System and to Wayne County by the Wayne County School System. One university, five senior colleges, two junior colleges, and one community college are within 85 miles of Monticello. Vocational training is available locally at the Wayne County Vocational Education Center in Monticello and at the Somerset State Vocational-Technical School in Somerset, 29 miles northeast of Monticello.

LABOR MARKET STATISTICS

The Monticello Labor Market Area includes Wayne County and the adjoining Kentucky counties of Clinton, McCreary, Pulaski and Russell.



Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data are compiled for over 127 clearly defined office, production, and service occupations. Tabulations are published for nine geographical areas of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Economic Development, Frankfort, Kentucky 40601.

Monticello is served by Kentucky Highway 90, a "AAA"-rated (80,000-pound gross load limit) trucking highway which connects with U.S. 27 just 21 miles northeast of Monticello; and Kentucky Highway 92, a "AA"-rated (62,000-pound gross load limit) trucking highway which connects with U.S. 27, 32 miles southeast. U.S. 127 is 23 miles southwest of Monticello via Kentucky 90. The Cumberland Parkway, a multi-lane toll road, is just 30 miles north of Monticello via Kentucky 90 and U.S. 27. Interstate 75, a major north-south highway, is 53 miles east of Monticello via Kentucky 92.

For manufacturers, the following fees apply: less than 50 employees - \$350 per year; more than 50 but less than 100 employees - \$562.50 per year; from 101 employees to 150 employees - \$675 per year; from 151 employees to 200 employees - \$780 per year; from 201 employees to 300 employees - \$900 per year; more than 301 employees - \$1,025 per year.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

RECREATION

Local

Monticello has a supervised recreation program. The Monticello-Wayne County Memorial Park is an 86-acre facility which offers five shelters with one shelter used for roller skating, two playgrounds, three basketball courts, two lighted tennis courts, volleyball, badminton, horseshoe pitching, croquet, two softball fields, one baseball field, and horseback riding trails.

An indoor swimming pool is located at the Monticello High School and is available to the community for recreation and instruction.

Private recreational facilities include a country club, a 9-hole golf course, two swimming pools, a movie theatre, and two tennis courts.

The Wayne County Sportsman's Club offers a clubhouse which is available for community activities. The clubhouse is located on 50 acres and provides kitchen and dining facilities.

The Wayne County Fair and Horse Show is an annual event which is held the first week in July.

The Labor Day Arts and Crafts Festival is held annually on the Saturday prior to Labor Day. Events include arts and crafts displays, a 10K run, a fun run, the Labor Day Tennis Tournament, and the Labor Day Slalom Ski Tournament. The following day a CB Jamboree is held.

Immanuel Baptist Church Camp, 17 miles south of Monticello, offers 6 cabins accommodating 250 campers; dining facilities; a staff house with a capacity of 16; a swimming pool; softball fields; volleyball courts; basketball courts; archery field; horseshoes; ping pong; and miniature golf.

Area (Within 65 miles)

The Daniel Boone National Forest, approximately 15 miles east of Monticello, covers 640,000 acres of timberland in eastern Kentucky. It encompasses much of Kentucky's great beauty and provides a vacation paradise. There are scenic hiking trails, rivers and streams stocked with a variety of fish, hunting preserves, camping sites, and numerous other natural and historical attractions.

General Burnside State Park, 22 miles northeast of Monticello, is Kentucky's only island state park. Rising out of Lake Cumberland and surrounded by beautiful Kentucky mountains, the park offers excellent fishing, an 18-hole golf course which is open year-round, a picnic area, a 110-site camping area for tents and recreational vehicles, a marina on the mainland near the park, a community pool, and recreation. The Big South Fork National River and Recreation Area, 32 miles east of Monticello near Whitley City, was developed as an outdoor recreation area by the U.S. Army Corps of Engineers in cooperation with the National Park Service. The area lies along the Big South Fork of the Cumberland River in Kentucky and Tennessee and encompasses some of the state's most rugged and scenic terrain. Recreational opportunities in the "National Area include hiking, camping, horseback riding and picnicking, whitewater rafting, canoeing and kayaking trips. The Big South Fork Scenic Railway offers a chance to see part of the rugged Cumberland River area by rail. The train operates on a regular schedule between Stearns and the Big South Fork National River and Recreation Area near the historic Blue Heron Coal Tipple, a distance of about 5 miles each direction.

Lake Cumberland State Resort Park near Jamestown, 40 miles northwest of Monticello, is a 3,000-acre park located on the 50,000-acre Lake Cumberland, which sports excellent bass, bluegill, and crappie fishing. The park features a modern 48-room resort lodge which is perched on a high bluff above the lake. The lodge has a swimming pool, a dining room, a gift shop, and a multi-purpose activities center. Other park facilities include an additional swimming pool, riding stables, tennis courts, hiking trails, a nature center, a 9-hole golf course, miniature golf, a picnic area, planned recreation, and a playground. A marina offers houseboats, and fishing boats and motors for rent plus year-round launching ramps.

Dale Hollow Lake State Park, 42 miles southwest of Monticello, is located alongside 48 square miles of surface water in southeastern Cumberland County. Park facilities include a restaurant, marina, a picnic area, and 144 sites for tent and trailer camping. Dale Hollow Lake straddles the Kentucky-Tennessee state line. Several private recreation facilities are located near the lake.

Cumberland Falls State Resort Park is located 46 miles east of Monticello near Corbin in the Daniel Boone National Forest. The park is famous for Cumberland Falls which drops 68 feet over a rock precipice and shows one of only two known "moonbows" in the world at full moon. The park offers 73 lodge rooms, woodland suites, 25 cottages, a convention center, camping, fishing, swimming, hiking, horseback riding, picnicking, tennis, backpacking, a nature center, shuffleboard, planned recreation, a playground, a gift shop, and an amphitheater.

William Whitley House State Shrine, 57 miles northeast of Monticello near Stanford, is the first brick house west of the Allegheny Mountains, built 1787-94. Whitley laid out Kentucky's first race track here and started U.S. counterclockwise racing. The facility provides picnic and playground areas in a ten-acre park.

Levi Jackson Wilderness Road State Park, 65 miles northeast of Monticello at London, is a 815-acre park located where the Boone Trace and Wilderness Road pioneer trails converge. In addition to a reproduced pioneer settlement, the park offers a museum on mountain folklore, 15 cabins, a pool, a bathhouse, hiking trails, horseback riding, miniature golf, shuffleboard, 185 campsites, a picnic area, a playground, and an amphitheater. A new 40-acre historical theme park, Wilderness Road Village, will open at the park in the fall depicting frontier life with a working crafts area, exhibits, entertainment, horse-drawn carriages and a tavern.

COMMUNITY IMPROVEMENTS

Recent

The following manufacturing firms have recently located in Monticello: G & A Manufacturing, Inc.; Leisure Time Cruisers; and Richardson Lumber Company. These new firms represent approximately 125 new jobs for Monticello.

The following Monticello firms have either expanded or announced plans to expand: Gamble Brothers, Inc.; Stardust Cruisers, Inc.; Wayne Lumber Company; and WPM Manufacturing, Inc. These plant expansions represent approximately 120 new jobs for Monticello.

An \$8,875,000 project to upgrade Kentucky 90 has been completed. The project included construction of a new 3.8-mile section of Kentucky 90 which serves as a bypass around Monticello, reconstruction of a 4.2-mile section of highway southwest of Monticello, and construction of a new bridge over Beaver Creek.

The construction of a \$2 million 46-unit, low-income housing project was recently completed.

A \$620,000 housing rehabilitation project of 39 houses in the Number One-Wray Hill Community has recently taken place.

The Monticello Utility Commission has constructed a new \$3 million sewage treatment plant with a design capacity of 700,000 gallons per day.

The Monticello Utility Commission has also completely renovated the water treatment plant and expanded the capacity of the plant from 1 million gallons per day to 2 million gallons per day. Cost of this project was \$1 million.

Construction of an access road from the Monticello-Wayne County Airport to the junction of Kentucky 1275 and Kentucky 90 has recently been completed.

The Monticello Electric Plant Board has recently constructed a small substation and power lines to meet the needs of local existing industry.

Under Way

The city of Monticello is currently a participant in a downtown revitalization program. A \$10,000 matching grant has been received.

The Monticello Utility Commission is in the process of extending sewer service to areas recently annexed into the city. Total cost of the project is \$3 million.

The Monticello Electric Plant Board is in the process of removing power lines along and across Main Street in downtown Monticello.

Planned

Plans are under way to open a Wal-Mart discount store in Monticello. The 50,968-square-foot store will be located in a proposed shopping center on the northwest quadrant of the Bypass and is expected to open in the spring of 1988. Approximately 95 jobs will be added to the Monticello community upon the store's opening.

Plans are currently under way to make major improvements at the Wayne County Middle School. The new construction will include twelve basic classrooms, two science rooms, three office rooms, a cafeteria and a kitchen. Ground should be broken in the spring of 1988 with completion scheduled for the summer of 1989. Cost of the project is estimated to be \$1,350,000.
