



CAMPTON, KENTUCKY - A RESOURCE PROFILE

Campton, the county seat of Wolfe County, is situated in the western part of the Eastern Kentucky Coal Field. Campton is located 65 miles southeast of Lexington, Kentucky, 134 miles southeast of Louisville, Kentucky; 138 miles southeast of Cincinnati, Ohio; and 204 miles north of Knoxville, Tennessee. Campton had an estimated 1994 population of 626.

Wolfe County, covering a total land area of 222 square miles, is characterized by narrow, cliff-rimmed, flat-topped ridges in the northwest. In other parts of the county, the slopes are not as steep, but the ridge tops are essentially the same. Wolfe County had an estimated 1994 population of 7,126.


The Economic Framework - The total number of Wolfe County residents employed in 1996 averaged 3,111. In 1995, manufacturing firms in the county reported 500 employees; wholesale and retail trade provided 189 jobs; 228 people were employed in service occupations; and state and local government accounted for 410 employees.

Labor Supply - There is a current estimated labor supply of 12,890 persons available for industrial jobs in the labor market area. In addition, from 1998 through 2002, 5,852 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Campton is served directly by Kentucky Highway 15, a AAA-rated trucking highway. The Mountain Parkway, a multi-lane limited access highway, is accessible one mile north of Campton. Interstate 64 is accessible 44 miles northwest of Campton via the Mountain Parkway. Ten common carrier trucking companies provide interstate and/or intrastate service to Campton. CSX Transportation provides rail service at Jackson, 20 miles southeast of Campton. The nearest scheduled commercial airline service is available at the Blue Grass Airport near Lexington, 69 miles northwest of Campton. Small craft air service is available at the Julian Carroll Airport near Jackson, 25 miles southeast of Campton; and at the Stanton Airport, 22 miles northwest.

Power and Fuel - Electric power is provided to Campton and Wolfe County by the Licking Valley Rural Electric Cooperative Corporation. Natural gas service is not available in Campton at the present time, however Jefferson Gas Transmission Company provides natural gas service to the industrial park and a portion of eastern Wolfe County.

Education - Primary and secondary education is provided to Campton and Wolfe County by the Wolfe County School System. In addition, one private school provides elementary education to the community. Eight institutions of higher learning are located within 70 miles of Campton. Four vocational-technical education facilities are available within 55 miles of Campton.







AVERAGE PLACEMENT WAGES



RECENT INDUSTRIAL DEVELOPMENTS

A 27-acre industrial park has been developed in Wolfe County. Utilities available at the park include natural gas, water, and sewer. A satellite downlink has been installed at the Wolfe County Courtroom for telecommunications purposes.

In-Steel, Inc., a metal furniture frame manufacturer, plans construction of a \$700,000 facility at the Campton/Wolfe County Industrial Park. The project is expected to be completed in the fall of 1997, and will create approximately 110 jobs.

The Daniel Boone Parkway, a multi-lane toll road, is accessible 48 miles southeast of Campton via Kentucky 15.



LOCAL GOVERNMENT

Structure

The City of Campton is governed by a mayor and four commissioners. The mayor is elected to a four-year term while the commissioners each serve two-year terms. Wolfe County is governed by a county judge/executive and three magistrates. Each county official is elected to a four-year term.

Planning and Zoning

There are no planning and zoning agencies operating in Wolfe County at the present time.

Mandatory state codes enforced - Kentucky Plumbing Code, National Electric Code, Kentucky Boiler Regulations and Standards, Kentucky Building Code (modeled after BOCA code)

Local Fees and Licenses

The City of Campton levies an annual business license fee of \$50. Unloading license fees are \$25 annually. Wolfe County levies annual business license fees ranging from \$6.50 to \$11.50. Wolfe County also levies a 1.25 percent occupational license tax on wages, salaries, and commissions of individuals employed within the county.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

Customized Training

The Kentucky Tech system, through its training and development coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Businesses wanting to establish a customized training program should contact a training and development coordinator located at the Mayo Regional Technology Center or the Hazard Regional Technology Center.

Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies testing packages for evaluating job applicants, selecting employees for promotional consideration and developing training programs within the organization. Career Connections Assessment Centers are located at the Mayo Regional Technology Center and the Hazard Regional Technology Center.

Adult Education Services

Adult education programs are available to adults who want to develop new academic skills, improve basic skills, or earn a high school equivalence diploma. In Campton, adult basic education and adult literacy are available through KVEC-Wolfe County in Hazard.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation (BSSC), an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry. Programs range from entry level for new workers to advanced training for experienced employees.

The Bluegrass State Skills Corporation is a major source for skills training assistance for new and existing companies. BSSC works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package programs customized to meet the specific needs of a company.

RECREATION

Local

The Campton Park offers a baseball field, a basketball court, a tennis court, picnic tables, shelter houses, and a playground. Other recreational facilities in Campton include two baseball fields and four gymnasiums.

A homecoming festival is held annually each Labor Day weekend in Campton. The festival includes a parade, booths, crafts, and live music.

Wolfe County is located within the Daniel Boone National Forest, which covers 640,000 acres of timberland in eastern Kentucky. It encompasses much of Kentucky's great beauty and provides a vacation paradise. There are scenic hiking trails, rivers and streams stocked with a variety of fish, hunting preserves, camping sites, and numerous other natural and historical attractions.

Several tourist attractions are located near Campton. Red River Gorge, part of the Daniel Boone National Forest and considered one of eastern Kentucky's most prominent features, is a boulder-strewn area of rugged forest, streams, cliffs, overlooks, arches, rare plants and animal life. Picnic and campsites are available in the Koomer Ridge Recreation area. The Pioneer Weapons Area features a 7,480-acre preserve where hunters are limited to primitive weapons use only. Cliffview Resort provides lodging for family vacations. Construction of an 18-hole golf course at the resort is underway.

Natural Bridge State Resort Park near Slade, 13 miles northwest of Campton, is located within the Daniel Boone National Forest where cliffs and stone arches fill the landscape. The rugged beauty of the great Natural Bridge is the main attraction. The park offers a 35-room resort lodge with a dining room, a convention center, a gift shop, ten rustic cottages, and 95 camping sites. Other facilities include a lake, a swimming pool, picnic shelters and playgrounds, mini-golf, hiking trails, a riding stable, a chair lift, and pedal boats.
