





LEITCHFIELD-GRAYSON COUNTY, KENTUCKY - A RESOURCE PROFILE

Leitchfield, the county seat of Grayson County, is situated near the eastern edge of the Western Kentucky Coal Field Region. Leitchfield is located 77 miles southwest of Louisville, Kentucky; 130 miles north of Nashville, Tennessee; and 273 miles east of St. Louis, Missouri. In 1986, Leitchfield had an estimated population of 5,020.

Caneyville, located 13 miles west of Leitchfield, had a 1986 estimated population of 570. Clarkson, located four miles east of Leitchfield, had a 1986 estimated population of 610.

Grayson County, with a land area of 493 square miles, is characterized by flat-topped, sandstone-capped ridges. In 1986, Grayson County had an estimated population of 21,601.

The Economic Framework - The total number of Grayson County residents employed in 1987 averaged 8,610. Manufacturing firms in the county reported 2,030 employees; wholesale and retail trade provided 1,090 jobs; 450 people were employed in service occupations; state and local government accounted for 950 employees; and contract construction firms provided 180 jobs.

Labor Supply - There is a current estimated labor supply of 12,890 men and 16,510 women available for industrial jobs in the labor market area. In addition, from 1988 through 1992, 7,330 young men and 7,015 young women in the area will become 18 years of age and potentially available for industrial jobs.


Transportation - Paducah and Louisville Railway provides main line rail service to Leitchfield. Leitchfield is served by the Western Kentucky Parkway and U.S. 62, both "AAA"-rated highways. Fourteen common carriers serve Leitchfield with interstate and/or intrastate service. The nearest scheduled commercial airline service is available at Standiford Field, 5 miles southeast of Louisville, 72 miles northeast of Leitchfield. The Leitchfield-Grayson County Airport, 5 miles southeast of Leitchfield, maintains a 4,000-foot paved runway.

Power and Fuel - Electric power is provided to Leitchfield and Grayson County by the Kentucky Utilities Company. Grayson County is also provided electric power by the Warren Rural Electric Cooperative Corporation. Natural gas is provided to Leitchfield by Leitchfield Utilities.

Education - The Grayson County School System, which is accredited by the Southern Association of Colleges and Schools, provides public education to Leitchfield and Grayson County. One nonpublic school operates in Leitchfield. Eleven colleges and universities are located within 80 miles of Leitchfield. Vocational training is available at Grayson County Area Vocational Education Center in Leitchfield and at Elizabethtown State Vocational-Technical School, 32 miles northeast of Leitchfield.







Highways

Highway access to Leitchfield is provided by the Western Kentucky Parkway; U.S. Highway 62, a "AAA"-rated (80,000-pound gross load limit) trucking highway; and Kentucky Highway 259, a "AA"-rated (62,000-pound gross load limit) trucking highway. Downtown Leitchfield is located approximately one mile north of an interchange to the Western Kentucky Parkway which connects with Interstate 65 and the Blue Grass Parkway at Elizabethtown, 33 miles northeast. The Western Kentucky Parkway also provides direct access to the Green River Parkway, 32 miles west of Leitchfield.

Kentucky Highway 259 was widened to four lanes extending from the Leitchfield city boundary to the Western Kentucky Parkway. A bypass around the north side of Leitchfield is tentatively planned for the near future.

LOCAL GOVERNMENT

Structure

Leitchfield is served by a mayor and six council members. The mayor serves a four-year term while the council members each serve two-year terms. Grayson County is served by a county judge/executive and six magistrates. Each official serves a four-year term.

Planning and Zoning

There is no planning and zoning agency in Leitchfield or Grayson County at the present time.

Mandatory state codes enforced - Kentucky Plumbing code, National Electric Code, Kentucky Boiler Regulations and Standards, Kentucky Building Code (modeled after BOCA code)

Local Fees and Licenses

The City of Leitchfield levies an occupational license tax of one percent on wages of individuals and one percent of the net profits of businesses. Unloading and vending licenses range from \$10 to \$35.

A 3 percent tax is levied on utilities receipts for schools in Grayson County. Tax is paid by all consumers of utilities as an add-on to the utilities bills. Exempted are receipts from utilities services that are resold and the receipts from the sale of energy or energy producing fuels that exceed 3 percent of the cost of production in manufacturing, processing, mining or refining.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

RECREATION

Local

Leitchfield provides many recreation programs which include baseball and softball leagues. As part of the program, the Grayson County Middle School gymnasium is open to adults in the community for organized sports such as volleyball, swimming, badminton, floor tennis and table tennis. Three parks, two playgrounds, five baseball fields, two tennis courts, an archery range, and a municipal swimming pool are provided for recreational activities. A city-county sports complex was recently constructed in Leitchfield. The \$50,000 facility includes a football field, a baseball field, a swimming pool, basketball courts, tennis courts, a running track, and a playground. The reconstruction of an eight-acre lake is planned for one of the parks.

Private recreational facilities include a drive-in theater; a 14-lane bowling facility; a lake and pay-fishing area; Allen's Lake and Waterslide; and a golf club, which is available to residents on a membership basis. Facilities at the Lakeview Club include an 18-hole golf course; a clubhouse with a proshop, snack bar, locker room and party room; a driving range; a putting green; a swimming pool; and tennis courts.

Pine Knob, an outdoor theater located in Caneyville, 13 miles west of Leitchfield, provides unique entertainment in a quaint historic setting. The 400-seat outdoor theater features two shows including the "Dock Brown Show", which is based on the book "Dock Brown, the Grayson County Outlaw", and "Down in Hoodoo Holler".

Regular events and festivals in Grayson County include the annual Grayson County Fiddlin' Festival and the Old Time Fiddlers Contest, held each July; and the annual Grayson County Fair, held each Labor Day holiday. A Labor Day parade and a Christmas parade are also held in Leitchfield. Numerous ongoing activities, including civic and charitable events, are available throughout the year.

Area (Within 60 miles)

Noteworthy for its spaciousness, Rough River Dam State Resort Park at Falls of Rough is 18 miles northwest of Leitchfield. The 637-acre park on Rough River Lake features a 40-room lodge with a dining room, a coffee shop, a gift shop, a meeting room, and a 2,500-foot lighted airstrip. Cottages and camping sites are also available. Recreational facilities include a launching ramp, a dock with open and covered slips, fishing and pleasure boat rentals, a 9-hole, 3-par golf course, a swimming pool, a sand beach with a bathhouse complex, tennis courts, an archery range, hiking and fitness trails, picnic and playground areas, and planned recreation. Cruise boat excursions on Rough River Lake are available on the "Lady of the Lake" in season. Mammoth Cave National Park is located 42 miles southeast of Leitchfield near Cave City. Beneath 52,000 park acres, Mammoth Cave is among the major tourist attractions of all times. It is the largest cave network ever discovered, with over 300 miles of caverns. Some famous sights are Snowball Dining Room (267 feet below surface), Frozen Niagara, Crystal Lake, and Bottomless Pit. The park also features scenic boat trips on the Green River and nature and hiking trails. Park accommodations include a hotel with distinctive gift shops featuring native Kentucky and Southern Highland handicrafts, a motor lodge, hotel cottages, and woodland cottages. Other park facilities include the hotel dining room and coffee shop, a service center, group meeting facilities, a campground, boat rides, a picnic area, and tennis and shuffleboard courts. The park is open for tours every day of the year (except Christmas Day).

Nolin River Lake is just north of Mammoth Cave National Park. The lake has a surface area of 5,800 acres and offers facilities for camping, boating, and fishing.

Abraham Lincoln Birthplace National Historic Site, located 44 miles east of Leitchfield near Hodgenville, features the log cabin which was the birthplace of Abraham Lincoln, enclosed within a granite memorial shrine. The grounds include 116 acres of the original Thomas Lincoln farm and a visitors' center with audiovisual programs and exhibits on the Lincoln family.

Bernheim Forest Arboretum and Nature Center, located 56 miles northeast of Leitchfield, is a privately endowed 10,000-acre forest and wildlife refuge. The area contains over 1,200 labeled varieties of plants, trees and shrubs; ornamental gardens; a nature center; nature trails and waterfowl ponds.

My Old Kentucky Home State Park, 56 miles northeast of Leitchfield in Bardstown, portrays an image of the South's gentle and leisurely home life before the Civil War. The restored Georgian Colonial mansion is where composer Stephen Foster visited and where he was inspired to write "My Old Kentucky Home." A world-renown outdoor drama, "The Stephen Foster Story", is presented in the park's amphitheatre during the summer months. The park also offers a 40-site campground, a gift shop, a 9-hole golf course and pro shop, a picnic area, and planned recreation.

Bowling Green is located 58 miles southwest of Leitchfield. Bowling Green serves the area as a recreational and educational center. Kentucky Museum and Library offers extensive collections relating to the history and heritage of the Commonwealth. Western Kentucky University provides the city with many exciting sporting events. Beech Bend Amusement Park has many rides, games, an international raceway, and other forms of entertainment.

COMMUNITY IMPROVEMENTS

Recent

Recent industrial developments in Leitchfield include the installation of new production lines in both the Vermont American Corporation and the Bel Cheese, Inc. Link and Link, a wood processing company, purchased 11 acres for the development of a manufacturing facility in Leitchfield.

The Leitchfield/Grayson County Industrial Development Foundation recently constructed a 40,000-square foot "spec" building. The \$400,000 facility is located adjacent to the Western Kentucky Parkway and provides access to all utilities.

A city-county sports complex was recently constructed in Leitchfield. The \$50,000 facility includes a football field, a baseball field, a swimming pool, basketball courts, tennis courts, a running track, and a playground.

Kentucky Highway 259 was widened to four lanes extending from the Leitchfield city boundary to the Western Kentucky Parkway.

Under Way

Construction of a \$2 million elementary school in the Grayson County School System is under way. The project is scheduled for completion in the spring of 1990.

Planned

A bypass around the north side of Leitchfield is tentatively planned for the near future.
