



CARLISLE COUNTY, KENTUCKY - A RESOURCE PROFILE

Carlisle County is located in the extreme western portion of Kentucky in the Jackson Purchase Region. Bordered on the west by the Mississippi River, the county covers a land area of 192 square miles and the topography is composed of gently rolling hills and plains. Bardwell, the county seat of Carlisle County, is located 166 miles northwest of Nashville, Tennessee; 175 miles southeast of St. Louis, Missouri; and 245 miles southwest of Louisville, Kentucky.

Carlisle County had a 1994 estimated population of 5,291. Bardwell had an estimated 1994 population of 809 and Arlington had an estimated 1994 population of 466.


The Economic Framework - The total number of Carlisle County residents employed in 1995 averaged 2,465. Manufacturing firms in the county reported 231 employees; wholesale and retail trade provided 185 jobs; 66 people were employed in service occupations; state and local government accounted for 195 employees; and contract construction firms provided 27 jobs.

Labor Supply - There is a current estimated labor supply of 7,306 persons available for industrial jobs in the labor market area. In addition, from 1997 through 2001, 8,772 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major highways serving Carlisle County are U.S. Highway 62, U.S. Highway 51, and Kentucky Highway 80. The Purchase Parkway, a multilane highway, can be accessed 29 miles southeast of Bardwell via U.S. Highway 51 and Kentucky Highway 80. Interstate 24 is accessible 26 miles northeast of Bardwell via U.S. Highway 62. Twenty firms provide interstate and/or intrastate trucking service to Carlisle County. The Illinois Central Railroad provides rail service to Carlisle County. The nearest commuter airline service is available at Barkley Regional Airport near Paducah, 24 miles northeast of Bardwell, and commercial airline service is available at Evansville, Indiana, 136 miles northeast of Bardwell. Public riverport facilities are located at Hickman, Kentucky, on the Mississippi River, 33 miles southwest of Bardwell; and at Paducah, on the Tennessee River, 30 miles northeast of Bardwell.

Power and Fuel - Electric power is provided to Carlisle County by the Hickman-Fulton Counties Rural Electric Cooperative Corporation, Jackson Purchase Electric Cooperative Corporation and West Kentucky Rural Electric Cooperative Corporation. A small portion of Carlisle County is served by the Kentucky Utilities Company. Bardwell is served by Bardwell City Utilities. Bardwell Gas System provides natural gas to Bardwell, while New Commonwealth Natural Gas Company provides gas service to Arlington.

Education - Carlisle County is served by the Carlisle County School System. Five senior colleges and one community college are located within 71 miles of Bardwell. The nearest state vocational-technical education center is located at Paducah, 30 miles distant. The nearest area vocational education center is located in La Center, Kentucky, 20 miles distant.



LABOR MARKET STATISTICS

The Carlisle County Labor Market Area includes Carlisle County and the adjoining Kentucky counties of Ballard, Fulton, Graves, Hickman, and McCracken. The labor market is supplemented by nearby counties in Missouri, Illinois, and Tennessee.



UNEMPLOYMENT RATES 1995







AVERAGE PLACEMENT WAGES


Carlisle County is served by the Paducah local office of the Kentucky Department for Employment Services. The focus of the following data is on job placements made by the Paducah local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1996, the local employment office filled 1,982 job openings in various occupational categories. RECENT INDUSTRIAL DEVELOPMENTS

Owens Sawmill, Inc. announced plans in 1995 for a \$30,000 expansion in Arlington.

Carlisle County has developed a conceptual plan for a proposed 160 acre industrial park to be located just north of Bardwell on U.S. Highway 51. Completion of Phase I of the new Carlisle County Sanitation District #1 is expected by mid 1998 at a cost of \$3 million, and will provide treatment plant capacity of 300,000 gallons per day, with the ability to double as the need arises. It will be located less than 2,000 feet from the proposed industrial site. The area also has access to rail.

Hickman, Carlisle, Ballard, and Fulton Counties are all working with the Tennessee Valley Authority (TVA) under a \$300,000 TVA grant and have contracted with a technical resource coordinator for services to enhance the economic development of the four river county area. The Four River Counties Group, Inc. is working to bring local school systems, city and county governments, and economic development offices together for leadership development and to develop an economic development telecommunications database to link all of these systems. Software development and installation is expected to be completed by January 1997. Area high school interactive video teleconferencing rooms and equipment are being used for telecommunications studies and industry specific training. Plans call for adding retooling and retraining programs. The four-county group is also involved in a combined marketing effort and is targeting the food processing and auto supply industries.

There are presently no unions representing workers at manufacturing plants in Carlisle County.

TRANSPORTATION

Highways

Major highways serving Bardwell include U.S. 62 and U.S. 51; both are AAA-rated (80,000-pound gross load limit) trucking highways. U.S. Highway 51 connects Bardwell with both the Purchase Parkway, a multilane highway, at Fulton, 29 miles south; and with Interstate 57 near Cairo, Illinois, 19 miles northwest of Bardwell. U.S. 51 and Kentucky Highway 80 also connect Bardwell with the Purchase Parkway near Mayfield, 29 miles southeast. Access to Interstate 24 is available 26 miles northeast of Bardwell via U.S. 62.



A new Carlisle County sewerage treatment plant is expected to be completed by mid 1998 at a cost of \$3.0 million. The state-of-the-art facility will provide treatment capacity of 300,000 gallons per day, with the ability to be doubled.

Phase I of the new Carlisle County Sanitation District #1 project will serve Bardwell, Arlington, and the school system. Additional phases of the project call for a county-wide system after 1998.

LOCAL GOVERNMENT

Structure

Bardwell is served by a mayor and six council members. Arlington is served by a mayor and four commission members. In both cities the mayor is elected to a four-year term and the council/commission members serve two year terms. Carlisle County is served by a county judge/executive and five magistrates which are elected to four-year terms.

Planning and Zoning

There are currently no planning and zoning commissions in Carlisle County.

Local Fees and Licenses

The City of Arlington levies annual business license fees ranging from \$15 to \$40. The City of Bardwell does not levy any business license fees.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies testing packages for evaluating job applicants, selecting employees for promotional consideration, and developing training programs within the organization. A Career Connections Assessment Center is located on the campus of the West Kentucky Regional Technology Center in Paducah.

Adult Education Services

Adult education programs are available to adults who want to develop new skills, improve basic skills, or earn a high school equivalency diploma. In Bardwell, adult basic education and adult literacy programs are administered through the Carlisle County West Kentucky Education Consortium.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

The twenty-acre Carlisle County Park near Bardwell includes a community center, a ball diamond, a horse show ring, two lighted tennis courts, a basketball court, shelter and picnic facilities, and public restooms. Organized recreational programs include T-ball and Little League for boys and girls. Skeet and trap shooting is organized by 4-H, but open to all.

The Arlington American Legion Park, which is privately owned and operated, features a five-acre site which includes two ball diamonds, a skating rink, and a concession stand.

The Carlisle County Fair, held the second weekend in August, is held at the Carlisle County Park and attracts over 7,000 people. The Great River Road Extravaganza is held Memorial Day Weekend and features arts and crafts. The Carlisle County Fire and Rescue Rodeo is held the last weekend in October and also includes a junior rodeo for teens.

The state owned and maintained Winford Wildlife Management Area in Carlisle County provides a 237-acre hunting and fishing area with eastern woodlands and swamp terrain.

The Westvaco Wildlife Management Area is located in Carlisle and Hickman Counties and owned by the Westvaco Corporation of Wickliffe, Kentucky. The Wildlife Area is a public/private partnership with the Kentucky Department of Fish and Wildlife Resources to provide a habitat for waterfowl and wildlife. It also serves as a renewable managed working forest producing timber for Westvaco. Visitors can enjoy watching the birds and animals, the special beauty of a typical Mississippi River bottom, or a brisk hike along forest roads and trails. In addition, there are 644 acres in the northern end of the management area open to public hunting year round with the purchase of a Westvaco hunting permit and valid state hunting license. Fishing is also permitted.

The Great River Road, a U.S. Scenic Byway extending along the western portion of Carlisle County, offers the traveler an opportunity to explore Kentucky life and recreational opportunities along the Mississippi River.
