





EDMONTON, KENTUCKY - A RESOURCE PROFILE

Edmonton, county seat of Metcalfe County, is situated in the Pennyroyal region of south central Kentucky. Edmonton is 49 miles east of Bowling Green, Kentucky; 110 miles south of Louisville, Kentucky; 115 miles northeast of Nashville, Tennessee; and within 220 miles of Knoxville, Tennessee, and Cincinnati, Ohio. In 1980, Edmonton had a population of 1,401.

Metcalfe County, covering 296 square miles, had a 1980 population of 9,484.

The Economic Framework

Total number of Metcalfe County residents employed in 1981 averaged 4,035, with 3,050 in nonagricultural jobs. Manufacturing firms provided 380 jobs, wholesale and retail trade provided 270 jobs, and 80 persons were employed in service occupations. Manufacturing employment is greatest in the apparel and related products and lumber and wood industries.

Per capita personal income in Metcalfe county in 1980 was \$4,453. Between 1976 and 1980, per capita personal income increased by 29.8 percent.

The Edmonton labor market area includes Metcalfe and the six adjoining counties. The number of labor market area residents employed in 1981 averaged 46,965, with 38,835 working in nonagricultural jobs. Manufacturing provided 8,745 jobs, wholesale and retail trade provided 4,700 jobs, and 3,120 persons worked in service occupations.

Resources for Growth

- 1. Labor Supply There is a current labor supply of 7,470 men and 4,000 women available for industrial jobs in the labor market area. In addition, 4,150 young men and 3,920 young women in the area will become 18 years of age before 1986 and potentially available for work.
- 2. Transportation The nearest rail service is provided by the Louisville & Nashville Railroad at Glasgow, 16 miles distant. U.S. Highway 68 and Kentucky Highways 80, 163, 496 and 533 serve Edmonton. An interchange of the Cumberland Parkway, a multilane toll road which connects with Interstate 65, is located two miles northwest of Edmonton. Three trucking companies serve Edmonton. A small craft airport is located at Glasgow. The nearest commercial airports with scheduled airline service are located at Louisville, Kentucky, 110 miles distant, and at Nashville, Tennessee, 115 miles distant.

- 3. Power and Fuel Electricity is provided to Edmonton and Metcalfe County by Tri-County Electric Membership Corporation, which receives power from the Tennessee Valley Authority. Portions of Metcalfe County are served by Farmers RECC, which receives power from the East Kentucky Power Cooperative. The Edmonton Natural Gas System is supplied by Texas Eastern Transmission Corporation. The Edmonton area is served by two propane distributors and two distillate fuel oil distributors. Low sulphur content coal is available in Kentucky.
- 4. Education Edmonton and Metcalfe County are served by the Metcalfe County School System. Five institutions of higher learning are located within 70 miles of Edmonton.

The nearest state vocational-technical school, in Bowling Green, 49 miles distant, offers training in 25 different courses. The Barren County Area Vocational Education Center, 16 miles distant, offers 12 courses. The Education Center also offers adult evening classes in Business and Office, Electricity, Machine Shop, Refrigeration and Welding.

THE LABOR MARKET AREA

The Edmonton labor market area includes Metcalfe County and the adjoining Kentucky counties of Adair, Barren, Cumberland, Green, Hart, and Monroe.



Occupational wage rates for specific industries are usually not available to most government agencies, and wage data furnished to state employment agencies by individual industrial employers are protected from disclosure by federal law. The most reliable up-to-date wage information can be obtained by direct contact with local employers.

Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data are compiled for over 127 clearly defined office, production, and service occupations. Tabulations are published for nine geographical areas of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Economic Development, Frankfort, Kentucky 40601.

Property Taxes

All property in Kentucky is assessed at 100 percent of fair cash value.

Land and buildings are taxed by the state and may be taxed by local jurisdictions. The state rate is \$0.229 per \$100 of assessed valuation.

Manufacturing machinery, raw materials inventories, pollution control equipment, and goods in the process of manufacture are not subject to local taxation. The state rate is \$0.15 per \$100.

Other tangible personal property owned by manufacturers (automobiles, trucks, finished goods, office furniture, office equipment) is taxed by the state at \$0.45 per \$100 and may be taxed by local jurisdictions.

Property stored in public warehouses in a transit status is not subject to local taxation. The state rate is only \$0.015 per \$100.

Intangible personal property located in Kentucky (money in hand, shares of stock, notes, bonds, accounts receivable, and other credits) is taxed by the state at \$0.25 per \$100, and is not subject to local taxation.

Private leaseholds in industrial facilities owned by cities or counties and financed by industrial revenue bonds are subject to a state tax of \$0.015 per \$100 of value (essentially the lessee's equity, adjusted for appreciation or depreciation). Local taxation is not permitted.

RECREATION

Local

Edmonton offers a supervised recreation program during the summer months. A recreation committee has been organized to plan the youth programs. Recreational facilities include three parks, three playgrounds, three tennis courts, three baseball diamonds, one football field, and four gymnasiums.

Edmonton's new M. A. R. C. Park contains a playground, tennis courts, ball fields and the Barnlot Theater.

The 25-acre Metcalfe County Lake provides for activities such as swimming and fishing. Also, playground equipment and facilities for playing basketball, volleyball, tennis, and softball are available.

Area (Within 45 miles)

Old Mulkey Meeting House State Shrine, 22 miles south of Edmonton near Tompkinsville, offers picnic areas and playgrounds. The house was built in 1804, and is the oldest log meeting house in the state. Daniel Boone's sister is buried in the graveyard and authentic records written in pokeberry ink are on display.

Mammoth Cave National Park is located 26 miles northwest of Edmonton near Cave City. Beneath 51,000 park acres, Mammoth Cave is among the major tourist attractions of all times. It is one of the largest cave networks ever discovered, with at least 150 miles charted on five levels and vast areas not yet mapped. Some famous sights are Snowball Dining Room (267 feet below surface), Frozen Niagara, Crystal Lake, and Bottomless Pit. The park also features scenic boat trips on the Green River and nature and hiking trails. Park accommodations include a hotel with distinctive gift shops featuring native Kentucky and Southern Highland handicrafts, a motor lodge, hotel cottages, woodland cottages, and a hotel annex with budget accommodations and craft shop featuring live exhibits of broom making and weaving. Other park facilities include the hotel dining room and coffee shop, a service center, group meeting facilities, a campground, a picnic area, and tennis and shuffleboard courts.

Barren River Lake State Resort Park, 30 miles southwest of Edmonton at Lucas, is a full-facility resort park offering a resort lodge, a coffee shop, cottages, a lodge pool, a beach, riding stables, nature trails, open and covered boat slips, a 9-hole par-3 golf course, lighted handball and tennis courts, shuffleboard, park camping with a service building, a restaurant, fishing and pleasure boat rentals, picnic areas, and a playground. Barren River Lake, which covers 10,000 acres, is a popular area for skiing, sailing, fishing, and swimming.

Green River Lake State Park near Campbellsville, 40 miles northeast of Edmonton is made up of 1,300 acres surrounding an 8,200-acre lake. The park is open all year-round and offers 96 campsites, a beach, boat docks, fishing, swimming, and a picnic area.

Nolin River Lake, approximately 40 miles to the northwest, is a 5,800-acre lake which provides for great fishing, hunting and camping. Facilities on the lake include two public marinas, four campgrounds operated by the Army Corps of Engineers, two Corps-operated, day-use areas, and two privately-owned campgrounds.

Dale Hollow Lake State Park, approximately 40 miles southeast of Edmonton, is located on 3,497 lakeside acres in southeastern Cumberland County. Park facilities include a marina, a picnic area, and 144 sites for tent and trailer camping. A private resort located on the lake provides facilities for swimming, fishing, boating, and playground activities, and offers cabin and houseboat rentals. Another private campground has tent and trailer camping, houseboat rentals, and a picnic area.

Lake Cumberland State Resort Park at Jamestown, 44 miles east of Edmonton, is a 3,000-acre park located on the 50,000-acre Lake Cumberland, which sports excellent bass, bluegill, and crappie fishing. The park features a modern resort lodge which is perched on a high bluff above the lake. The lodge has a swimming pool, a dining room, a gift shop, and a multipurpose convention center. Other park facilities include an additional swimming pool, riding stables, tennis courts, hiking trails, a 9-hole golf course, miniature golf, a picnic area, a playground, a 350-seat amphitheater, and a nature center. A marina offers houseboats, and fishing boats and motors for rent plus year-round launching ramps.
