They went to Ecuador for two years and then came to Bowling Green as refugees. Upon arrival in Bowling Green on October 28, 2003 the International Center found them housing for four months, during this time they studied English and learned survival skills for living in the United States. After four months Maria and her family moved into the Housing Authority's residential area. Maria

became involved in the REACH HIGHER Program at the Housing Authority of Bowling Green. While involved with the REACH HIGHER Program, Maria worked at Emerson Car Parts and DESA.

While living in Quito, Ecuador Maria worked as a seamstress, a skill that she has continued to practice for friends and family. Maria's dream has been to open an alteration shop. This dream will come true on January 8, 2008.

Maria and Viviana (Maria's daughter) will open the doors on January 8.
