



LETCHER COUNTY, KENTUCKY - A RESOURCE PROFILE

Letcher County, with a 1992 estimated population of 27,044, has a land area of 339 square miles. Whitesburg, the county seat of Letcher County, is located in southeastern Kentucky. In 1992, Whitesburg had an estimated population of 1,701. Whitesburg is located 149 miles southeast of Lexington, Kentucky; 159 miles northeast of Knoxville, Tennessee; 222 miles southeast of Louisville, Kentucky; and 217 miles southeast of Cincinnati, Ohio. Jenkins, located 12 miles northeast of Whitesburg, had a 1992 estimated population of 2,690.


The Economic Framework - The total number of Letcher County residents employed in 1993 averaged 7,074. In 1992, manufacturing firms in the county reported 44 employees; wholesale and retail trade provided 1,289 jobs; 1,226 people were employed in service occupations; state and local government accounted for 1,208 employees; and 1,255 people were employed by mining and quarrying operations.

Labor Supply - There is a current estimated labor supply of 36,958 persons available for industrial jobs in the labor market area. In addition, from 1994 through 1998, 16,421 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Whitesburg is served directly by highways U.S. 119 and Kentucky 15. U.S. Highways 23 and 119 serve Jenkins. The Daniel Boone Parkway is located 35 miles northwest of Whitesburg, while Interstate 75 is accessible 92 miles west of Whitesburg. Fourteen trucking companies provide Letcher County with interstate and/or intrastate service. CSX Transportation provides main line rail service to Whitesburg, Jenkins and Letcher County. Lonesome Pine Airport, 30 miles south of Whitesburg, maintains a 5,400-foot paved runway. Tri-City Regional Airport, near Bristol, Tennessee, 97 miles southeast of Whitesburg, provides the nearest scheduled commercial airline service.

Power and Fuel - Kentucky Power Company provides electric power to Whitesburg, Jenkins, and Letcher County. Letcher County is also provided electric power by Cumberland Valley Rural Electric Cooperative Corporation. Natural gas service is currently only available at private wells in Letcher County.

Education - Primary and secondary education is provided to Whitesburg and Letcher County by the Letcher County School System. The Jenkins Independent School System, located in Jenkins, Kentucky, 12 miles northeast of Whitesburg, also provides education for Letcher County. A nonpublic school also operates in the county. Southeast Community College, affiliated with the University of Kentucky, operates an extension campus in Whitesburg. Ten other institutions of higher learning are located within 100 miles of Whitesburg. Vocational training is provided by the Letcher County Area Vocational Education Center in Whitesburg and the Hazard State Vocational-Technical School in Hazard, 31 miles northwest of Whitesburg.



LABOR MARKET STATISTICS

The Letcher County Labor Market Area includes Letcher County and the adjoining Kentucky counties of Harlan, Knott, Perry, and Pike. The southeastern boundary of Letcher County is formed by the Kentucky-Virginia state line. The Labor Market Area may be supplemented by Wise County, Virginia.



UNEMPLOYMENT RATES 1993





AVERAGE PLACEMENT WAGES



TRANSPORTATION

Highways

Whitesburg is served directly by U.S. Highway 119 and Kentucky Route 15, both "AAA"-rated (80,000-pound gross load limit) trucking highways. Jenkins is served directly by U.S. Highway 23, a "AAA"-rated trucking highway. The Daniel Boone Parkway, a limited-access toll road, is located 35 miles northwest of Whitesburg via Kentucky Route 15. Interstate 75 is located 92 miles west of Whitesburg via Kentucky Route 15 and the Daniel Boone Parkway.

Blackey is served by Kentucky Route 7 and Fleming-Neon is served by Kentucky Route 317. Each is a "AA"-rated (62,000-pound gross load limit) trucking highway.

Two major highway improvement projects in Letcher County include the recent widening and straightening of U.S. 119 near Whitesburg. U.S. 23 and 119 at Jenkins is being widened to four lanes.

U.S. Highway 23 extends from Michigan to Florida and is predominately four lanes throughout the highway system. Construction is planned to widen the entire highway to four lanes. U.S. 23 and Alternate U.S. 58 in Virginia provide multilane access to Interstate 81, 74 miles southeast of Letcher County.



Letcher County is governed by a county judge/executive and five magistrates. Whitesburg, Blackey, Fleming-Neon and Jenkins are each governed by a mayor-council form of government.

Local Fees and Licenses

The City of Whitesburg levies a business license fee of \$75 for the first year for most businesses. Then each year thereafter, the fee is based on annual retail sales receipts. The City of Jenkins levies an annual business license fee ranging from \$18.75 to \$300. Annual unloading license fees are \$100. The City of Fleming-Neon levies annual business license fees ranging from \$25 to \$75.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

Local

Recreation

Letcher County maintains a public park which includes a swimming pool, four tennis courts, two playgrounds, a baseball diamond, and a football field. Private recreational facilities include a twin-cinema theatre, a country club, a golf course, a swimming pool, a skating rink, and a drive-in theatre.

Recreational projects under way in the Whitesburg area include the development of: Fish Pond Lake, a county fishing lake with picnic facilities; and the Riverside Community Park.

Nature Conservancy's Bad Branch Falls is located ten miles south of Whitesburg. This hiking area features a 60-foot waterfall and various endangered plant and animal species.

Daniel Boone and Jefferson National Forests, which lie in Kentucky and Virginia respectively, are located near Whitesburg. Hunting, fishing, hiking, and camping are permitted.

Carr Fork Lake, located about 20 miles north of Whitesburg, is a 710-acre flood control lake which provides excellent recreational facilities. Kentucky Highways 15 and 160 provide easy access to the lake area. The lake provides swimming, boating, productive fishing and a camping area with hookups and primitive campsites.

The Lilley Cornett Woods is located in Letcher County, approximately 30 miles east of Whitesburg. Guided tours are offered from April to October in the 554 acres of virgin woodland.

Development of new picnic areas and overlooks are under way at the Little Shepherd Trail. This is a 20-mile state-designated scenic route on the Pine Mountain ridge.

Culture

Appalshop, Inc., located in Whitesburg, is an award-winning, nationally acclaimed non-commercial arts and education center which produces and distributes film and television documentaries, recordings, radio programs, and plays focusing on the Appalachian region. The center consists of Appalshop Films, Headwaters Television, June Appal Recordings, Roadside Theatre, WMMT-FM, Appalachian Media Institute, and the Appalshop Center, which features an art gallery and a 175-seat theatre and presents a variety of performances and community activities throughout the year.

Letcher County Arts Council, Inc., promotes art, music, theatre, dance, writing, and other cultural programs in the area. High quality ballet, jazz and modern dance classes are offered in Whitesburg.
