



MIDDLESBORO AND PINEVILLE, KENTUCKY - A RESOURCE PROFILE

Middlesboro, Bell County's largest city, had a 1990 population of 11,328. Located in the southeastern corner of the state, Middlesboro is only a few miles from the Tennessee and Virginia state lines. Middlesboro is located 61 miles north of Knoxville, Tennessee; 129 miles southeast of Lexington, Kentucky; 205 miles south of Cincinnati, Ohio; and 255 miles north of Atlanta, Georgia.

Pineville is the county seat of Bell County and is located 13 miles north of Middlesboro. In 1990, Pineville had a population of 2,198.

Bell County covers 360 square miles and is situated in the Eastern Coal Field Region of Kentucky. In 1990, Bell County had a population of 31,506. Both the Cumberland Gap National Historical Park and the Pine Mountain State Resort Park are located within Bell County's boundaries, making it the only county in Kentucky to contain both a national park and a state park.


The Economic Framework - The total number of Bell County residents employed in 1992 averaged 8,595. In 1991, manufacturing firms in the county reported 941 employees; wholesale and retail trade provided 2,546 jobs; 1,775 people were employed in service occupations; state and local government accounted for 1,582 employees; and 1,107 people were employed by mining and quarrying operations.

Labor Supply - There is a current estimated labor supply of 34,048 persons available for industrial jobs in the labor market area. In addition, from 1993 through 1997, 14,137 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Middlesboro is served by U.S. Highways 25E and 58, and Kentucky Highway 74. Pineville is served by U.S. Highways 25E and 119, and Kentucky Highways 221 and 66. Interstate 75 is accessible 48 miles northwest of Middlesboro and 35 miles northwest of Pineville via U.S. 25E. Interstate 81 is located 54 miles southeast of Middlesboro and 67 miles southeast of Pineville via U.S. 25E. Fifteen trucking companies provide interstate and/or intrastate service to Middlesboro while thirteen trucking companies serve Pineville. The Middlesboro-Bell County Airport is equipped with a 3,650-foot paved runway. The nearest scheduled airline service is available in Knoxville, Tennessee, at the McGhee Tyson Airport, 71 miles south of Middlesboro. Rail service is provided to Middlesboro and Pineville by the CSX Transportation Company. Middlesboro is also served by the Norfolk Southern Railway.

Power and Fuel - Kentucky Utilities Company provides electric power to Middlesboro, Pineville and Bell County. Natural gas service is provided to both Middlesboro and Pineville by Delta Natural Gas Company, Inc.

Education - Three public school systems operate in Bell County: the Middlesboro Independent School System, the Pineville Independent School System, and the Bell County School System. Two non-public schools are available in Middlesboro. Twelve institutions of higher learning are located within 100 miles of Middlesboro. Vocational education is available at two vocational education centers located in Pineville - the Bell County Area Vocational Education Center and the Cumberland Valley Health Occupations Center. Harlan State Vocational-Technical School provides post-secondary vocational training in Harlan, Kentucky, 46 miles northeast of Middlesboro.



LABOR MARKET STATISTICS

The Middlesboro/Pineville Labor Market Area includes Bell County and the adjoining Kentucky counties of Clay, Harlan, Knox, Leslie, and Whitley. Additional workers may be drawn from nearby counties in Tennessee and Virginia.







AVERAGE PLACEMENT WAGES



TRANSPORTATION

Highways

U.S. Highway 25E, a "AAA"-rated (80,000-pound gross load limit) highway, U.S. Highway 58 and Kentucky Highway 74 serve Middlesboro. Pineville is served by U.S. Highways 25E and 119, both "AAA"-rated. Kentucky Highways 221 and 66 also serve Pineville.

Interstate 75 is located 35 miles northwest of Pineville and 48 miles northwest of Middlesboro via U.S. 25E. Interstate 81 is located 54 miles southeast of Middlesboro and 67 miles southeast of Pineville via U.S. 25E.

Construction of the Cumberland Gap Tunnel is under way. The \$258 million federal highway project is scheduled for completion by early 1996 with the concurrent restoration of the Cumberland Gap to be completed by 1998. In addition, an 11-mile section of U.S. Highway 25E in Bell County extending from Pineville into Knox County is presently being converted to four lanes. Upon completion, U.S. 25E will provide four-lane access to Tennessee from I-75 in Whitley County. All projects have been let and are expected to reach completion by 1995.



The City of Pineville is presently extending water service to the Stoney Fork and Hances Creek areas. Construction of several new lines and replacement of existing lines at the Stoney Fork area will eliminate some leaking problems thereby increasing overall water capacity by approximately 25 percent. The \$1.6 million project is scheduled for completion by June 1994. In addition, the City of Pineville plans to expand its existing water treatment plant in the near future.

Local Fees and Licenses

The City of Middlesboro levies a two percent occupational license tax on gross wages, salaries, and commissions of individuals and on net profits of businesses. The City of Middlesboro also levies an annual business license fee ranging from \$250 to \$750 based upon the number of employees.

The City of Pineville levies a one and one-half percent occupational license tax on gross wages, salaries, and commissions of individuals and on net profits of businesses. The City of Pineville also levies an annual business license fee ranging from \$35 to \$500 based upon gross receipts.

PROPERTY TAXES

×

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. A 15% reduction is automatically granted for accounts receivable.

Construction began in 1993 of an \$11 million higher education facility to be used jointly by the Southeast Community College and Kentucky Tech, thereby making it the first joint venture between the community college system and the vocational education program in Kentucky. Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low cost customized training programs and services for both established and prospective businesses. Businesses wanting to establish a customized training program should simply contact a Training and Development Coordinator located at the Laurel State Vocational-Technical School in London, Kentucky.

Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies customized assessment in career inventories, interest inventories, psychomotor skills and academic potential, as well as pre-hire assessment. A Career Connections Assessment Center is located at the Laurel State Vocational-Technical School.

Adult Education Services

Adult education programs are available to adults who want to develop new skills, improve basic skills or earn a high school equivalency diploma. In Bell County, adult literacy is provided by the Bell County Council on Literacy in Middlesboro and adult basic education is provided by the Bell County Board of Education in Pineville and the Middlesboro Independent Board of Education in Middlesboro.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

Middlesboro offers a variety of recreational facilities and programs. The city supports supervised programs, six parks, four playgrounds, a swimming pool, six tennis courts, one softball field, two baseball diamonds, one football field, four basketball courts and the Tri-County YMCA.

Many private recreational facilities are also available in Middlesboro. The Middlesboro Country Club, which opened in 1889, has been in continuous operation longer than any other Country Club in the United States. The country club maintains a nine-hole golf course and a swimming pool. A movie theatre, a video arcade and a roller skating rink are available to the public in Middlesboro.

The Cumberland Mountain Fall Festival is held in Middlesboro in mid-October. Other tourist attractions found in Middlesboro are the Cumberland Gap Arts Council and Coal House (Chamber of Commerce Building). Lincoln Memorial University, located a few miles outside of Middlesboro in Harrogate, Tennessee, has the world's second largest collection of Abraham Lincoln relics on display. Cumberland Gap National Historical Park includes: a frontier museum; Pinnacle Mountain that overlooks three states; three caves; an old iron furnance; and Hensley Settlement, a resort mountain village where the Quilt Festival is held annually. Cumberland Gap is a natural passage which served as a gateway through the Appalachian Mountains for pioneers moving westward into new frontiers. As a part of a major federal project, the Gap will be restored to its original condition by 1998.

Pineville offers a variety of cultural events and attractions. The Southeastern Kentucky Community Concert Series performs concerts on a regular basis. Also held in town each year is the Sidewalk Art Show. The City of Pineville recently restored the Bell Theatre in downtown Pineville. Movies and community events are featured at the theatre. Located just outside of town is Pine Mountain State Resort Park, which provides the finest in mountain scenery and the ultimate in quiet comfort. The 1,500-acre park is located in the Kentucky Ridge State Forest and is the scene of the Mountain Laurel Festival each spring. Also featured is a 35-acre lake, 30 lodge rooms, 20 cottages, a dining room, a gift shop, a convention center, 33 camping sites, a lodge pool, fishing, a nine-hole golf course, hiking trails, a nature center, a recreation room, picnicking, playgrounds, miniature golf, shuffleboard, and planned recreation. The City of Pineville plans to restore a lake in the Pineville area for recreational purposes. A boat dock and 50 RV sites will be added to the area. In addition, the existing nine-hole golf course at the lake will be expanded to 18 holes.

COMMUNITY IMPROVEMENTS

Middlesboro and Pineville each re-certified as a "Kentucky Certified City" in 1992, and are distinguished as gold award winners. Re-certification is based on achievement in the following areas: existing industry assistance, small business assistance, educational resources, and community development factors of health care, public safety, arts and culture, recreation, governmental awareness and resources. In addition to receiving the 1992 Gold Award, Middlesboro and Pineville were recognized as Hall of Fame communities. This category not only demonstrates that a community is adequately prepared for immediate growth, but also that the community has analyzed emerging economic trends, and has set about planning for the future. The Certified Cities Program is sponsored by the Kentucky Chamber of Commerce.

Recent

Mountain Tarp and Awning Company recently relocated to a newer more modern facility in Middlesboro. New products have been added to its manufacturing operation.

Cumberland Gap Provision Company, a meat processor in Middlesboro, added 30 new jobs.

The Bell County Industrial Foundation received donated property for the development of an industrial park. Covering approximately 50 acres, the site has access to all utilities and public highways. Sewer lines are presently being constructed.

Middlesboro Appalachian Regional Hospital recently completed a \$3 million expansion project involving the construction of a new emergency room, an out-patient care area, and acquistion of new equipment.

Bell County School System currently has two schools including an elementary and high school which are participating in the National Alliance. The program is designed to award grants to selected schools, thereby providing monies for telecommunications equipment to create innovative and unique learning opportunities. Bell County High School was one of only four high schools selected in Kentucky.

The Middlesboro Independent School System recently completed construction of two new gymnasiums, two new libraries, and three new computer labs, plus the installation of central air conditioning at all school buildings.

Construction of a \$1.2 million multi-purpose facility was recently completed at Pine Mountain State Resort Park. Facilities include a convention center and a recreation area.

The Middlesboro Medical Mall and Senior Citizens Center have recently opened. Total cost of construction for the two projects was \$1.8 million.

The Middlesboro-Bell County Airport Board recently completed a project to resurface the runway and constructed several new hangars at the airport.

The City of Pineville restored the Bell Theatre in downtown Pineville at a cost of \$200,000. Movies and community events are featured at the theatre.

Under Way

Construction of the Cumberland Gap Tunnel is under way. The \$258 million federal highway project is scheduled for completion by early 1996 with the concurrent restoration of the Cumberland Gap to be completed by 1998. In addition, an 11-mile section of U.S. Highway 25E in Bell County extending from Pineville into Knox County is presently being converted to four lanes. Upon completion, U.S. 25E will provide four-lane access to Tennessee from I-75 in Whitley County. All projects have been let and are expected to reach completion by 1995.

M. Fine & Sons Manufacturing Company, Inc. is in the process of adding 30 new jobs which will improve its finishing processes for the garments.

The City of Pineville is presently constructing a new 724,000-gallon-per-day wastewater treatment facility. Line extensions and replacements are included in this \$2.6 million project, which is scheduled for completion by January 1995.

Construction began in 1993 of an \$11 million higher education facility to be used jointly by the Southeast Community College and Kentucky Tech, thereby making it the first joint venture between the community college system and the vocational education program in Kentucky. The Middlesboro Campus is scheduled for completion in early 1995.

The City of Middlesboro is presently constructing new sewer lines in the developing areas of the beltline. At a cost of \$850,000, the project is scheduled for completion by November 1993.

Wal-Mart in Middlesboro is relocating to another new facility. Construction of a 200,000-square-foot super store is under way and scheduled for completion in Summer 1994. The new store will create approximately 225 new jobs.

The City of Pineville is presently extending water service to the Stoney Fork and Hances Creek areas. Construction of several new lines and replacement of existing lines at the Stoney Fork area will eliminate some leaking problems thereby increasing overall water capacity by approximately 25 percent. The \$1.6 million project is scheduled for completion by June 1994. The Middlesboro Independent School System is in the process of constructing a fine arts center which should be completed by December 1993. Total cost of the project is estimated at \$2.8 million.

Phase I of the Middlesboro Centennial Park and Canal Project was completed in 1990. Phase II is under way. The project involves the dredging of a canal that runs through the center of downtown Middlesboro and development of the area surrounding the canal. Landscaping, walking trails, and gazebos have been planned.

Planned

The City of Pineville plans to expand its existing water treatment plant in the near future.

The City of Pineville plans to restore a lake in the Pineville area for recreational purposes. A boat dock and 50 RV sites will be added to the area. In addition, the existing nine-hole golf course at the lake will be expanded to 18 holes.
