



# LOUISA, KENTUCKY - A RESOURCE PROFILE

Louisa, the county seat of Lawrence County, lies on the Kentucky-West Virginia border in the northeastern section of Kentucky's Eastern Coal Field Region. Lawrence County's eastern border is formed by the Big Sandy River. Its river valleys become narrower and the elevation generally higher as one moves westward.

Louisa is located 33 miles south of Ashland, Kentucky; 34 miles southwest of Huntington, West Virginia; 244 miles northeast of Knoxville, Tennessee; and 205 miles east of Louisville, Kentucky. Louisa had an estimated 1994 population of 2,258. Lawrence County, with a land area of 418 square miles, had an estimated 1994 population of 15,072.


The Economic Framework - The total number of Lawrence County residents employed in 1994 averaged 4,400. Manufacturing firms in the county reported 205 employees; wholesale and retail trade provided 637 jobs; 549 people were employed in service occupations; state and local government accounted for 555 employees; contract construction firms provided 125 jobs; and 99 people were employed by mining and quarrying operations.

Labor Supply - There is a current estimated labor supply of 22,477 persons available for industrial jobs in the labor market area. In addition, from 1996 through 2000, 11,393 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - U.S. Highway 23, a "AAA"-rated (80,000-pound gross load limit) trucking highway, serves Louisa and provides access to Interstate Highway 64, 25 miles north of the city. Kentucky Highways 3 and 32, both "AA"-rated (62,000-pound gross load limit) trucking highways, also serve Louisa. U.S. Highway 52 is accessible two miles east of Louisa in West Virginia via West Virginia Route 37. Fourteen common carrier trucking companies serve Louisa, providing interstate and/or intrastate service. CSX Transportation provides main line rail service to Louisa. The nearest scheduled commercial airline service is available at Tri-State Airport, 31 miles northeast of Louisa near Huntington, West Virginia.

**Power and Fuel** - American Electric Power provides electric power to Louisa and a major portion of Lawrence County. The remainder of the county is served by the Big Sandy Rural Electric Cooperative Corporation and the Grayson Rural Electric Cooperative Corporation. Columbia Gas of Kentucky provides natural gas service to Louisa.

**Education** - The Lawrence County Public Schools System provides primary and secondary education to students in Lawrence County. Ten institutions of higher learning are located within 85 miles of Louisa. The Ashland Regional Technology Center at Ashland, the Martin County Area Technology Center and the Mayo Regional Technology Center provide vocational training facilities within 35 miles of Louisa.



#### LABOR MARKET STATISTICS

The Louisa Labor Market Area includes Lawrence County and the adjoining Kentucky counties of Boyd, Carter, Elliott, Johnson, Martin, and Morgan. Although not included below, the Labor Market Area is supplemented by Wayne County in West Virginia, which forms the eastern boundary of Lawrence County.







# AVERAGE PLACEMENT WAGES



# RECENT INDUSTRIAL DEVELOPMENT

The Greater Louisa Industrial foundation plans to utilize 23 acres of land, located near the junction of Kentucky Routes 23 and 32 for an industrial site.

American National Rubber recently began operation in Louisa and expects to have 190 jobs filled by 1996. Total investment was \$2.4 million.

# NON-MANUFACTURING FIRMS

Brown Food Service, a distribution center for institutional foods and supplies, is a major non-manufacturing employer in Louisa. Expansion currently underway will increase refrigeration capacity of 12,500 square feet by another 6,000 square feet. The operation has an average employment of 125, and serves eastern Kentucky, south Ohio, and nearby counties in Virginia and West Virginia. Three Rivers Medical Center employs 200 persons. Kentucky Power Company currently employees 220 persons. Jim Syrus Construction and Equipment, Inc. employs 20 persons.

Wilson Enterprises, a land development firm, employs 10 full-time persons and is in the process of developing a strip mall, food marts, a 60-room motel, and a 50 home residential area for older adult couples. Young Realty is preparing a 10-acre site with utilities at the northern city limits of Louisa that will be available for development.

Kentucky Highways 3 and 32, both "AA"-rated (62,000-pound gross load limit) trucking highways, also serve Louisa. Kentucky Route 645 is a multi-lane highway from its intersection with U.S. 23, 14 miles south of Louisa, to Inez.

U.S. Highway 52, a major trucking highway, is accessible two miles east of Louisa in West Virginia, via West Virginia Route 37.



# LOCAL GOVERNMENT

#### Structure

The City of Louisa is governed by a mayor and six council members. The mayor is elected to a four-year term while the council members each serve two-year terms. Lawrence County is governed by a county judge/executive and four magistrates. Each county official serves a four-year term.

# **Local Fees and Licenses**

Business licenses in Louisa range from \$20 to \$95 annually. A \$10 automobile sticker fee and an eight percent insurance premium license are levied annually.

# PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

Music, science, and art department additions were recently completed at Fallsburg Elementary and Blaine Elementary Schools at a cost of \$900,000. Construction of a new 31 classroom elementary school in Louisa is expected to be completed in 1996 at a cost of \$5.8 million.

# Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

### RECREATION

#### Local

Louisa offers a variety of recreational opportunities for all ages. Facilities include Stella-Moore Park, which features a softball field, tennis courts, and a basketball court. Additional football and baseball fields are available at the local schools. The City of Louisa operates a swimming pool and is developing a recreation area with a picnic area, a shelter house, horseshoe pits, grills, and a pond. A mini-park and a playground are maintained in the downtown area as well.

A softball field is located in the Lawrence County community of Martha, approximately 15 miles southwest of Louisa.

The U.S. Army Corps of Engineers recently developed Yatesville Lake four miles northwest of Louisa. With almost 40 miles of scenic shoreline, the lake and recreational site is located on approximately 27,000 acres. It provides some of the best bass fishing in the eastern United States. Future development plans for the lake include the Pleasant Ridge Recreational Area, which will offer an array of recreation activities such as an 18-hole golf course, lodge accommodations, tennis courts, horseback riding, an outdoor pool, day camps, RV hook ups, and hiking trails.

Recreational boating is a popular sport at Levisa and Tug Forks of the Big Sandy River where a boat ramp is available.

Louisa sponsors several recreational programs each year, including Little League baseball, basketball, and football. Adult baseball and basketball leagues are offered as well.

Phase I plans are underway in Louisa to develop a museum honoring a former local resident, Fred M. Vinson, the 13th Chief Justice of the United States Supreme Court. The \$2.0 million Phase II of the project is being supported by the National Bar Association and the National American Legion. The project includes a restoration of his birthplace which is listed on the National Register of Historic Places.

### Area (Within 35 miles)

The Big Sandy area provides a variety of recreational attractions including nine lakes, five golf courses, several parks and other sources of entertainment.

The Paramount Arts Center, located in Ashland, 33 miles north of Louisa, is owned and operated by the Greater Ashland Foundation, a non-profit group. The Center is the site of many cultural events including plays, concerts, and ballets. Groups may rent the facility for conventions and performances.

The Kentucky Highland Museum, also at Ashland, is the former Mayo Manor Mansion and features displays of clothing, artwork, and changing exhibits relating to Appalachian culture.
