

NICHOLASVILLE, KENTUCKY - A RESOURCE PROFILE

Nicholasville, the county seat of Jessamine County, lies within central Kentucky's Blue Grass Region, an area of low rolling hills. Nicholasville is located 12 miles south of Lexington, Kentucky; 85 miles east of Louisville, Kentucky; and 90 miles south of Cincinnati, Ohio. The city had a 1990 population of 13,603 persons.

Jessamine County, with a land area of 175 square miles, features terrain which ranges from rolling hills in the northern and central portions of the county, to steeper hills in the southern portions. Along the Kentucky River, which forms the southern boundary of the county, the landscape is much more rugged - the river winds through a deeply entrenched gorge whose cliff-lined walls rise vertically 400 feet or more. Jessamine County's 1990 population was 30,508 persons.


The Economic Framework - The total number of Jessamine County residents employed in 1990 averaged 16,025. In 1989, manufacturing firms in the county reported 1,598 employees; wholesale and retail trade provided 1,971 jobs; 955 people were employed in service occupations; state and local government accounted for 930 employees; and contract construction firms provided 920 jobs.

Labor Supply - There is a current estimated labor supply of 33,893 persons available for industrial jobs in the labor market area. In addition, from 1990 through 1994, 24,143 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Nicholasville is served by U.S. Highway 27, a "AAA"-rated trucking highway, and by Kentucky Routes 29, 39, and 169, all "AA"-rated highways. In addition, Interstate Highways 64 and 75 are accessible approximately 17 miles northeast of Nicholasville near Lexington. Thirty-seven trucking companies serve Nicholasville. The Southern Railway System provides main line rail freight service to Nicholasville. The nearest scheduled commercial airline service is available at Bluegrass Airport, 13 miles northwest of Nicholasville near Lexington.

Power and Fuel - The City of Nicholasville Utilities, whose source of electric power is Kentucky Utilities Company, provides electric power to Nicholasville. Kentucky Utilities Company and Blue Grass Rural Electric Cooperative Corporation also serve portions of Jessamine County. Delta Natural Gas Company provides natural gas service to Nicholasville.

Education - The Jessamine County Public School System, accredited by the Southern Association of Colleges and Schools, provides primary and secondary education in Jessamine County. Asbury College, seven miles west of Nicholasville, is the nearest of 11 colleges and universities located within 50 miles of Nicholasville. Vocational training is available at Central Kentucky State Vocational-Technical School and at two area vocational education centers, all located at Lexington, 12 miles north of Nicholasville.



UNEMPLOYMENT RATES 1990







Highways

Nicholasville is served by U.S. Highway 27, a "AAA"-rated (80,000-pound gross load limit) trucking highway, and by Kentucky Routes 29, 39, and 169, all "AA"-rated (60,000-pound gross load limit) trucking highways.

In addition, Interstate 64, a major east-west highway, and Interstate 75, a major north-south traffic artery, intersect 17 miles northeast of Nicholasville at Lexington.

A bypass has been constructed around the west side of downtown Nicholasville, from U.S. Highway 27 north of the city to U.S. Highway 27 south of the city. A project to widen the segment of U.S. Highway 27 from the bypass at Nicholasville north to Lexington has also been completed. This portion of U.S. 27 is now a four-lane highway.



Nicholasville is governed by a mayor and four commissioners. The mayor is elected to a four-year term, while the commissioners serve two-year terms each. Jessamine County is governed by a county judge/executive and six magistrates. Each county official serves a four-year term.

Jessamine County levies a one percent occupational license tax on gross wages, salaries, and commissions of individuals and on net profits of businesses.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. A 15% reduction is automatically granted for accounts receivable.

Vocational Training

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

City-County Park, a 22-acre facility, was developed jointly by the City of Nicholasville and the Jessamine County Fiscal Court. It is the home of many youth and adult sports activities. Primary facilities include: a softball field, two basketball courts, two shelters, two tennis courts, and four soccer fields. City-County Park also provides space for the Jessamine Youth Football League in an enclosed lighted football facility equipped with fieldhouse, grandstands, and concession area. The park is also the home of the Jessamine Little League and Babe Ruth Baseball Association. The baseball games are held at a four-field complex which includes a concession area. City-County Park provides a large playground area suitable for all ages of youth.

The Jessamine County Fairgrounds, located at City-County Park, offers a multi-purpose building including restroom facilities with group reservations available. The Fairgrounds also features a horse show ring, a tractor pull arena, animal barns, a 16-pit horseshoe area, and a covered shelter for pageants, shows, and theatricals.

Six other parks are available locally including: Lake Mingo Park, a municipally-owned facility, features three shelter areas which are available for group reservations, a tennis court, a playground area, a picnic area, a basketball court, an exercise area, and a one-half mile paved jogging/walking track. Hayden Park, located on Jefferson Street, offers a state of the art playground area, a multi-purpose ball diamond, and a shelter/restroom facility. Rock Fence Park, located on the corner of Oak Street and Kentucky 169, offers a large playground area and a shelter/picnic area for the surrounding neighborhood. The James Mason Soccer Facility, located on Keene Road at Belle Place, offers an olympic-size soccer field that is recessed for amphitheater-type seating on all sides of the field. Billy Lockridge Park is located in the front of Keene Land on Keene Way Drive. The park includes a playground area, a picnic area, and a shelter. Woody Grow Park is located in the rear of Keene Land. The park offers a sand volleyball court, a basketball court, a playground area, and a shelter.

Youth athletics programs include baseball, basketball, football, and soccer. The football programs have corresponding cheerleading programs for girls. Adult leagues for basketball, softball, and volleyball are available as well.

The Lone Oak Country Club offers a 18-hole golf course, a swimming pool, and tennis.

Asbury College, located in Wilmore, features special exhibits, performances, and sports events which are open to the public.

COMMUNITY IMPROVEMENTS

Utilities

Delta Natural Gas Company recently completed several projects for replacement of obsolete distribution facilities and extended service to new housing and business development areas.

The City of Nicholasville recently expanded its water treatment system to six million gallons-per-day. The \$3.4 million expansion included construction of a water transmission line loop and a one million gallon elevated water storage tank. In addition, the utilities department plans to construct another wastewater treatment facility at a total cost of \$9.8 million. This improvement will raise the total treatment capacity to 5.7 million gallons per-day.

The Spears Water Company, Inc. plans to construct an additional 250,000-gallon water storage tank.

Contingent upon funding, the Lexington-South Elkhorn Water District plans to construct a 500,000-gallon elevated water storage tank and additional water distribution lines.

Education

Jessamine County School System is planning or currently involved in several improvements projects. These projects include renovation and expansion of facilities, plus additions to the curricula including programs for advanced technology, computer use, and for gifted students. Construction of the "Jessamine County Independent High School" was recently completed.

Community Development

Construction of the Kentucky Veterans Center in Wilmore is near completion. The 300-bed facility will provide three levels of care including domiciliary, intermediate, and skilled. The \$15 million facility will eventually employ 325 persons at full capacity.

The Jessamine County Health Department recently purchased property with plans to construct a new health department facility. Total cost of the project is estimated at \$700,000.

The Jessamine County Historical Society and the Jessamine County Fiscal Court are cooperatively renovating the old county jail which will be converted to rental office space and meeting facilities for the Historical Society.

A major project to restore the downtown area of Wilmore, Kentucky is under way. Details include: storefront refurbishments, construction of new sidewalks, streetlights and parking lots, and general aesthetic improvements.
