



HAZARD, KENTUCKY - A RESOURCE PROFILE

Hazard, the county seat of Perry County, is located in the Eastern Kentucky Coal Field. Hazard is located 117 miles southeast of Lexington, Kentucky; 155 miles north of Knoxville, Tennessee; 191 miles southeast of Louisville, Kentucky; and 188 miles southeast of Cincinnati, Ohio. The city's estimated 1994 population was 5,730.

Perry County, with a land area of 342 square miles, is made up of ridges and valleys occupying about equal portions of the landscape. Perry County had an estimated 1994 population of 31,193.


The Economic Framework - The total number of Perry County residents employed in 1995 averaged 10,590. Manufacturing firms in the county reported 268 employees; wholesale and retail trade provided 2,994 jobs; 2,548 people were employed in service occupations; state and local government accounted for 2,288 employees; contract construction firms provided 220 jobs; and 1,318 people were employed by mining and quarrying operations.

Labor Supply - There is a current estimated labor supply of 40,122 persons available for industrial jobs in the labor market area. In addition, from 1998 through 2002, 14,477 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major highways directly serving Hazard include Kentucky Highways 15, 80, and 476, all AAA-rated (80,000-pound gross load limit) trucking highways. Two interchanges of the Daniel Boone Parkway are located within five miles of Hazard. Fourteen trucking companies provide interstate and/or intrastate service to Hazard. CSX Transportation provides main line rail service to Hazard. The Wendell H. Ford Regional Airport, 10 miles north of Hazard, maintains a 5,000-foot paved runway. The nearest scheduled commercial airline services are located at Blue Grass Airport near Lexington, Kentucky, 121 miles northwest; and at Tri-State Airport near Huntington, West Virginia, 121 miles northeast of Hazard.

Power and Fuel - Electric power is provided to Hazard and Perry County by American Electric Power. The City of Hazard Gas Company provides natural gas service to Hazard.

Education - Primary and secondary education is provided by the Hazard Independent School System, which is accredited by the Southern Association of Colleges and Schools, and the Perry County School System. Hazard Community College offers degrees in Associate in Arts, Associate in Science, Associate in Applied Science, Associate in Nursing, and Associate in Radiography. In addition, seven other colleges are located within 70 miles of Hazard. Vocational training is available locally at the Hazard Regional Technology Center. Three area technology centers are also located within 35 miles of Hazard.



LABOR MARKET STATISTICS

The Hazard Labor Market Area includes Perry County and the adjoining Kentucky counties of Breathitt, Clay, Harlan, Knott, Leslie, Letcher, and Owsley.



UNEMPLOYMENT RATES 1995







AVERAGE PLACEMENT WAGES



TRANSPORTATION

Highways

Hazard is served directly by Kentucky Highways 15, 80, and 476, all AAA-rated (80,000-pound gross load limit) trucking highways. Kentucky 80 is four lanes between Hazard and Pikeville. Interchanges with the Daniel Boone Parkway, a multi-lane toll road, are located four miles north and five miles west of Hazard.

The Mountain Parkway, a multi-lane highway, is accessible 53 miles north of Hazard via Kentucky 15. Interstate 75, a major north-south multi-lane highway, is accessible 61 miles west of Hazard via the Daniel Boone Parkway.

Interstate 64, a major east-west multi-lane highway, is accessible 97 miles northwest of Hazard, near Winchester, via Kentucky 15 and the Mountain Parkway.



LOCAL GOVERNMENT

Structure

The City of Hazard is served by a mayor, four council members, and a city manager. Perry County is governed by a county judge/executive and three magistrates.

Planning and Zoning

Local Fees and Licenses

The City of Hazard levies a 1.0 percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses within the city. A franchise fee of 3.0 percent of gross sales is also levied.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

The Hazard Independent School District ranks 15th in the state in absolute ranking by district total scores of the KIRIS Assessment, improving its standing from 17th. A \$3.5 million district-wide renovation project is under way. All schools in the district will undergo significant upgrade and renovation.

The Perry County School System completed construction of Perry County Central High School. The 1,300-student complex consolidated two existing high schools in the system. Facilities include 70 classrooms, an auditorium, a library, a chemistry and physics lab, and the John C. Combs Arena.

Hazard Community College

Hazard Community College is one of 14 two-year colleges in the University of Kentucky Community College System. H.C.C. is a unique multi-campus institution with a commuter campus in Hazard and a residential campus at Lees College in Jackson. Serving the eight-county Kentucky River region of southeastern Kentucky, the college enrolls 2,400 students in credit courses and over 7,500 students in non-credit classes each semester. The college is committed to the development of the region through education, leadership training, economic development, preservation of Appalachian culture, and cultural enrichment.

The College is constructing a classroom/economic development building. The \$10 million complex will feature state-of-the-art classrooms, computer labs, training rooms, a 10,000 square-foot convention center, a telecommunications/interactive video center, a bookstore, food service, a black-box theatre, and faculty offices.

Eastern Kentucky Challenger Center

Hazard Community College is facilitating the development of a Challenger Learning Center. Formed in 1986 by families of the NASA Challenger 51-L space crew, the Challenger Center for Space Science Education develops programs that inspire students to learn and explore while fostering an interest in math, science, and technology. The centers, targeting grades 5-8, give students hands-on experience in a spaceflight simulator. Instructional models emphasize educational content, cooperative learning, problem-solving, and responsible decision-making.

VOCATIONAL-TECHNICAL TRAINING

Kentucky Tech schools are operated by the Cabinet for Workforce Development and provide secondary (Sec) and postsecondary (P/S) vocational-technical training.

Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Businesses wanting to establish a customized training program should contact a Training and Development Coordinator located at the Hazard Regional Technology Center.

Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies testing packages for evaluating job applicants, selecting employees for promotional consideration and developing training programs within the organization. A Career Connections Assessment Center is located at the Hazard Regional Technology Center.

Adult Education Services

Adult education programs are available to adults who want to develop new skills, improve basic skills, or earn a high school equivalency diploma. In Hazard, adult basic education and adult literacy classes are administered through the Kentucky Valley Educational Coop office.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Hazard offers a variety of public recreational facilities which includes three city parks with basketball courts, tennis courts, an amphitheater, a picnic shelter, two playgrounds, a nine-hole golf course, two volleyball courts, a horseshoe court, and a boat ramp on the North Fork of Kentucky River.

Perry County Park features a swimming pool, four picnic shelters, four ball fields, two tennis courts, two basketball courts, a walking track, mini-golf, a playground, a horse show ring, and a senior citizens center.

The Hazard Pavilion, located in the heart of Hazard, is a multi-purpose complex which contains an Olympic-size swimming pool, an indoor track, basketball/volleyball courts, two tennis courts, racquetball courts, an aerobics room, locker rooms, and a kitchen.

A private country club in Perry County maintains a nine-hole golf course and a swimming pool.

The Black Gold Festival, held the third weekend in September, is dedicated to the coal industry, one of Kentucky's major resources. Events held during the festival include a canoe and raft race; car raffle; 10,000 meter marathon; powder shoot; style show; parade; coal truck competition; square dancing; window decorating contest; horseshoe contest; continuous country, rock, and gospel music; old-fashioned dressup day; the Miss Black Gold Festival Pageant; arts and crafts exhibits; and food booths. The festival annually attracts nearly 100,000 visitors.

Hazard Community College provides many entertainment opportunities which include the Greater Hazard Area Performing Arts Series, Civic Chorus, and Civic Theater.

The Bobby Davis Park and Museum contains artifacts and photographs depicting the area's heritage from the late nineteenth century through World War II.
