BOYLE COUNTY



DANVILLE, KENTUCKY - A RESOURCE PROFILE

Danville, the county seat of Boyle County, is located in the gently rolling landscape of central Kentucky's Blue Grass Region. The city's central location and excellent transportation facilities contribute to the city's growth as a manufacturing and distribution center. Danville had a estimated population of 13,036 in 1992. Danville is located 35 miles south of Lexington, Kentucky; 84 miles southeast of Louisville, Kentucky; 155 miles north of Knoxville, Tennessee; and 114 miles south of Cincinnati, Ohio.

Boyle County, with a land area of 181 square miles, had a 1992 estimated population of 25,934 persons.


The Economic Framework - The total number of Boyle County residents employed in 1994 averaged 12,616. In 1993, manufacturing firms in the county reported 3,493 employees; wholesale and retail trade provided 3,837 jobs; 3,149 people were employed in service occupations; state and local government accounted for 1,563 employees; and contract construction firms provided 368 jobs.

Labor Supply - There is a current estimated labor supply of 5,302 persons available for industrial jobs in the labor market area. In addition, from 1996 through 2000, 8,958 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major "AAA"-rated (80,000-pound gross load limit) trucking highways serving Danville are U.S. Highways 127 and 150. Thirty-one common carrier trucking companies provide interstate and/or intrastate service to the city. The Norfolk Southern Corporation provides main line rail service to the city. The Danville-Boyle County Airport maintains two paved runways of 5,000 and 2,400 feet. The nearest scheduled commercial airline service is available at the Blue Grass Airport near Lexington, 38 miles north of Danville.

Power and Fuel - Kentucky Utilities Company provides electric power to Danville and portions of Boyle County. The major portion of Boyle County is served by Inter-County Rural Electric Cooperative Corporation. Western Kentucky Gas Company provides natural gas service to Danville.

Education - Primary and secondary education is provided to Danville and Boyle County by the Danville Independent School System and the Boyle County School System. The Danville Independent School System is accredited by the Southern Association of Colleges and Schools. The Kentucky School for the Deaf is also located in Danville. Centre College, located in Danville, is an independent, four-year college which confers Bachelor of Arts and Bachelor of Science degrees. The Kentucky College of Business, also located in Danville, confers the Associate in Science degree. Eastern Kentucky University has a satellite campus in Danville. In addition, seven institutions of higher learning are located within 36 miles of Danville. Vocational training is available at Kentucky Tech-Central in Lexington, 35 miles northeast of Danville; the Harrodsburg Area Vocational Education Center, 9 miles north of Danville at Harrodsburg; and the Garrard County Area Vocational Education Center at Lancaster, 12 miles east of Danville.



UNEMPLOYMENT RATES 1994





AVERAGE PLACEMENT WAGES



Denyo Company, Ltd. recently invested \$2.7 million in the purchase of the former Clark Equipment building. The company will manufacture heavy portable generators for hospitals, construction projects, and related industry, and plans to be in full operation by Fall 1995. TRANSPORTATION

Highways

U.S. Highways 127 and 150 are "AAA"-rated (80,000-pound gross load limit) trucking highways serving Danville. U.S. 127 provides Danville with four-lane access to the Blue Grass Parkway, 24 miles to the north. The Blue Grass Parkway is a multi-lane highway which connects with Interstate 65, 67 miles west of Danville.

U.S. 150 provides direct access to Interstate 75, 38 miles southeast of Danville and to U.S. Highway 27, 11 miles southeast. Interstate 75 is also accessible 38 miles east of Danville via U.S. 150 and Kentucky Route 1295 and 52. U.S. 127 continues south to the multi-lane Cumberland Parkway, 51 miles south of Danville.

Kentucky Routes 33 and 34, both "AA"-rated trucking highways (62,000-pound gross load limit), also serve Danville.



The city of Danville is served by a mayor, four city commissioners, and a city manager. The mayor serves a four-year term and the commissioners serve two-year terms. Boyle County is served by a county judge/executive and six magistrates. The county judge/executive and magistrates are elected to four-year terms.

Local Fees and Licenses

The City of Danville levies a business license fee of \$25 annually. An occupational license fee of one percent is levied on wages, salaries and commissions of individuals and on net profits of businesses with a minimum of \$25.

Boyle County levies an occupational license fee of 0.45 of one percent on wages, salaries and commissions of individuals and on net profits of businesses.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

Centre College

Centre College, founded in 1819, is a co-educational, four-year liberal arts college with a heritage of academic excellence. Centre offers majors in 23 programs, as well as a dual degree engineering program (3 years at Centre, two-years at an engineering school leading to a B.S. and M.S.). Centre is accredited by the Southern Association of Colleges and Schools and is the only private college in Kentucky with a Phi Beta Kappa chapter.

Centre College has \$20 million of campus improvements planned. These improvements include; beautification of the College's park-like setting; construction of at least one new residence hall and new Greek houses in addition to the continued renovation of existing student housing facilities; construction of a new student center; renovation of Sutcliffe Hall into a total athletic facility; renovation of the Carnegie Library building; improve playing fields and construction of indoor tennis courts.

Eastern Kentucky University

Eastern Kentucky University's Danville Center, which opened in 1994, greatly improves area residents' access to quality, affordable higher education and expands EKU's ability to meet the needs of the region. Several two-year degrees are offered, and you may also fulfill the general education requirements (freshman and sophomore level) necessary to earn a baccalaureate degree. However, most four-year degree-seeking students must attend classes on the Richmond campus to complete their degrees. Classes offered at the center usually meet once a week for three hours in late afternoon or early evening. The schedule includes both upper division and graduate courses. The Center also is available for community training sessions and workshops.

Kentucky College of Business

Kentucky College of Business is accredited as a junior college of business, and the Danville location is one of the school's six campuses in the state. The college offers six degree programs and six diploma programs in secretarial business management, legal and medical secretary, data processing, and accounting fields. The college confers the Associate in Science degree.

Lindsey Wilson College

Lindsey Wilson College offers an evening degree program in Danville, where one can earn an associate degree in less than two years by attending classes two evenings per week. The program is designed for busy adults, and a counselor is available to provide pre-enrollment counseling, academic guidance, and advice about financial aid, and will arrange transfer credits for college level work completed at another institution.

VOCATIONAL-TECHNICAL TRAINING

Kentucky Tech schools are operated by the Cabinet for Workforce Development and provide secondary (Sec) and postsecondary (P/S) vocational-technical training.

Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies customized assessment in career inventories, interest inventories, pre-hire assessment, psychomotor skills and academic potential. A Career Connections Assessment Center is located at Kentucky Tech-Central, Lexington, Kentucky (606-255-8501).

Tech Prep

Tech Prep is a combined secondary and postsecondary program of studies that leads to an associate degree or diploma in a technical field. Kentucky Tech-Danville School of Health Occupations, offers programs in Tech Prep. Kentucky Tech-Garrard County offers Tech Prep in the areas of automotive technology, carpentry, drafting, electricity, health services and welding. Kentucky Tech-Harrodsburg offers Tech Prep programs in the areas of automotive technology, carpentry, electrical technology, health services and welding.

Adult Education Services

Adult education programs are available to adults who want to develop new skills, or earn a high school equivalency degree. In Danville, adult literacy and adult basic education is provided by the Danville Adult Learning Center, Danville High School, East Lexington Avenue, Danville, Kentucky 40422.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

Danville and Boyle County offer a wide variety of recreational opportunities. Public recreation facilities include three large parks, five mini-parks, nine playgrounds, two tennis courts, three baseball diamonds, four softball fields, four football fields and four soccer fields. The Danville-Boyle County Recreation Department offers year-round programs for all ages. The city sponsors exercise, karate, indoor soccer, and arts and crafts programs. A supervised playground program is available during the summer months, and sports enthusiasts may participate in leagues for basketball, football, baseball, softball, fast-pitch softball, and soccer. The state YMCA also offers a variety of year-round activities. A community theatre is active in Danville, and presents several productions each year. Private recreational facilities include a country club, two golf courses, two swimming pools, four movie theatres, a bowling facility, a roller-skating rink and a racquetball court.

Crawford Springs Park, a small county park two miles from Perryville, offers a nature area, picnic and barbecue equipment, and wildflower and tree identification.

Construction of a new city park is being planned. The park will include the following: a public pool, four baseball fields, four softball field, five tennis courts, a jogging/walking trail, shelters, five basketball courts, five soccer fields, two football fields, playgrounds, restrooms, and concession stands. Also planned is a community park which will include a 6.5 acre lake.

Constitution Square State Historic Site, in Danville, is a reproduction of Kentucky's first courthouse square, including the original 1792 post office which was the first in the west.

The McDowell House is the home in which pioneer surgeon Dr. Ephraim McDowell lived and worked. Now a registered national historic landmark, the house is located adjacent to Constitution Square and is open to the public year-round. The Apothecary Shop next door displays authentic 18th and 19th century pharmaceuticals.

The Centre College campus is the site of a variety of intercollegiate sports activities throughout the fall, winter and spring months. The college's track is available for public use. The Norton Center for the Arts, also located on the Centre campus, offers a variety of cultural and entertainment activities, including art exhibitions, concerts and theatrical performances by national touring companies to the college and the community-at-large.

The Great American Brass Band Festival, held on the campus of Centre College during June, features some of the world's top brass bands. Organized in 1990, the festival is known as "America's greatest band concert in the park" and attracts as many as 40,000 people from as far away as New Orleans, Washington, Seattle and even Europe. Events include traditional marches, New Orleans jazz, ragtime, and classical music on the main stage; hot air balloons, parades, antique bicycles, street musicians and food vendors.

Listed as the "oldest country store in America" in continuous operation by the same family, Penn's Store was established in 1850 and continues to be a "meeting place" for folks from everywhere. Nestled in the unique Knob Region of central Kentucky, Penn's Store provides services to local descendants of pioneering families that settled in the area in the 1700's, as well as newcomers to the area.

Perryville Battlefield State Historic Site near Perryville has a museum and monuments which detail one of the most desperate battles of the Civil War. A re-enactment which draws 40,000 spectators and several hundred re-enactors is staged each year on the weekend closest to October 8, the date of the 1862 battle. A \$2 million federal grant has been awarded to develop a national historic site at Perryville.

Fishing, boating, and water sports are available on **Herrington Lake** in Boyle County. Several marinas are located on the lake, and a resort on Gwinn Island with cabins and campgrounds is a popular recreational area.

Central Kentucky Wildlife Refuge, a 500-acre refuge, located 13 miles from Danville, is a permanent sanctuary for plants and animals native to central Kentucky. The refuge includes six walking trails covering over five miles.
