



MARSHALL COUNTY, KENTUCKY - A RESOURCE PROFILE

Marshall County is located in the Jackson Purchase Region of western Kentucky. The Tennessee River flows along the northern boundary of the county while Kentucky Lake forms the eastern boundary. Benton, the county seat of Marshall County, is located 131 miles northwest of Nashville, Tennessee; 196 miles southeast of St. Louis, Missouri; and 206 miles southwest of Louisville, Kentucky. Calvert City is 12 miles north of Benton and Hardin is 7 miles south of Benton.

Marshall County covers a total land area of 304 square miles. In 1988, Marshall County had an estimated population of 26,700 with 3,670 persons residing in Benton, 2,320 in Calvert City, and 600 in Hardin.


The Economic Framework - The total number of Marshall County residents employed in 1989 averaged 10,647. In 1988, manufacturing firms in the county reported 2,651 employees; wholesale and retail trade provided 1,601 jobs; 924 people were employed in service occupations; state and local government accounted for 1,191 employees; and contract construction firms provided 764 jobs.

Labor Supply - There is a current estimated labor supply of 22,047 persons available for industrial jobs in the labor market area. In addition, from 1990 through 1994, 11,495 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major highways serving Marshall County include Interstate 24, the Purchase Parkway; U.S. Highways 62, 68, and 641; and Kentucky Highway 80. Twenty trucking companies provide interstate and/or intrastate service to Marshall County. Paducah and Louisville Railway provides rail service to Calvert City, while J & J Railroad operates locally in Hardin. The nearest commercial airline service is available at Barkley Regional Airport near Paducah, 34 miles northwest of Benton. The Kentucky Dam Village State Resort Park Airport, 12 miles north of Benton, maintains a 4,000-foot paved runway to accommodate small aircraft. Two public riverports are located within 26 miles of Benton, including the Port of Lyon County and the Paducah-McCracken County Riverport.

Power and Fuel - Electric power is distributed in Benton by the Benton Electric System, in Calvert City by Jackson Purchase Electric Cooperative Corporation and in Hardin by West Kentucky Rural Electric Cooperative Corporation. Natural gas is distributed in Benton by Union Gas Company of Kentucky, in Calvert City by Western Kentucky Gas Company and in Hardin by Hardin Natural Gas System.

Education - The Marshall County School System, which is accredited by the Southern Association of Colleges and Schools, provides primary and secondary education to the county. Seven institutions of higher learning are located within 75 miles of Benton. Vocational training is available locally at the Marshall County Area Vocational Education Center in Benton and at the West Kentucky State Vocational-Technical School, 28 miles northwest of Benton in Paducah.



UNEMPLOYMENT RATES 1989





AVERAGE PLACEMENT WAGES



The focus of the following data is on job placements made by the Paducah local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1989, the local employment office filled 3,017 job openings in various occupational categories. TRANSPORTATION

Highways

Major highways serving Marshall County include Interstate 24, Purchase Parkway, U.S. Highways 62, 68 and 641, plus Kentucky Highway 80.

Interstate 24, a major east-west highway, is routed through northern Marshall County and connects with the Purchase Parkway and U.S. Highways 62, 68 and 641. Interstate 24 also provides access to the Western Kentucky Parkway, 26 miles northeast of Benton.

The Purchase Parkway, a multilane toll road, traverses north and south through Marshall County. Interchanges on the parkway are located at Interstate 24, at U.S. 68 in central Marshall County, and at Benton.

U.S. Highways 62, 68 and 641, plus Kentucky Highway 80 are also major routes to Marshall County. All four highways are "AAA"-rated (80,000-pound gross load limit) trucking highways.



Water

The Tennessee River forms the northern boundary of Marshall County and Kentucky Lake forms the eastern boundary of the county. Two major riverports are located near Marshall County, the Paducah-McCracken County Riverport and the Port of Lyon County.

The Paducah-McCracken Riverport is 25 miles northwest of Benton. The Paducah-McCracken County Riverport Authority operates an ice-free, deep water inland waterways port located at Mile 1 on the Tennessee River, at the confluence of the Ohio and Tennessee Rivers, 48 river miles east of where the Ohio River flows into the Mississippi River, and at the head of the Tennessee-Tombigbee Waterway.

The Port of Lyon county is located 26 miles northeast of Benton. The Port Authority of Lyon County operates a port facility in the Lick Creek embayment on Barkley Lake at Cumberland River Mile 43.6. Kentucky Lake is only ten miles from the Port as the two lakes are joined by a one and three-quarter mile long canal, 300 feet wide. It is the only public port on either Barkley Lake or the adjoining Kentucky Lake, and there is only one lock between the Port and the Tennessee-Tombigbee.

Local fees and Licenses

The City of Benton levies an occupational license tax of one-half of one percent of the gross salaries, wages and commissions of all persons in the city. Annual business licenses are based on the type of businesses, the tax for manufacturing businesses is \$150 for plants with less than 200 employees and \$300 for plants with 200 employees or more.

Calvert City levies annual business license fees ranging from \$5 to \$100 for most businesses.

Marshall County levies a one percent occupational license tax on gross salaries, wages and commissions of individuals and on net profits of businesses.

Marshall County schools also levy a one-half of one percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses. Exempted are nonresidents and certain businesses including public service companies that pay ad valorem taxes, insurance companies, banks, and trust companies.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

Benton, Calvert City, and Hardin each provide city parks with tennis courts, athletic fields, and playgrounds. Benton's park offers a swimming pool and skating facilities. Calvert City's park has a motorcycle race track. Through a Heritage Conservation Recreation Service grant, Calvert city acquired a new football/soccer field and a mini-park which includes a covered bridge, a walkway, and a picnic area. The Joe Creason Community Center is located in Benton. Facilities include meeting rooms, a kitchen, and a multi-purpose basketball court.

Bowling is available at Draffenville, near Benton. Miniature golf is available at Gilbertsville, near Calvert City, and at Aurora, near Hardin. Country clubs with golf courses and swimming pools are located at Benton and Calvert City. Tourist attractions in Marshall County include Forgotten Past, offering a museum, miniature train rides, go-carts, miniature golf, and horseback riding; and Wonder Waters Park, featuring a giant waterslide, bumper boats and other water-related activities.

One of the finest outdoor recreational areas in the eastern United States is located in and around Marshall County. Kentucky Dam Village State Resort Park is located at Gilbertsville, near Calvert City, and Kenlake State Resort Park is located at Aurora, near Hardin. Both parks are situated on Kentucky Lake, which forms the eastern boundary of Marshall County.

Kentucky Dam Village State Resort Park, located near Gilbertsville, is one of the largest and most popular vacation resorts in Kentucky. A modern lodge with 72 rooms, 67 cottages, and a 221-site campground make up the accommodations. The park includes a 4,000-foot lighted airstrip. There is also a dining room overlooking Kentucky Lake, a coffee shop, a snack bar, two gift shops, a meeting room, an activities center, and a recreation room. Recreational activities to choose from include boating and fishing at the largest docking facility in the Kentucky parks system, golf at the 18-hole Village Green Course, fishing, hiking, horseback riding, picknicking, swimming at the lodge pool or off the sand beach, and tennis.

Charm and serenity exemplify Kenlake State Resort Park which is located on Kentucky Lake which is located on Kentucky Lake. The park offers hotel and cottage accommodations and an efficient camping site. Other facilities include a 9-hole golf course, pool and lake swimming, horseback riding, hiking trails, fishing, boating, picknicking, planned recreation, and one of the finest tennis complexes in the area.

COMMUNITY IMPROVEMENTS

Recent

Calvert City re-certified as a Kentucky Certified City in 1989 and is distinguished as a gold award winner recognizing six consecutive years of certification. Re-certification is based on achievement in the following areas: existing industry assistance, small business assistance, educational resources, and community development factors of health care, public safety, arts and culture, recreation, governmental awareness and resources. The Certified Cities Program is sponsored by the Kentucky Chamber of Commerce.

Several new companies recently commenced operations in Marshall County including Sun Up Foods, Inc., which produces frozen juice concentrate; Guard Screen, Inc., which manufactures vandal-resistant window screens; and 372 Cox Group, which produces aircraft and automotive tools and dies, and prototype parts. These new firms represented an investment of \$5.4 million and created 65 new jobs.

Construction of two new speculation buildings at the Benton Industrial Park is complete. The 10,000-square-foot buildings are located on U.S. 641 bypass with full access to utilities.
