

DANVILLE, KENTUCKY – A RESOURCE PROFILE

Danville, the county seat of Boyle County, is located in the gently rolling landscape of central Kentucky's Blue Grass Region. The city's central location and excellent transportation network contribute to its growth as a manufacturing and distribution center. Danville is located 35 miles south of Lexington, Kentucky; 84 miles southeast of Louisville, Kentucky; 162 miles north of Knoxville, Tennessee; and 119 miles south of Cincinnati, Ohio.

Boyle County covers a land area of 182 square miles and had an estimated 1998 population of 27,186 persons. Danville had an estimated population of 16,470 in 1998.


The Economic Framework – Boyle County firms employed 14,533 people in 1997. Contract construction firms provided 392 jobs; manufacturing firms in the county reported 3,777 employees; wholesale and retail trade provided 4,198 jobs; 3,579 were employed in the service industry; and state and local government accounted for 1,772 jobs.

Labor Supply – There is a current estimated labor supply of 17,562 persons available for industrial jobs in the labor market area. In addition, from 1999 through 2003, approximately 9,169 young persons in the labor market area will become 18 years of age and potentially available for industrial jobs.

Transportation – Major AAA-rated (80,000-pound gross load limit) trucking highways serving Danville are U.S. Highways 127 and 150. Twenty-eight common carrier trucking companies provide interstate and/or intrastate service to the city. The Norfolk Southern Corporation provides main line rail service to the city. The Danville-Boyle County Airport maintains two paved runways of 5,000 and 2,400 feet. The nearest scheduled commercial airline service is available at Blue Grass Airport near Lexington, 41 miles north of Danville.

Power and Fuel – Kentucky Utilities Company provides electric power to Danville and portions of Boyle County. The major portion of Boyle County is served by Inter-County Energy Cooperative Corporation. Western Kentucky Gas Company provides natural gas service to Danville.

Education – The Danville Independent School System and the Boyle County School System provide primary and secondary education to the residents of Danville and Boyle County. Centre College, in Danville, is an independent, four-year college which confers Bachelor of Arts and Bachelor of Science degrees. The National Business College, also in Danville, confers the Associate of Science degree. Eastern Kentucky University has a satellite campus in Danville. Fifteen other colleges and universities are within 60 miles of Danville. Area technology centers (ATC's) in Harrodsburg, 11 miles north of Danville, and in Lancaster, 17 miles east, provide secondary technical training. The Central Kentucky Technical College Danville Campus provides postsecondary technical training.



Selected Components of Nonagricultural Employment by Place of Work, 1997





TRANSPORTATION

Highways

U.S. Highways 127 and 150 are AAA-rated (80,000-pound gross load limit) trucking highways serving Danville. U.S. 127 provides Danville with four-lane access to the Blue Grass Parkway, 24 miles to the north. The Blue Grass Parkway is a multi-lane highway which connects with Interstate 65, 67 miles west of Danville.

U.S. 150 provides direct access to Interstate 75, 38 miles southeast of Danville and to U.S. Highway 27, 11 miles southeast. Interstate 75 is also accessible 38 miles east of Danville via U.S. 150 and Kentucky Route 1295 and 52. U.S. 127 South provides access to the multi-lane Cumberland Parkway, 51 miles south of Danville.

Kentucky Routes 33 and 34, both AA-rated trucking highways (62,000-pound gross load limit) also serve Danville.

Highway Miles from Danville, Kentucky to Selected Market Centers



The city of Danville is served by a mayor, four city commissioners, and a city manager. The mayor serves a four-year term and the commissioners serve two-year terms. Boyle County is served by a county judge/executive and six magistrates. The county judge/executive and magistrates are elected to four-year terms.

Planning and Zoning

Local Fees and Licenses

The City of Danville levies a business license fee of \$25 annually. An occupational license fee of one percent is levied on wages, salaries, and commissions of individuals and on net profits of businesses with a minimum of \$25.

Boyle County levies an occupational license fee of 0.45 of one percent on wages, salaries, and commissions of individuals and on net profits of businesses.

Sales and Use Tax

A state sales and use tax is levied at the rate of 6.0% on the purchase or lease price of taxable goods and on utility services. Local sales taxes are not levied in Kentucky.

State and Local Property Taxes

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside the city limits may also be subject to city property taxes. Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value. Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Customized Training

The Kentucky Tech system, through its training and development coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Businesses wanting to establish a customized training program should contact a Training and Development Coordinator at the Central Kentucky Technical College Danville Campus.

Assessment Services

Kentucky Tech Career Connections offers business, education, and government agencies testing packages for evaluating job applicants, selecting employees for promotional consideration and developing training programs within the organization. The Career Connections Assessment Center serving the Danville area is located at the Central Kentucky Technical College Danville Campus.

Adult Education Services

Adult education programs are available to adults who want to develop new academic skills, improve basic skills, or earn a high school equivalency diploma. In the Danville area, adult basic education and adult literacy classes are administered through Danville/Boyle County Literacy.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation (BSSC) was established in 1984 by the General Assembly of the Commonwealth of Kentucky as an independent, de jure corporation to stimulate economic development through customized business and industry specific skills training programs. The BSSC works with business and industry and Kentucky's educational institutions to establish programs of skills training. The BSSC is attached to the

Cabinet for Economic Development for administrative purposes, in recognition of the relationship between economic development and skills training efforts.

The BSSC is comprised of two economic development tools, matching grants and the newly authorized Skills Training Investment Credit Act. The BSSC grant program is available to new, expanding and existing business and industry. Eligible training activities include pre-employment skills training and assessment; entry level, skills upgrade and occupational upgrade training; train-the-trainer travel; and capacity-building. The Skills Training Investment Credit Act provides tax credits to existing businesses for skills upgrade training.

RECREATION

Danville and Boyle County offer a wide variety of recreational opportunities. Public recreation facilities include three neighborhood parks and one regional park, five pocket parks, twelve playgrounds, twelve public tennis courts, seven baseball diamonds, six softball fields, two football fields and eight soccer fields. The Danville-Boyle County Recreation Department offers year-round programs for all ages. The city sponsors exercise, karate, indoor soccer, and arts and crafts programs. A supervised playground program is available during the summer months, and sports enthusiasts may participate in leagues for basketball, football, baseball, softball, fast-pitch softball, and soccer. Through the cooperative efforts of city and county government, construction has begun on the regional Millenium Park. The YMCA offers a variety of year-round activities. A community theatre presents several productions each year. Private recreational facilities include a country club, two golf courses, three swimming pools, four movie theatres, a bowling facility, a roller-skating rink and a racquetball court.

Constitution Square State Historic Site, in Danville, is a reproduction of Kentucky's first courthouse square, including the original 1792 post office which was the first in the west. The McDowell House and Apothecary Shop was the home of pioneer surgeon Dr. Ephraim McDowell (1771-1830) where he performed his world-famous surgery in 1809. The home features a display of pharmaceutical relics and a gift shop and is open to the public year-round.

The Centre College campus is the site of a variety of intercollegiate sports activities throughout the fall, winter and spring months. The college's track is available for public use. The Norton Center for the Arts, on Centre's campus offers a variety of cultural and entertainment activities including art exhibitions, concerts and theatrical performances.

The Great American Brass Band Festival, held on the campus of Centre College during June, features some of the world's top brass bands. The festival is known as "America's greatest band concert in the park" and attracts thousands of visitors annually. Events include traditional marches, New Orleans jazz, ragtime, and classical music on the main stage; hot air balloons, parade, antique bicycles, street musicians and food vendors.

Penn's Store, listed as the "oldest country store in America" in continuous operation by the same family, was established in 1850. Perryville Battlefield State Historic Site near Perryville has a museum and monuments which detail one of the most desperate battles of the Civil War. A re-enactment is staged each year on the weekend closest to October 8, the date of the 1862 battle.

Fishing, boating, and water sports are available on Herrington Lake in Boyle County. Facilities at the lake include several marinas, and a resort on Gwinn Island with cabins and campgrounds. Central Kentucky Wildlife Refuge, a 500-acre refuge, 13 miles from Danville, is a permanent sanctuary for plants and animals native to central Kentucky. The refuge includes six walking trails covering over five miles.

APPENDIX - DEFINITIONS

Geographic definition of the labor market area

A county's labor market area is defined as the base county, adjacent counties, and any other major commuting counties. Adjacency is used to define the labor market area primarily because of the small size of Kentucky's counties. The major commuting counties are defined from the point of view of the base county. Major commuting counties are those counties that comprise 90% of the base county's total commuters. The source of the commuting patterns is the 1990 journey-to-work data available from the U.S. Department of Commerce, Bureau of Economic Analysis.

Example - Logan County

To determine the labor market area for Logan County the following steps are taken. First, the counties with workers commuting into Logan county are listed in ascending order (see the table below). The cumulative percent is calculated. Next, all counties that comprise up to 90% of the commuters are included in the labor market area (actually the cut-off will be the county that breaks the 90% threshold – Montgomery County, TN at 92.6% in this case). Although Robertson is not a major commuter county, it is included since it is adjacent. The Logan County labor market is then comprised of the seven bold-faced counties in the table below.

Potential Labor Supply

The potential labor supply is an estimate of those persons not classified as in the labor force (not employed and not unemployed), but who want a job. The assumption is that people not in the labor force at the local level would like a job at the same rate as the nation. The U.S. Department of Labor, Bureau of Labor Statistics provides national, yearly estimates of the percent of the people not in the labor force who want a job. This percent is applied to the county-level number of people not in the labor force.

Underemployed

Wholesale/retail trade and non-professional services have historically paid low wages. The assumption is that workers in these industries would take higher paying jobs if they were available. Non-professional services excludes Miscellaneous Repair Services (SIC 7600), Health Services (SIC 8000), Legal Services (SIC 8100), and Engineering and Management Services (SIC 8700).

Total Available Labor

Total available labor is the sum of the number of unemployed, potential labor supply, and underemployed. Please note that the number of unemployed is the only generally accepted measure of labor availability. The other concepts are weaker measures and should be used with caution.
