



# MARSHALL COUNTY, KENTUCKY - A RESOURCE PROFILE

Marshall County is located in the Jackson Purchase Region of western Kentucky. The Tennessee River flows along the northern boundary of the county while Kentucky Lake forms the eastern boundary. Benton, the county seat of Marshall County, is located 124 miles northwest of Nashville, Tennessee; 185 miles southeast of St. Louis, Missouri; and 200 miles southwest of Louisville, Kentucky. Calvert City is 15 miles north of Benton and Hardin is 7 miles south of Benton.

Marshall County covers a total land area of 304 square miles. In 1990, Marshall County had a population of 27,205 with 3,899 person residing in Benton, 2,531 in Calvert City, and 595 in Hardin.


The Economic Framework - The total number of Marshall County residents employed in 1991 averaged 10,617. In 1990, manufacturing firms in the county reported 2,847 employees; wholesale and retail trade provided 1,658 jobs; 1,118 people were employed in service occupations; state and local government accounted for 1,265 employees; and contract construction firms provided 791 jobs.

Labor Supply - There is a current estimated labor supply of 22,160 persons available for industrial jobs in the labor market area. In addition, from 1992 through 1996, 11,934 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major highways serving Marshall County include Interstate 24, the Purchase Parkway; U.S. Highways 62, 68, and 641; and Kentucky Highway 80. Twenty-three trucking companies provide interstate and/or intrastate service to Marshall County. Paducah and Louisville Railway provides rail service to Calvert City, while J & J Railroad operates locally in Hardin. The nearest commercial airline service is available at Barkley Regional Airport near Paducah, 34 miles northwest of Benton. The Kentucky Dam Village State Resort Park Airport, 12 miles north of Benton, maintains a 4,000-foot paved runway to accommodate small aircraft. Two public riverports are located within 26 miles of Benton; the Port of Lyon County and the Paducah-McCracken County Riverport.

Power and Fuel - Electric power is distributed in Benton by the Benton Electric System, in Calvert City by Jackson Purchase Electric Cooperative Corporation and in Hardin by West Kentucky Rural Electric Cooperative Corporation. Natural gas is distributed in Benton by Union Gas Company of Kentucky, in Calvert City by Western Kentucky Gas Company and in Hardin by Hardin Natural Gas System.

Education - The Marshall County School System, which is accredited by the Southern Association of Colleges and Schools, provides primary and secondary education to the county. Seven institutions of higher learning are located within 76 miles of Benton. Vocational training is available locally at the Marshall County Area Vocational Education Center in Benton and at the West Kentucky State Vocational-Technical School, 26 miles northwest of Benton in Paducah.



#### LABOR MARKET STATISTICS

The Marshall County Labor Market Area includes Marshall County and the adjoining Kentucky counties of Calloway, Graves, Livingston, Lyon, McCracken, and Trigg.



UNEMPLOYMENT RATES 1991





# AVERAGE PLACEMENT WAGES



The focus of the following data is on job placements made by the Mayfield local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1990, the local employment office filled 2,823 job openings in various occupational categories. # RECENT INDUSTRIAL DEVELOPMENTS

Degussa Corporation and Nippon Shokubai Company Ltd. of Osaka, Japan have joined and are constructing a \$20 million catalyst plant at Calvert City, International Catalyst Technology, Inc. The company will employ approximately 75 persons and will produce material for catalytic converters. It will be constructed next to the existing Degussa catalyst facility.

Guard Screen Company, Inc. has constructed a 6,000-foot addition that will double the plants manufacturing space. The \$250,000 expansion will increase employment at the facility.

# TRANSPORTATION

# Highways

Major highways serving Marshall County include Interstate 24, Purchase Parkway, U.S. Highways 62, 68 and 641, and Kentucky Highway 80.

Interstate 24, a major east-west highway, is routed through northern Marshall County and connects with the Purchase Parkway and U.S. Highways 62, 68 and 641. Interstate 24 also provides access to the Western Kentucky Parkway, 26 miles northeast of Benton.

The Purchase Parkway, a multi-lane toll road, traverses north and south through Marshall County. Interchanges on the parkway are located at Interstate 24, at U.S. 68 in central Marshall County, and at Benton. It is projected that in July 1992, the Parkway will no longer be a toll road.

U.S. Highways 62, 68 and 641, and Kentucky Highway 80 are also major routes in Marshall County. All four highways are "AAA"-rated (80,000-pound gross load limit) trucking highways.



Scheduled commercial airline service is also available at Evansville Regional Airport near Evansville, Indiana, 116 miles northeast of Benton; and at the Nashville Metropolitan Airport near Nashville, Tennessee, 124 miles southeast of Benton.

#### Water

The Tennessee River forms the northern boundary of Marshall County and Kentucky Lake forms the eastern boundary of the county. Two major riverports are located near Marshall County, the Paducah-McCracken County Riverport and the Port of Lyon County.

The Paducah-McCracken Riverport is 26 miles northwest of Benton. The Paducah-McCracken County Riverport Authority operates an ice-free, deep water inland waterways port located at Mile 1 on the Tennessee River, at the confluence of the Ohio and Tennessee Rivers, 48 river miles east of where the Ohio River flows into the Mississippi River, and at the head of the Tennessee-Tombigbee Waterway.

The Port of Lyon county is located 26 miles northeast of Benton. The Port Authority of Lyon County operates a port facility in the Lick Creek embayment on Barkley Lake at Cumberland River Mile 43.6. Kentucky Lake is only ten miles from the Port as the two lakes are joined by a one and three-quarter mile long canal, 300 feet wide. It is the only public port on either Barkley Lake or the adjoining Kentucky Lake, and there is only one lock between the Port and the Tennessee-Tombigbee.

# Electricity

# LOCAL GOVERNMENT

### Structure

The Cities of Benton, Calvert City and Hardin are each governed by a mayor and six council members. The mayors are elected to four-year terms while council members each serve two-year terms. Marshall County is governed by a county judge/executive and three magistrates. Each county official is elected to four-year term.

## Local Fees and Licenses

The City of Benton levies an occupational license tax of one-half of one percent of the gross salaries, wages and commissions of all persons in the city. Annual business licenses are based on the type of businesses. The tax for manufacturing businesses is \$150 for plants with 25+ employees and \$100 for plants with less than 25 employees.

Calvert City levies annual business license fees ranging from \$5 to \$100 for most businesses.

Marshall County levies a one percent occupational license tax on gross salaries, wages and commissions of individuals and on net profits of businesses.

Marshall County schools also levy a one-half of one percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses. Exempted are nonresidents and certain businesses including public service companies that pay ad valorem taxes, insurance companies, banks, and trust companies.

# PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. A 15% reduction is automatically granted for accounts receivable.

# **Vocational Training**

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

# Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

# RECREATION

### Local

Benton, Calvert City, and Hardin each provide city parks with tennis courts, athletic fields, and playgrounds. Benton's park offers a swimming pool and skating facilities. Through a Heritage Conservation Recreation Service grant, Calvert City has a football/soccer field and a mini-park which includes a covered bridge, a walkway, and a picnic area. The Joe Creason Community Center is located in Benton. Facilities include meeting rooms, a kitchen, and a multi-purpose basketball court.

Bowling is available at Draffenville, near Benton. Miniature golf is available at Gilbertsville, near Calvert City, and at Aurora, near Hardin. Country clubs with golf courses and swimming pools are located at Benton and Calvert City. Tourist attractions in Marshall County include Forgotten Past, offering a museum, miniature train rides, go-carts, miniature golf, and horseback riding; and Wonder Waters Park, featuring a giant waterslide, bumper boats and other water-related activities.

Kentucky Dam Village State Park, near Gilbertsville, is one of the largest and most popular vacation resorts in Kentucky. A modern lodge with 72 rooms, six different cottage types, and a 225-site campground make up the accommodations. There is also a dining room overlooking Kentucky Lake, a coffee shop, a snack bar, two gift shops, a meeting room, an activities center, and a recreation room. Recreational activities to choose from include boating and fishing at the largest docking facility in the Kentucky parks system, golf at the 18-hole Village Green Course, proshop, fishing, hiking, horseback riding, picnicking, swimming at the lodge pool or off the sand beach, and tennis.

Charm and serenity exemplify Kenlake State Resort Park which is located on Kentucky Lake near Aurora. The park offers hotel and cottage accommodations and an efficient camping site. Other facilities include a nine-hole golf course, pool and lake swimming, horseback riding, hiking trails, fishing, boating, picnicking, planned recreation, and one of the finest tennis complexes in the area.

#### COMMUNITY IMPROVEMENTS

#### Recent

Calvert City re-certified as a "Kentucky Certified City" in 1991, and is distinguished as a gold award winner recognizing eight consecutive years of certification. Re-certification is based on achievement in the following areas: existing industry assistance, small business assistance, educational resources, and community development factors of health care, public safety, arts and culture, recreation, governmental awareness and resources. The Certified Cities Program is sponsored by the Kentucky Chamber of Commerce.

The Marshall County School System has completed construction of an adult education center. This \$170,000 facility contains two large classrooms, and office and storage space.

Guard Screen Company, Inc. has constructed a 6,000-foot addition that will double the plants manufacturing space. The \$250,000 expansion will increase employment at the facility.

The City of Benton, in June 1992, refurbished the swimming pool at the city park. Total cost of this project was \$100,000.

A 85-bed detention center and a new sheriff complex is being planned in Marshall County. Approximate cost of the project is \$3 million.

# **Under Way**

Degussa Corporation and Nippon Shokubai Company Ltd. of Osaka, Japan have joined and are constructing a \$20 million catalyst plant at Calvert City, International Catalyst Technology, Inc. The company will employ approximately 75 persons and will produce material for catalytic converters. It will be constructed next to the existing Degussa catalyst facility.
