

PIKE COUNTY, KENTUCKY – A RESOURCE PROFILE

Pike County, located at the easternmost tip of Kentucky in the Eastern Kentucky Coal Field Region, covers 788 square miles of land area. Pike County is both Kentucky's largest county and the nation's largest underground bituminous coal-producing county. The estimated population of Pike County in 1998 was 72,121.

Pikeville, the county seat, is located along the Levisa Fork of the Big Sandy River. The city had an estimated population of 6,243 in 1998. Pikeville is located 142 miles southeast of Lexington, Kentucky; 218 miles southeast of Cincinnati, Ohio; and 197 miles northeast of Knoxville, Tennessee.

Elkhorn City, 23 miles southeast of Pikeville on the Kentucky-Virginia border, had an estimated population of 1,011 persons in 1998.

The Economic Framework – Pike County firms employed 23,784 people in 1997. Contract construction firms provided 649 jobs; mining and quarrying firms in the county employed 4,977; manufacturing firms in the county reported 651 employees; wholesale and retail trade provided 6,641 jobs; 5,149 were employed in the service industry; and state and local government accounted for 3,315 jobs.


Labor Supply – There is a current estimated labor supply of 41,961 persons available for industrial jobs in the labor market area. In addition, from 1999 to 2003, approximately 26,606 young persons in the labor market area will become 18 years of age and potentially available for industrial jobs.

Transportation – U.S. Highways 23, 119, and 460, and Kentucky 80 are AAA-rated trucking highways serving Pikeville. The Mountain Parkway, a multi-lane highway, is accessible 49 miles northwest of Pikeville. Thirteen trucking companies provide interstate and/or intrastate service to Pike County. CSX Transportation provides main line rail service to Pike County. The nearest commercial airport is located at Huntington, West Virginia, 93 miles north of Pikeville. The Pike County Regional Airport-Hatcher Field maintains a 3,600-foot and a 5,000-foot paved runway.

Power and Fuel – American Electric Power provides electric power throughout Pike County. Natural gas service is provided to Pikeville by the City of Pikeville. In addition, seven privately owned gas companies provide natural gas service at wholesale rates to Pike County.

Education – The Pikeville Independent School System and the Pike County School System provide primary and secondary education in Pike County. Two private elementary schools also operate in Pike County. Pikeville College is a local four-year, independent, liberal arts college affiliated with the Presbyterian Church. Prestonsburg Community College operates a branch campus in Pikeville. Five other institutions of higher learning are located within 60 miles of Pikeville.

Four area technology centers (ATC) providing secondary technical training are in Pike County. The nearest technical college providing postsecondary technical training is the Mayo Technical College in Paintsville, 28 miles from Pikeville. Pikeville Technical College is scheduled to open in January, 2000.

Work Force Commuting Patterns (1990)






Selected Components of Nonagricultural Employment by Place of Work, 1997

TRANSPORTATION

Highways

Pike County and Pikeville are served by an excellent transportation network including AAA-rated (80,000-pound gross load limit) U.S. Highways 23 and 119. U.S. 460 and Kentucky Route 80 are AAA-rated west of Pikeville and AA-rated (62,000-pound gross load limit) east of the city. The Mountain Parkway, a multi-lane limited access highway, is accessible 49 miles northwest of Pikeville, and provides easy access to Interstate 64, 125 miles northwest of Pikeville. Elkhorn City is located 24 miles southeast of Pikeville via Kentucky Route 80.

Construction is underway to convert U.S. 119 between Pikeville and Belfry, Kentucky (near the West Virginia border) to four lanes. The four-laning of U.S. Highway 23 from southern Pike county to the Virginia state line is scheduled for completion by October, 1999. Work is also underway to convert U.S. 460 to four lanes from U.S. 23 near Pikeville to the Virginia state line near Grundy. Completion is projected for 2001.



LOCAL GOVERNMENT

Structure

Pikeville is governed by a mayor, four commissioners, and a full-time city manager. The mayor is elected to a four-year term, while the commissioners each serve two-year terms. Elkhorn City is governed by a mayor and six council members. The mayor is elected to a four-year term, while the council members each serve two-year terms. Pike County is governed by a county judge/executive and six magistrates. Each county official serves a four-year term.

Planning and Zoning

Local Fees and Licenses

The City of Pikeville levies a two percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses. The City of Pikeville also levies an annual business license fee on most businesses.

Elkhorn City levies a one percent occupational license tax on wages, salaries, and commissions of individuals. The city also levies a business license fee on businesses, occupations, and professions in the city. These fees range from \$25 to \$150 annually for most businesses. Elkhorn City also levies a \$50 per year loading and unloading fee.

Sales and Use Tax

A state sales and use tax is levied at the rate of 6.0% on the purchase or lease price of taxable goods and on utility services. Local sales taxes are not levied in Kentucky.

State and Local Property Taxes

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside the city limits may also be subject to city property taxes. Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value. Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Pikeville College School of Osteopathic Medicine

The Pikeville College School of Osteopathic Medicine (PCSOM) is the 19th and newest school of osteopathic medicine in the country. PCSOM offers a four-year program that results in the degree of Doctor of Osteopathic Medicine (DO). Osteopathic medicine emphasizes the inter-relationship of the body's nerves, muscles, bones and organs. The osteopathic philosophy of treating the whole person is applied to the prevention, diagnosis, and treatment of illness, disease, and injury. The emphasis is on training physicians as primary care physicians. The curriculum also emphasizes preventive medicine and community and behavioral medicine. Customized Training

The Kentucky Tech system, through its training and development coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Businesses wanting to establish a customized training program should contact a Training and Development Coordinator at the Mayo Technical College in Prestonsburg.

Assessment Services

Kentucky Tech Career Connections offers business, education, and government agencies testing packages for evaluating job applicants, selecting employees for promotional consideration and developing training programs within the organization. The Career Connections Assessment Center serving the Pike County area is located at the Mayo Technical College in Prestonsburg.

Adult Education Services

Adult education programs are available to adults who want to develop new academic skills, improve basic skills, or earn a high school equivalency diploma. In the Pike County area, adult basic education and adult literacy classes are administered by the Pike County Board of Education.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation (BSSC) was established in 1984 by the General Assembly of the Commonwealth of Kentucky as an independent, de jure corporation to stimulate economic development through customized business and industry specific skills training programs. The BSSC works with business and industry and Kentucky's educational institutions to establish programs of skills training. The BSSC is attached to the Cabinet for Economic Development for administrative purposes, in recognition of the relationship between economic development and skills training efforts.

The BSSC is comprised of two economic development tools, matching grants and the newly authorized Skills Training Investment Credit Act. The BSSC grant program is available to new, expanding and existing business and industry. Eligible training activities include pre-employment skills training and assessment; entry level, skills upgrade and occupational upgrade training; train-the-trainer travel; and capacity-building. The Skills Training Investment Credit Act provides tax credits to existing businesses for skills upgrade training.

RECREATION

Pike County is in the center of Kentucky's mountain vacationland and is surrounded by some of the most majestic scenery in the eastern United States.

There are over 20 public parks in the county, providing several baseball, softball and football fields, tennis courts, three swimming pools, walking/running tracks and playgrounds.

An 18-hole public golf course is available. There are also two private country clubs with golf courses and swimming pools. There are three bowling alleys and a 10-screen movie theater.

The Pikeville Area Family YMCA's 32,000 square-foot facility offers a wide array of recreational activities, as well as YMCA programs such as softball and soccer.

A skate park for in-line skating, skateboards and bikes, is near the YMCA and Bob Amos Park.

The Augusta Dils York "Creekmore" Mansion, located on a hill overlooking downtown Pikeville, was home to Augusta Dils York, a prominent woman of Pikeville. This circa 1912 mansion features period furniture, antiques, china, and many other historic artifacts. Tours are offered by appointment.

Annual events in Pike County include Hillbilly Days, an outdoor festival to benefit Shriners Hospital for Children, held in Pikeville. Summerfest is Pikeville's July 4th celebration. Coal Digger Days is hosted by Hardy, Kentucky. Elkhorn City holds the Apple Blossom Festival in May, a 4th of July celebration, and Octoberfest.

Pike County is home of the infamous Hatfield-McCoy Feud. The county has developed some sites for the Hatfield-McCoy Feud Tour, and is working to develop more sites in the county.

U.S. 23 through Pike County is the "Country Music Highway." The Pike County section is named for Pike County native Patty Loveless.

Fishtrap Lake, seven miles southeast of Pikeville, contains 1,131 acres of excellent boating and fishing. The lake extends about 18 1/2 miles up the Levisa Fork of the Big Sandy River. A planning study is underway to develop a hiking-biking-equestrian trail around Fishtrap Lake.

Breaks Interstate Park, near Elkhorn City on the Kentucky-Virginia border, is a unique park sponsored by Kentucky and Virginia which is situated on the rim of the largest river canyon east of the Mississippi. The canyon is a five-mile cut with 1,600-foot palisades on either side. Sometimes called the "Grand Canyon of the South" this park offers 4,600 acres of breathtaking scenery. The "Breaks" is a full-facility resort park with a 36-room lodge, cottages, a restaurant, a swimming pool, camping facilities, fishing, whitewater rafting, and a visitors center. Numerous special events are held at the park throughout the year.

Jenny Wiley State Resort Park, 29 miles northwest of Pikeville near Prestonsburg, takes full advantage of its picturesque highland setting. The 1,700-acre park offers facilities and activities such as a 49-room lodge, a dining room, a gift shop, 17 cottages, a lodge pool, sky lift, recreation rooms, campsites, picnic areas, planned recreation, playground, golf, hiking, horseback riding, miniature golf, shuffleboard, fishing, and fishing boat and pedal boat rentals. Also located at the park is Jenny Wiley Summer Music Theatre, which features four outdoor productions including Broadway musicals and the "Jenny Wiley Story".

APPENDIX - DEFINITIONS

Geographic definition of the labor market area

A county's labor market area is defined as the base county, adjacent counties, and any other major commuting counties. Adjacency is used to define the labor market area primarily because of the small size of Kentucky's counties. The major commuting counties are defined from the point of view of the base county. Major commuting counties are those counties that comprise 90% of the base county's total commuters. The source of the commuting patterns is the 1990 journey-to-work data available from the U.S. Department of Commerce, Bureau of Economic Analysis.

Example - Logan County

To determine the labor market area for Logan County the following steps are taken. First, the counties with workers commuting into Logan county are listed in ascending order (see the table below). The cumulative percent is calculated. Next, all counties that comprise up to 90% of the commuters are included in the labor market area (actually the cut-off will be the county that breaks the 90% threshold – Montgomery County, TN at 92.6% in this case). Although Robertson is not a major commuter county, it is included since it is adjacent. The Logan County labor market is then comprised of the seven bold-faced counties in the table below.

Potential Labor Supply

The potential labor supply is an estimate of those persons not classified as in the labor force (not employed and not unemployed), but who want a job. The assumption is that people not in the labor force at the local level would like a job at the same rate as the nation. The U.S. Department of Labor, Bureau of Labor Statistics provides national, yearly estimates of the percent of the people not in the labor force who want a job. This percent is applied to the county-level number of people not in the labor force.

Underemployed

Wholesale/retail trade and non-professional services have historically paid low wages. The assumption is that workers in these industries would take higher paying jobs if they were available. Non-professional services excludes Miscellaneous Repair Services (SIC 7600), Health Services (SIC 8000), Legal Services (SIC 8100), and Engineering and Management Services (SIC 8700).

Total Available Labor

Total available labor is the sum of the number of unemployed, potential labor supply, and underemployed. Please note that the number of unemployed is the only generally accepted measure of labor availability. The other concepts are weaker measures and should be used with caution.
