





#### MURRAY - A RESOURCE PROFILE

Murray, Kentucky, home of Murray State University is a community of 14,248 residents in western Kentucky's Jackson Purchase region. Serving as the county seat of Calloway County, Murray is approximately 20 miles west of Kentucky Lake - the state's largest lake-and its multitude of nearby recreation areas. Calloway County, bordered by Kentucky Lake to the east, Marshall County on the north, Graves County on the west, and the Tennessee state line to the south, has a land area of 384 square miles. The 1980 census showed that there were 30,031 persons living in the county.

Murray is in close proximity to interstate highway and parkway systems, and is only 120 miles northwest of Nashville, Tennessee, and 228 miles southwest of Louisville, Kentucky.

## The Economic Framework

Total employment in Calloway County in 1981 averaged 11,626 with 11,076 employed in nonagricultural jobs. Manufacturing provided 1,297 jobs; wholesale and retail trade provided 2,103 jobs; and state and local government provided 2,798 jobs. Manufacturing employment is greatest in the miscellaneous manufacturing and the food and kindred products fields.

Per capita income in the county in 1980 was \$6,770. Between 1976 and 1980 per capita income increased by 48.5 percent.

Murray is the hub of a labor market area which includes Calloway and its three adjoining counties. Area employment in 1981 averaged 36,700 with 34,583 employed in nonagricultural jobs. Manufacturing provided 7,933 jobs; wholesale and retail trade provided 5,726 jobs; and state and local government provided 5,488 jobs.

## Resources for Growth

- 1. There is a current estimated labor supply of 9,505 men and 7,128 women available for industrial jobs in the labor market area. In addition, 4,483 young men and 4,195 young women will become 18 years of age, and potentially available for work, before 1986.
- 2. Local transportation capability is excellent. The Louisville and Nashville Railroad serves Murray on its line between Paducah, Kentucky, and Bruceton, Tennessee. The Purchase Parkway is accessible 19 miles north of Murray at Benton, Kentucky, and provides multilane transportation capability from its intersection with Interstate 24, 27 miles north of Murray, southwest to the Kentucky-Tennessee state line at Fulton, Kentucky. Direct highway access to Murray is provided by U. S. Highway 641 and Kentucky highways 94 and 121. Four trucking companies provide both interstate and intrastate service to Murray; four others provide interstate service only. The Murray-Calloway County Airport, five miles northwest of Murray, provides scheduled commuter air carrier service. Other major commercial airlines provide service to Cape Girardeau Municipal Airport at Cape Girardeau, Missouri, 100 miles northwest of Murray, and to Nashville Metropolitan Air-

port at Nashville, Tennessee, 126 miles southeast of Murray. Privately owned port facilities are located on Kentucky Lake, 12 miles from Murray.

- 3. Tennessee Valley Authority provides electric power to Murray and Calloway County through the Murray Electric System and the West Kentucky Rural Electric Cooperative Corporation. Natural gas is supplied by Texas Gas Transmission Corporation through Murray Natural Gas. There are four suppliers of distillate fuel oil and one supplier of propane in the Murray area.
- 4. Education is an important growth asset for Murray. Both the Murray Independent and the Calloway County school systems are accredited by the Southern Association of Colleges and Schools.

Murray State University is a state-supported institution of higher education, offering undergraduate, graduate, and professional programs in the fields of business and public affairs, creative expression, environmental sciences, human development and learning, humanistic studies, and industry and technology. Four other institutions of higher learning are located within 60 miles of Murray.

Vocational and technical training in 28 course areas is offered at the West Kentucky State Vocational-Technical School at Paducah, 46 miles northwest of Murray. The Murray Vocational Education Center offers vocational training in eight areas.

#### THE LABOR MARKET AREA

The Murray Labor Market Area includes Calloway County and the adjoining Kentucky counties of Graves, Marshall and Trigg.



Occupational wage rates for specific industries are usually not available to most government agencies, and wage data furnished to state employment agencies by individual industrial employers are protected from disclosure by federal law. The most reliable up-to-date wage information can be obtained by direct contact with local employers.

Associated Industries of Kentucky, a voluntary organization of Kentucky businesses, regularly collects occupational wage rates and fringe benefits data from participating member firms. Data are compiled for over 127 clearly defined office, production, and service occupations. Tabulations are published for nine geographical areas of Kentucky, as shown on the map below. It should be noted that the data may be weighted by the preponderance of firms in the larger cities and may be somewhat higher than the rates paid in the smaller communities. Data from these tabulations are available, upon request, from the Kentucky Department of Economic Development, Frankfort, Kentucky 40601.

## Highways

Murray is served directly by U. S. Highway 641 and by Kentucky highways 94 and 121. Access to the Purchase Parkway, a multilane toll road, is available 19 miles north of Murray at Benton via U. S. Highway 641, and 23 miles northwest of Murray at Mayfield via Kentucky Highway 121. U. S. 641 and Kentucky 121 to Mayfield are "AAA" rated, 80,000-pound gross load limit highways.

The Purchase Parkway provides access to Interstate 24, a major route connecting Interstate 57 in Illinois with Interstate 59 at Chattanooga, Tennessee. Interstate 24 is 27 miles north of Murray via U. S. Highway 641 and the Purchase Parkway.

A project to widen U. S. Highway 641 from Murray to Benton was completed in 1981, thus greatly improving access to the Purchase Parkway.

#### Water

The Port of Murray-Calloway County is located on Kentucky Lake, approximately 12 miles from Murray. This large, privately-owned port is owned by the Hutson Company Inc. and Hutson Grain Inc. and is operated by the Hutson Company and the Pillsbury Company. ## Property Taxes

All property in Kentucky is assessed at 100 percent of fair cash value.

Land and buildings are taxed by the state and may be taxed by local jurisdictions. The state rate is \$0.229 per \$100 of assessed valuation.

Manufacturing machinery, raw materials inventories, pollution control equipment, and goods in the process of manufacture are not subject to local taxation. The state rate is \$0.15 per \$100.

Other tangible personal property owned by manufacturers (automobiles, trucks, finished goods, office furniture, office equipment) is taxed by the state at \$0.45 per \$100 and may be taxed by local jurisdictions.

Property stored in public warehouses in a transit status is not subject to local taxation. The state rate is only \$0.015 per \$100.

Intangible personal property located in Kentucky (money in hand, shares of stock, notes, bonds, accounts receivable, and other credits) is taxed by the state at \$0.25 per \$100, and is not subject to local taxation.

Private leaseholds in industrial facilities owned by cities or counties and financed by industrial revenue bonds are subject to a state tax of \$0.015 per \$100 of value (essentially the lessee's equity, adjusted for appreciation or depreciation). Local taxation is not permitted.

#### RECREATION

#### Local

The city of Murray has a year-round supervised recreational program, with organized total-youth sports for children of the city and county. The city has a 100-acre park, a 20-acre park, two mini parks, three swimming pools (olympic, training and infant), seven tennis courts, nine ball fields, 2 soccer fields, six covered pavilions, picnic areas, bike and hiking trails, and playground equipment available for public use. A new golf course is under construction.

Among the youth sports programs offered by the city of Murray are baseball, soccer, basketball, boxing, karate, football and swimming.

Several historic buildings have been restored at the city-county park, including the relocated Louisville and Nashville Railroad freight depot. The depot is used by the Murray-Calloway County Community Theatre, and several plays are presented there each season, year-round. The theatre group stresses the need for theatrical education as well as production, and integrates workshops on acting, directing and technical theatre into its yearly activities.

Private recreational facilities in Murray include two country clubs with 18-hole golf courses, a bowling facility, 6 movie theaters, and a skating rink.

Murray State University has sixteen lighted tennis courts, six racquetball courts, a lighted baseball-football field, four indoor basketball courts, sauna, weight rooms, indoor jogging track, outdoor track, indoor archery/golf range, gymnastic room, several open playing fields, and an indoor swimming pool. The Murray State University Thoroughbreds are perennial challengers for major honors in the eight men's and five women's intercollegiate sports in the Ohio Valley Conference. In addition, several lectures, recitals, concerts, and plays are presented each year on campus and are also open to the public.

Other attractions on the Murray State University campus include the National Museum of the Boys Scouts of America, which houses historical scouting memorabilia and exhibits and the Norman Rockwell painting collection. The Wrather West Kentucky Museum, housed in Murray State University's oldest building, reflects the cultural heritage of the geographic area surrounding Murray and Western Kentucky.

#### Area

Murray's location in the heart of Kentucky's Land of the Lakes region makes it an excellent recreation area. The city is located near two of the largest inland lakes in America - Kentucky Lake and Lake Barkley. This lakeland area offers numerous recreational facilities for water sports, fishing, boating and camping.

Located around this lakeland area are three of the state's finest resort parks - Kenlake State Resort Park, Lake Barkley State Resort Park, and Kentucky Dam Village State Resort Park.

Charm and serenity exemplify Kenlake State Resort Park which is located on the 160,000-acre Kentucky Lake, 16 miles northeast of Murray. The park offers hotel and cottage accommodations and an efficient camping site. Other facilities include a 9-hole golf course, pool and lake swimming, horseback riding, hiking trails, fishing, boating, picnicking, playgrounds, shuffleboard, planned recreation, and one of the finest tennis complexes in the area.

Lake Barkley State Resort Park, 30 miles northeast of Murray near Cadiz, is located on the scenic Little River embayment of the 58,000-acre Lake Barkley. The magnificent lodge includes 120 rooms, four suites, nine cottages, a dining room, a coffee shop, a gift shop, two meeting rooms, and a recreation room. An activities center with a capacity for 400 and a 80-site campground area located near the lodge. A lodge pool, a beach and bathouse, an 18-hole golf course, tennis courts, a riding stable, a trapshooting range, a basketball court, hiking trails, playgrounds, and a picnic area comprise the recreational facilities. The marina near the lodge has everything for the "boat lover": covered and open slips, launching ramp, and rentals for fishing boats, skiing boats, and pleasure-ride pontoons.

Kentucky Dam Village State Resort, located 30 miles north of Murray near Gilbertsville, is one of the largest and most popular vacation resorts in Kentucky. A modern lodge with 72 rooms, six different cottage types, and a 225-site campground make up the accommodations. A recently completed convention center has a theater-seating capacity of 750 persons and a seating capacity of 500 for dinner. For smaller groups, the convention center can be partitioned. There is also a dining room overlooking Kentucky Lake, a coffee shop, a snack bar, two gift shops, a meeting room, an activities center, and a recreation room. Recreational activities to choose from include boating and fishing at the largest docking facility in the Kentucky parks system, golf at the 18-hole Village Green Course, hiking, horseback riding, picnicking, swimming at the lodge pool or off the sand beach, and tennis.

Land Between the Lakes National Recreation Area, accessible 20 miles northeast of Murray, is woodland formed into a peninsula by Kentucky Lake and Lake Barkley. A major area for outdoor recreation, conservation, and environmental learning, there are facilities for fishing, boating, hiking, swimming, hunting, camping and picnicking.
