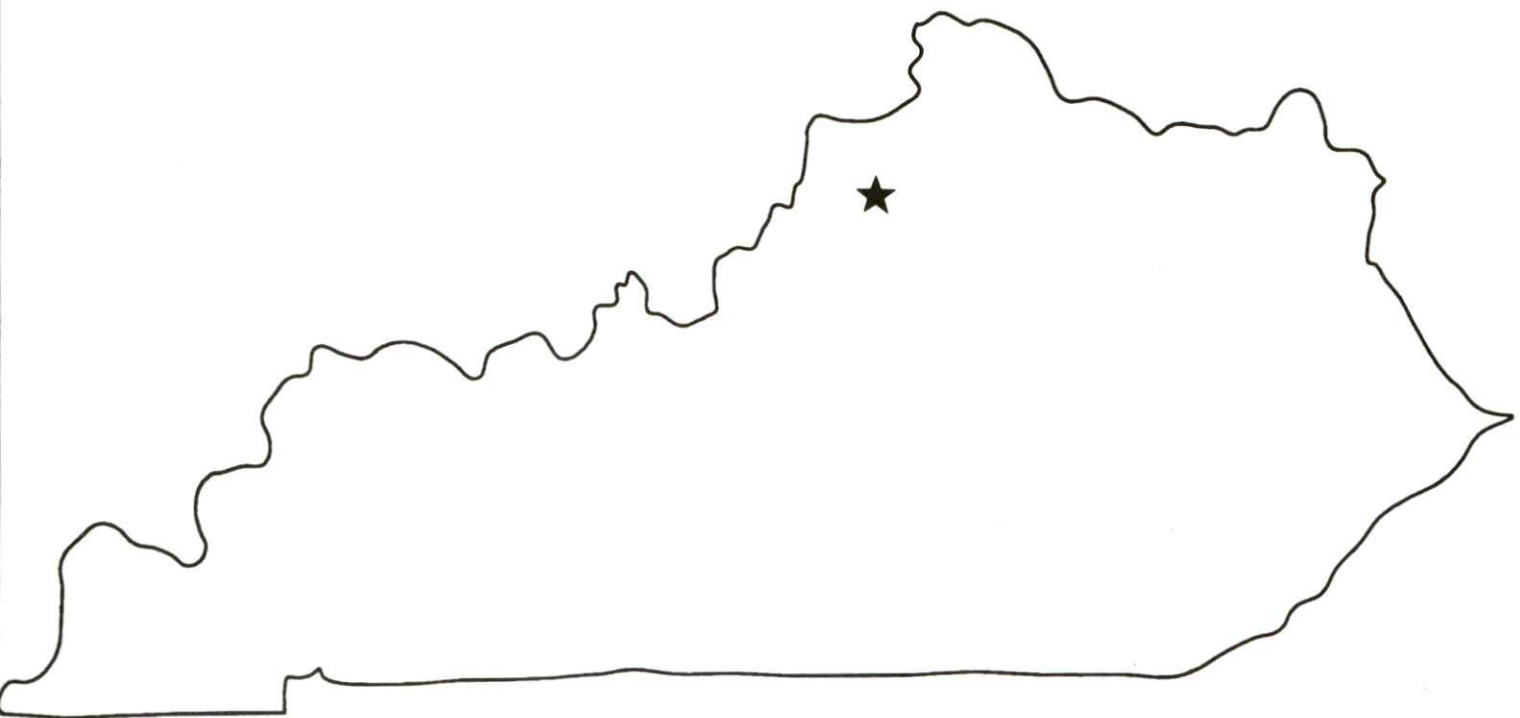

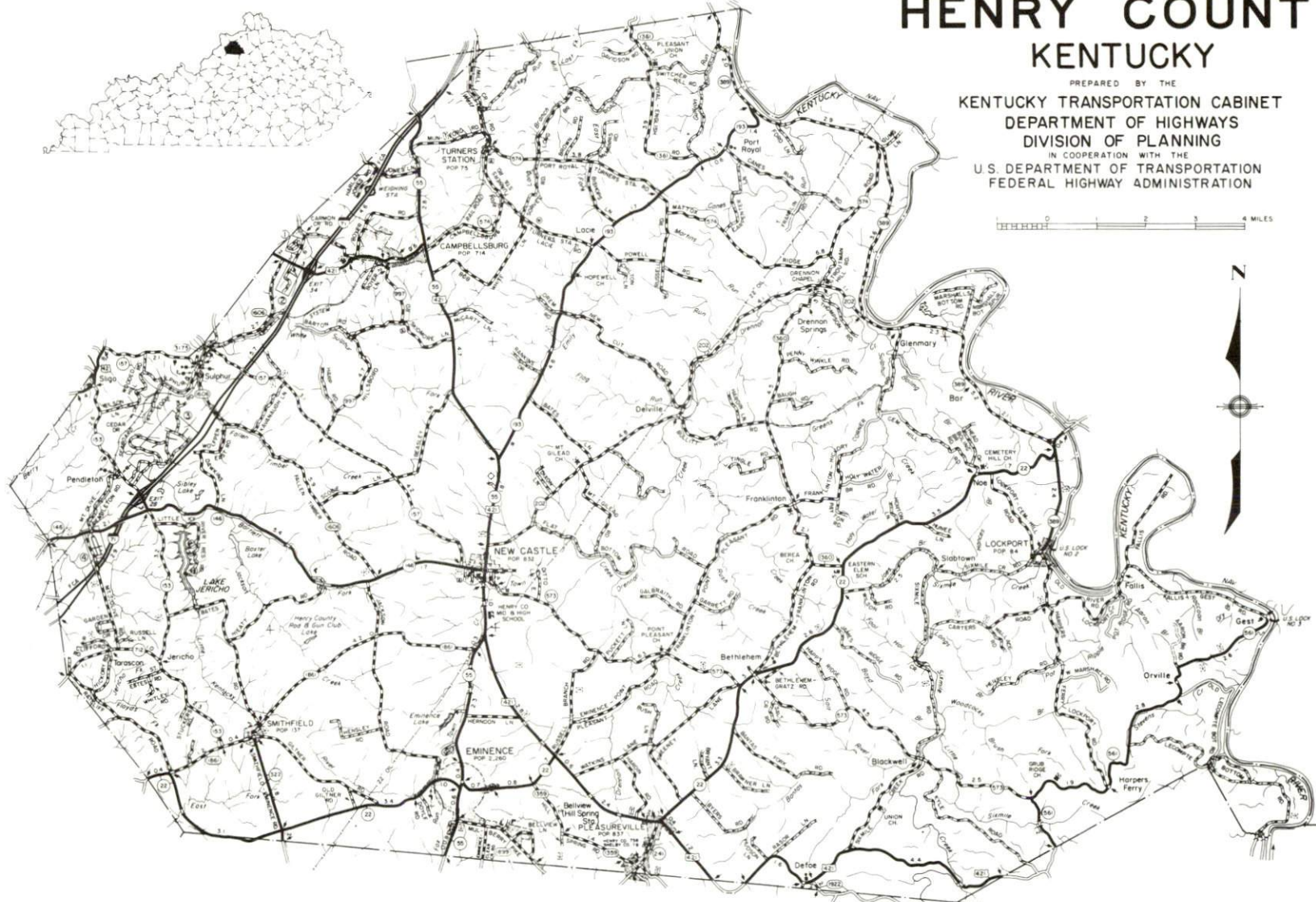

## **HENRY COUNTY, KENTUCKY - A RESOURCE PROFILE**

Henry County, located in north-central Kentucky in the Outer Blue Grass Region, has a land area of 289 square miles. The Kentucky River forms the eastern boundary of the county. Henry County had an estimated 1992 population of 13,486 persons.

New Castle, the county seat, is located 38 miles northeast of Louisville, Kentucky; 75 miles southwest of Cincinnati, Ohio; and 211 miles northeast of Nashville, Tennessee. New Castle had an estimated population of 933 in 1992. Campbellsburg, located eight miles north of New Castle, had an estimated 1992 population of 627. Eminence, the largest city in Henry County, is four miles south of New Castle and had an estimated 1992 population of 2,254.

**The Economic Framework** - The total number of Henry County residents employed in 1993 averaged 7,162. In 1992, manufacturing firms in the county reported 704 employees; wholesale and retail trade provided 676 jobs; 478 people were employed in service occupations; state and local government accounted for 536 employees; and contract construction firms provided 80 jobs.

**Labor Supply** - There is a current estimated labor supply of 3,619 persons available for industrial jobs in the labor market area. In addition, from 1995 through 1999, 10,584 young persons in the area will become 18 years of age and potentially available for industrial jobs.

**Transportation** - Major AAA-rated trucking highways serving Henry County include Interstate 71, U.S. Highway 421, and Kentucky Route 55. Other AAA-rated highways serving the county include Kentucky Routes 22, 146, 322, and 561. Twenty-six trucking companies provide interstate and/or intrastate service to Henry County. CSX Transportation provides main line rail service to Campbellsburg. The Capital City Airport in Frankfort, 30 miles southeast of New Castle, maintains a 5,000-foot paved runway. The nearest scheduled commercial airline service is available at Standiford Field in Louisville, 42 miles southwest of New Castle.

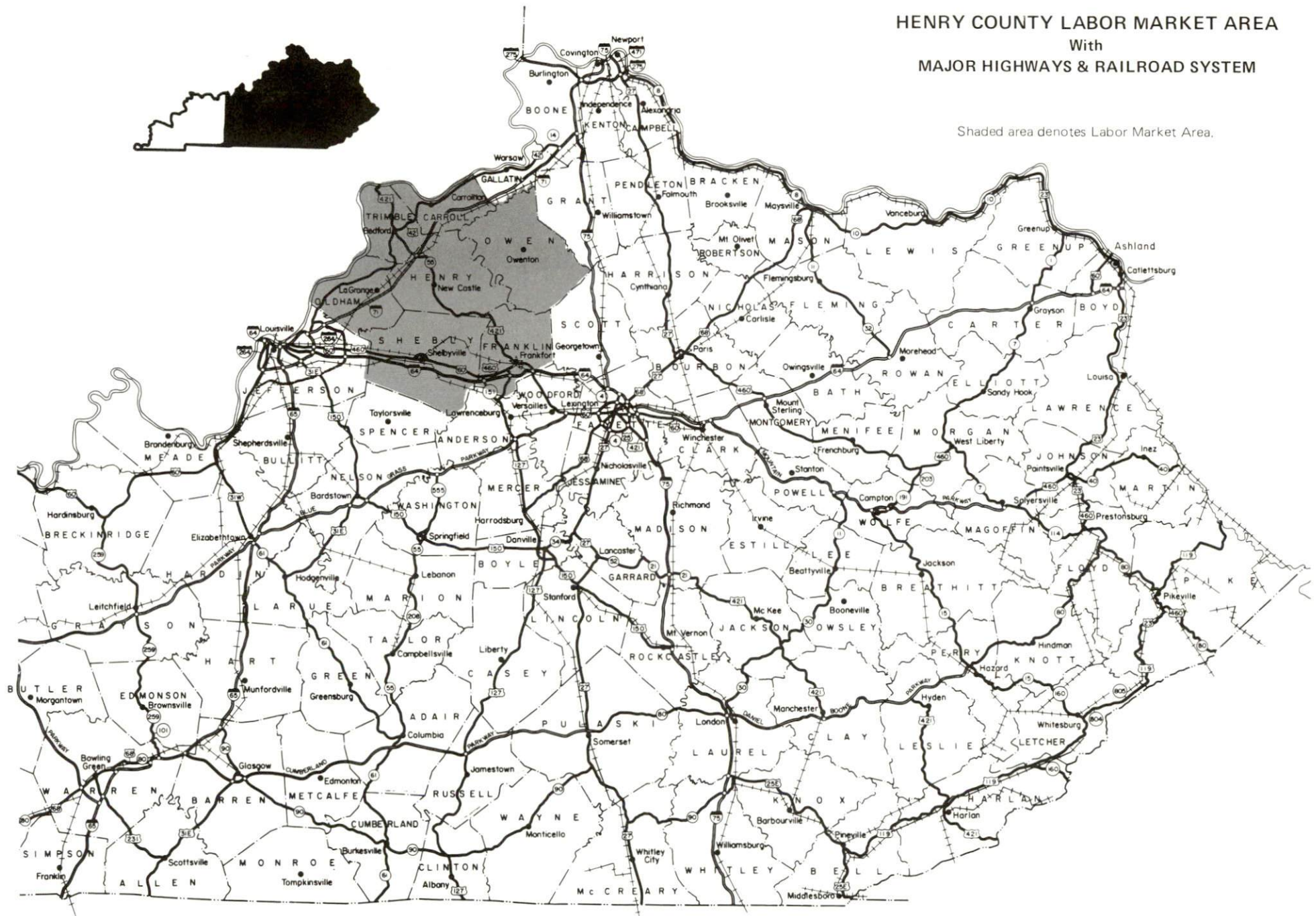
**Power and Fuel** - Electric power is provided to Henry County by Kentucky Utilities Company and by Shelby Rural Electric Cooperative Corporation. Louisville Gas and Electric supplies natural gas service to the county.

**Education** - Primary and secondary education is provided by the Eminence Independent School System and the Henry County School System. Twelve colleges and universities are located within 55 miles of New Castle. Vocational training is available at the Jefferson State Vocational-Technical School in Louisville, 38 miles southwest of New Castle; the Shelby County Vocational Education Center in Shelbyville, 16 miles south of New Castle; and at the Oldham County Area Vocational Education in Buckner, 18 miles west of New Castle.

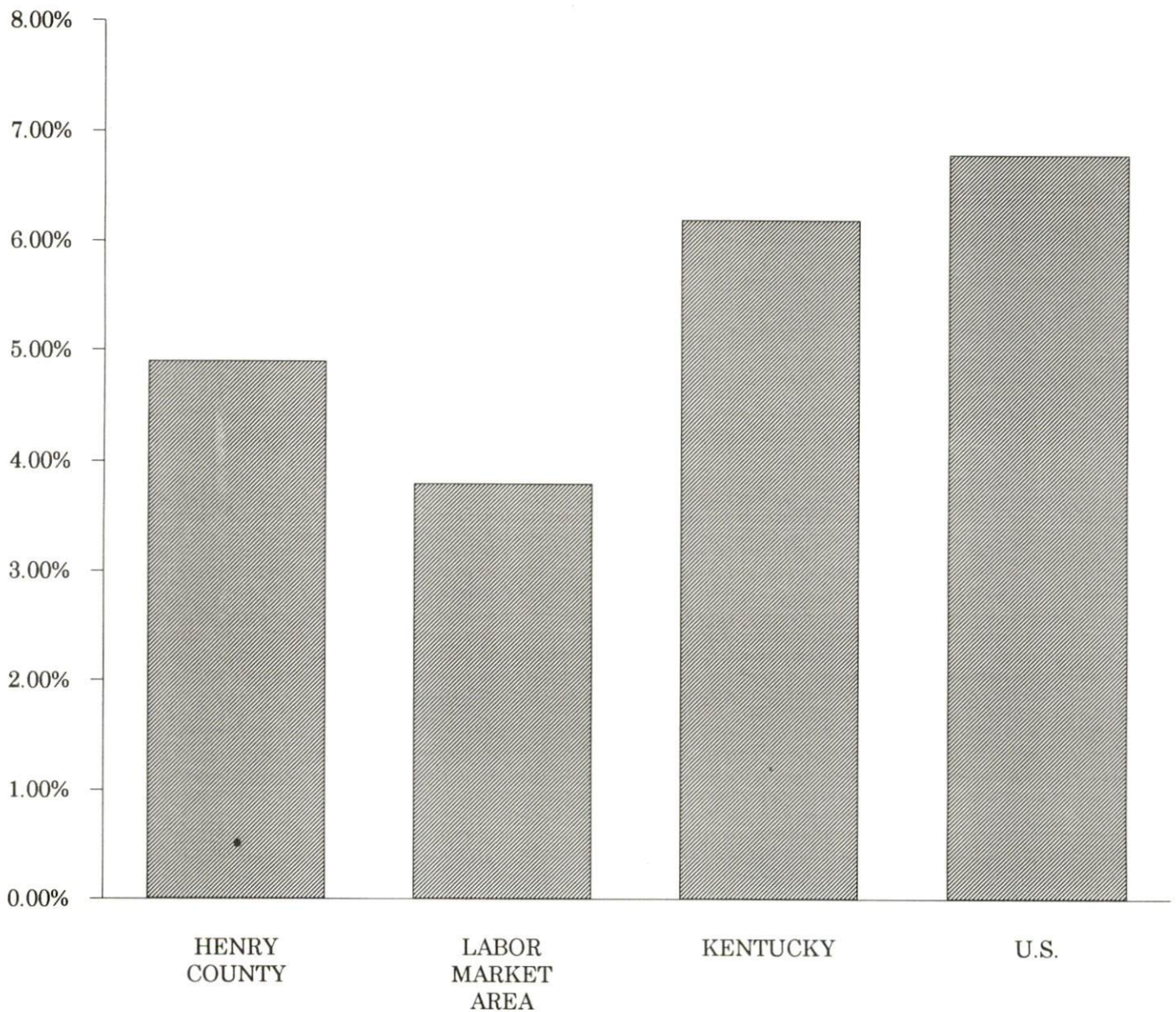

## UNEMPLOYMENT RATES 1993



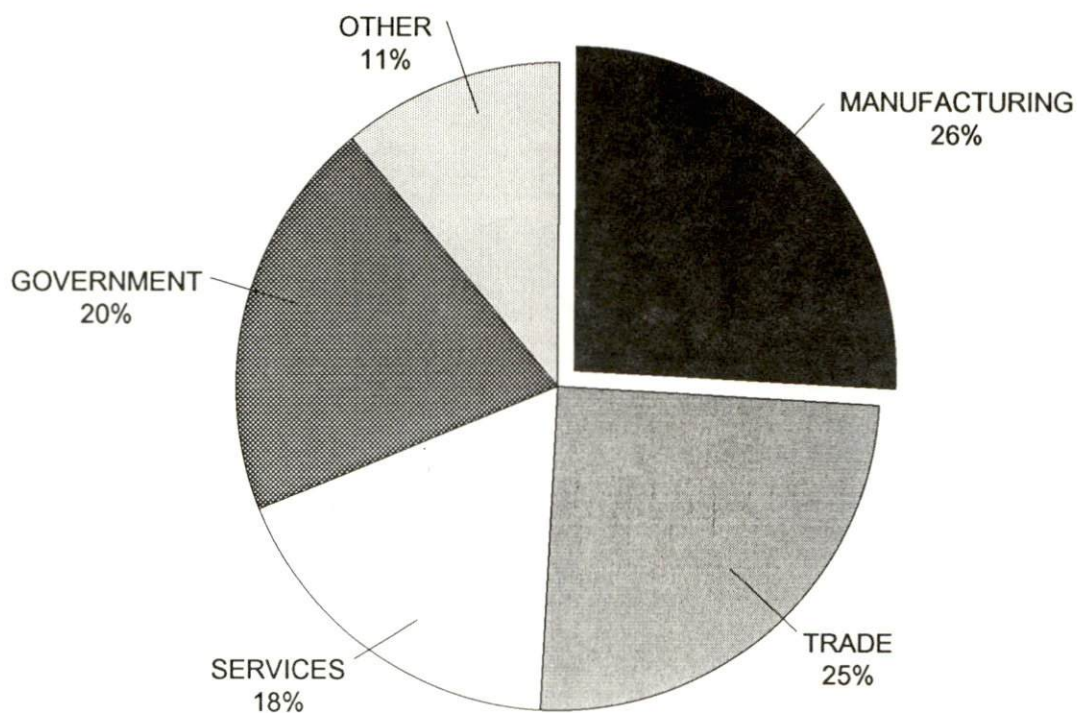

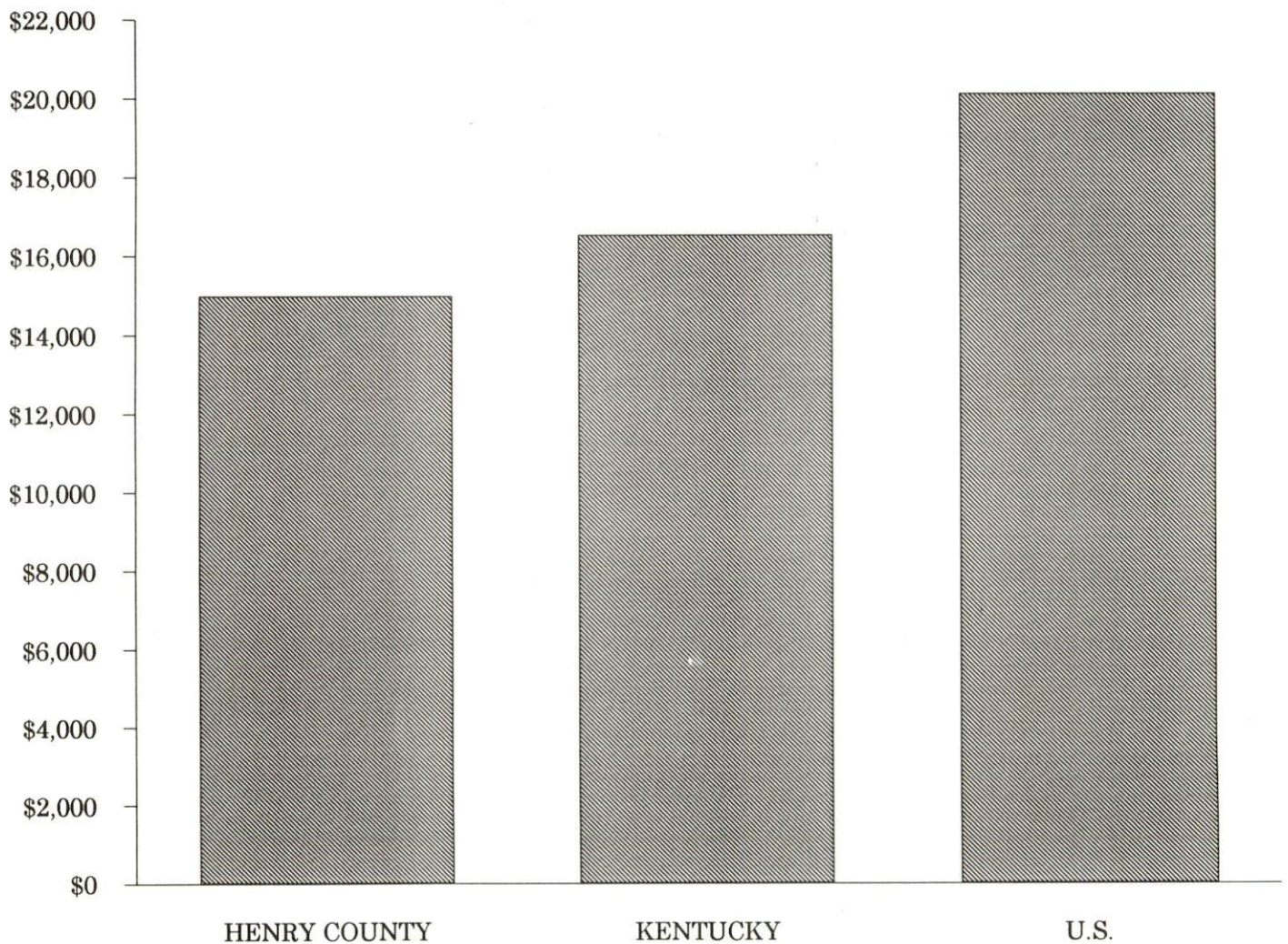

Henry County is served by the Louisville local office of the Kentucky Department for Employment Services. The focus of the following data is on job placements made by the Louisville local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1994, the local employment office filled 17,560 job openings in various occupational categories. 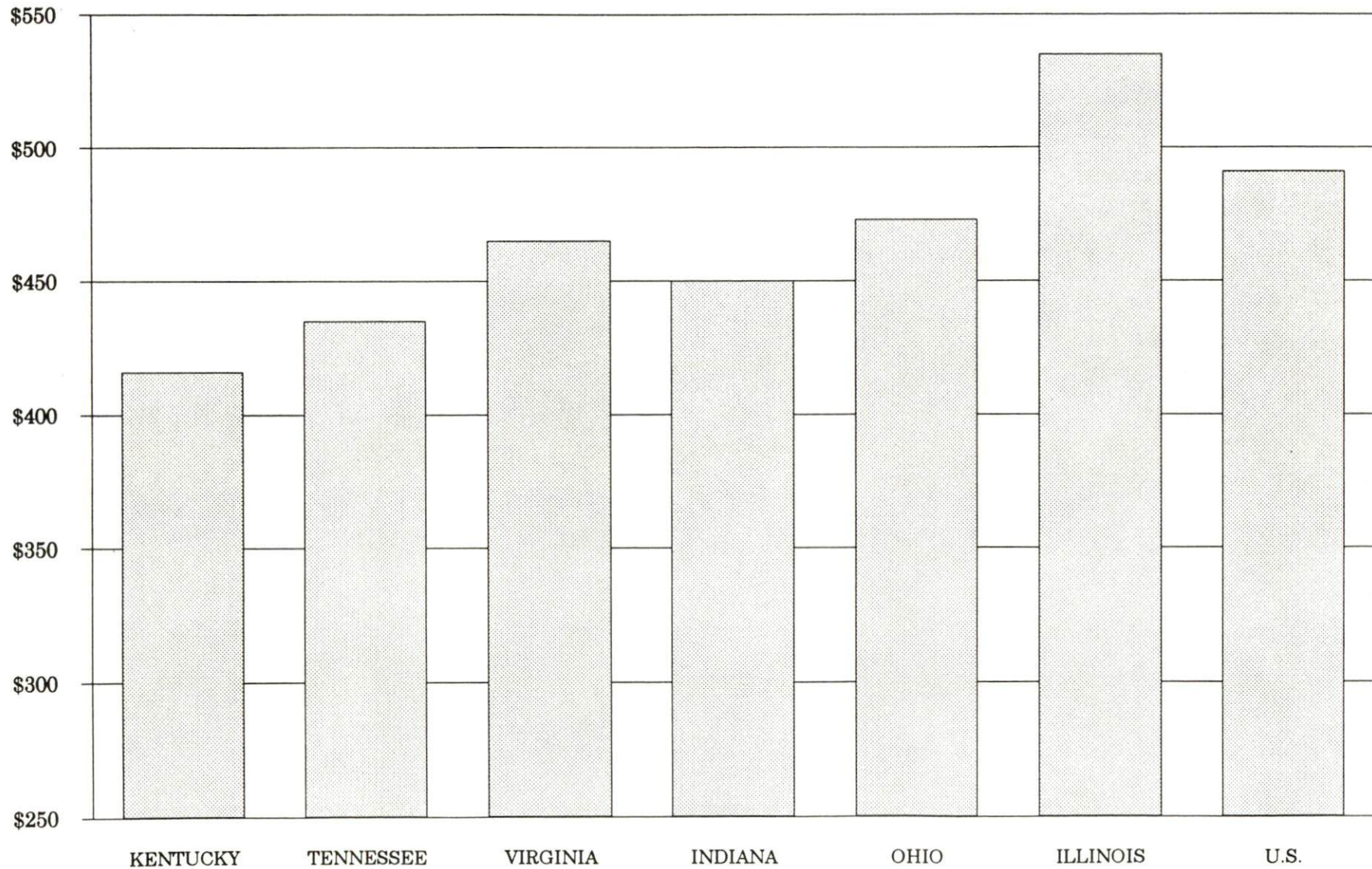

## TRANSPORTATION

### Highways

Major AAA-rated (80,000-pound gross load limit) trucking highways serving Henry County include Interstate 71, U.S. Highway 421, and Kentucky Route 55. Kentucky Highway 55 is AA-rated (62,000-pound gross load limit) north of Campbellsburg. New Castle and Campbellsburg are located along U.S. 421 and Eminence is located along Kentucky 55. Other AAA-rated highways serving the county include Kentucky Routes 22, 146, 322, and 561. Henry County's highways provide good access to Louisville and its metropolitan area.

Interstate 71, a major north-south highway connecting Louisville and Cincinnati, traverses west Henry County. Interchanges are located one mile west of Campbellsburg, via U.S. 421; and eight miles west of New Castle, via Kentucky 146. Access to Interstate 64, which connects Louisville and Lexington, is available 15 miles south of Eminence via Kentucky 55.

A reconstruction of Kentucky Highway 55 extending from Eminence to Interstate 64 near Shelbyville is planned. The project will include widening and straightening and the addition of passing lanes, and is scheduled for completion in 1996.

Kentucky Routes 193 and 389, AA-rated trucking highways, also serve Henry County.

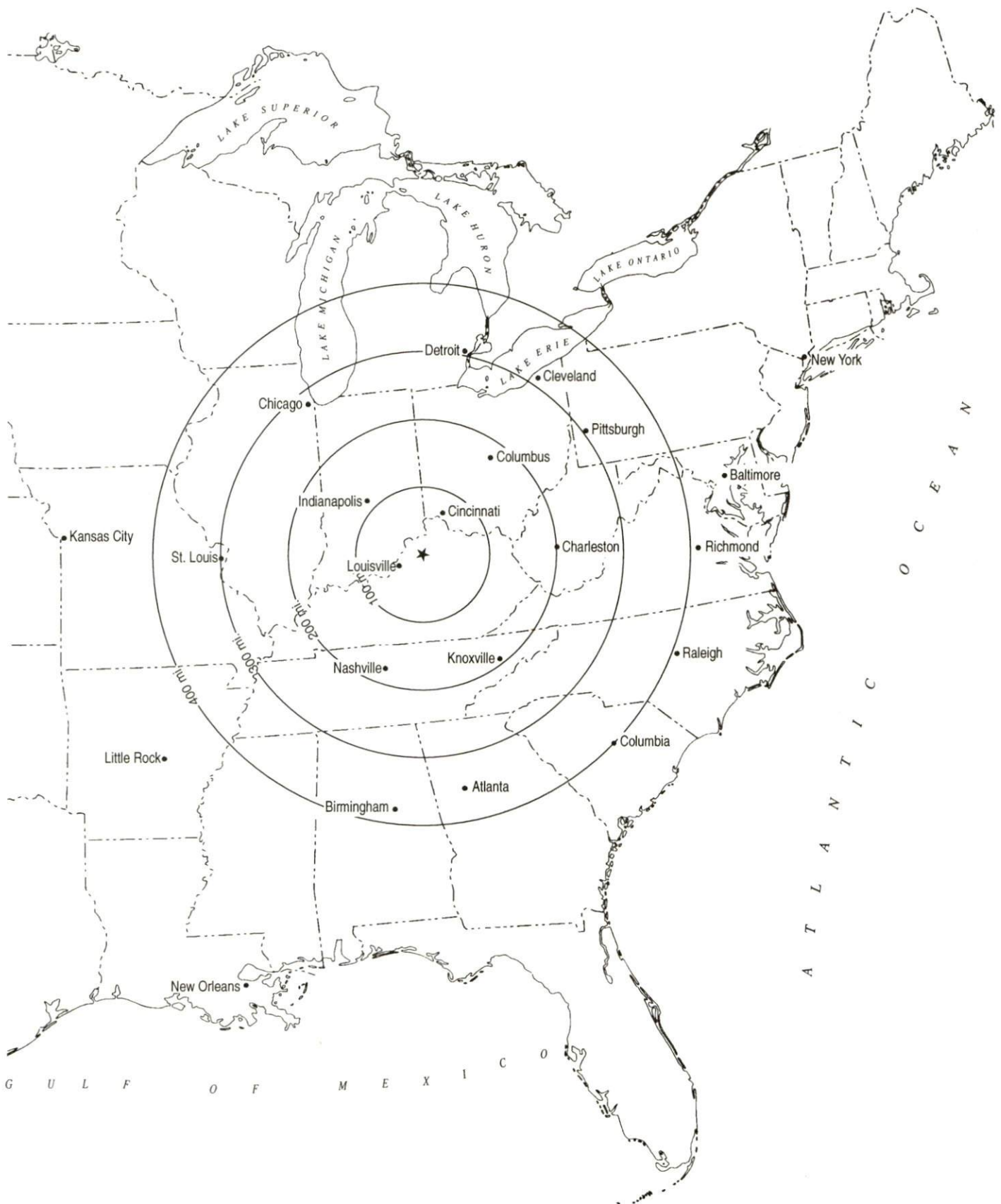

## LOCAL GOVERNMENT

### Structure

Campbellsburg, Eminence, and New Castle are each governed by a mayor-city council form of government. Henry County is served by a county judge/executive and six magistrates.

### Planning and Zoning

Joint agency - Henry County Planning & Zoning Commission

Participating cities - Campbellsburg, Eminence, New Castle, Pleasureville, and Smithfield

Zoning enforced - All areas within Henry County

Subdivision regulations enforced - All areas within Henry County

Local codes enforced - Building and Housing

Mandatory state codes enforced - Kentucky Plumbing Code, National Electric Code, Kentucky Boiler Regulations and Standards, Kentucky Building Code (modeled after BOCA code)

### Local Fees and Licenses

The City of Campbellsburg levies business license fees ranging from \$15 to \$50 and an eight percent insurance premium tax. The City of New Castle levies a \$35 business license Fee.

The City of Eminence levies an occupational license tax of 0.75% on all wages, commissions, and salaries of individuals employed within the city and on net profits of businesses. The minimum annual tax is \$50 and a maximum annual tax of \$3,000 on net profits.



## PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. Accounts receivable are taxed at 85% of face value.

### Customized Training

The Kentucky Tech system, through its Training and Development Coordinators, will provide technical assistance and will identify and develop low-cost customized training programs and services for both established and prospective businesses. Businesses needing customized training should contact a Training and Development Coordinator located at Jefferson SVTS.

### Assessment Services

Kentucky Tech Career Connections offers to business, education, and government agencies customized assessment in career inventories, interest inventories, pre-hire assessment, psychomotor skills and academic potential. A Career Connections assessment center is located at the Jefferson SVTS.

### Tech Prep

Tech Prep is a combined secondary and postsecondary program of studies that leads to an associate degree or diploma in a technical field. Eminence High School, through Kentucky State University, is currently in the third-year implementation of its tech prep program in the area of business technology, health services, computer science, criminal justice, drafting/CAD/ animation and electronics manufacturing.



### Adult Education Services

Adult education programs are available to adults who want to develop new skills, improve basic skills or earn a high school equivalency degree. In Henry County, literacy and adult basic education are provided by the Henry County Board of Education.

### Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is a major source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

## RECREATION

### Local

Harry Hill Recreational Park, located one mile south of New Castle, includes two softball fields, playground area, basketball courts, shelter house and restrooms, horseshoe court and a volleyball court. A public park, located in New Castle, contains a tennis court and a baseball diamond. The Henry County Fairgrounds, located two miles south of New Castle, provides facilities for the annual County Fair which features agricultural exhibits, rides and special events. A senior citizens activity center is located at the Henry County Fairgrounds. Facilities at a private country club located a few miles north of the city include a swimming pool, an 18-hole golf course including pro shop, a clubhouse, and two tennis courts.

Organized recreation is available through various leagues including youth softball, baseball, and football; and adult softball and volleyball.

Lake Jericho and Lake Jericho Recreation Area are located approximately eight miles from New Castle and Campbellsburg. Fishing and boating are favorite activities at this 136-acre lake. Private facilities are available for picnicking and tent and trailer camping.

The Kentucky River, located in northeastern Henry County, affords several recreational opportunities for the entire family including boating, fishing, water skiing, and picnicking.

Recreational facilities in Eminence include a public swimming pool and playground, two public tennis courts, and two Optimist Club little league ball fields. Facilities at the Eminence schools are also open to the public. A parcel of land was recently acquired for the construction of a county-wide community center in Eminence.
