



BOWLING GREEN, KENTUCKY - A RESOURCE PROFILE

Bowling Green, the county seat of Warren County, is the home of Western Kentucky University. Situated on the banks of the Barren River, Bowling Green is Kentucky's fifth largest city with a 1990 population of 40,641. The city is located 62 miles northeast of Nashville, Tennessee; 117 miles southwest of Louisville, Kentucky; and 274 miles southeast of St. Louis, Missouri.

Warren County covers a land area of 547 square miles in Kentucky's Pennyroyal Region. Warren County had a 1990 population of 76,673.


The Economic Framework - The total number of Warren County residents employed in 1991 averaged 39,876. In 1990, manufacturing firms in the county reported 7,071 employees; wholesale and retail trade provided 10,510 jobs; 7,876 people were employed in service occupations; state and local government accounted for 5,182 employees; and contract construction firms provided 1,856 jobs.

Labor Supply - There is a current estimated labor supply of 19,632 persons available for industrial jobs in the labor market area. In addition, from 1992 through 1996, 13,375 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Major highways directly serving Bowling Green include Interstate 65, the Green River Parkway (a multi-lane toll road), and U.S. Highways 31W, 68, and 231. Of the forty trucking companies providing interstate and/or intrastate service to Bowling Green, eight companies maintain local terminals. CSX Transportation provides main line rail service to Bowling Green. The Bowling Green-Warren County Airport maintains two paved runways; 6,500 and 4,000 feet in length. The nearest scheduled commercial airline service is available at the Nashville Metropolitan Airport near Nashville, Tennessee, 68 miles southwest of Bowling Green.

Power and Fuel - Electric power is provided to Bowling Green and a portion of Warren County by Bowling Green Municipal Utilities. Warren County is also provided electric power by the Warren Rural Electric Cooperative. Both Bowling Green Municipal Utilities and Warren Rural Electric Cooperative are supplied by the Tennessee Valley Authority. Western Kentucky Gas Company provides natural gas service locally.

Education - Primary and secondary education is provided by the Bowling Green Independent School System and the Warren County School System. Both school systems are accredited by the Southern Association of Colleges and Schools. Western Kentucky University, located in Bowling Green, offers degrees in associate, bachelors, masters, and specialist degree programs. Draughons Junior College and Davidson Technical College are also located in Bowling Green and offer programs in five academic areas. In addition, ten other colleges and universities are located within 65 miles of Bowling Green. The Bowling Green State Vocational-Technical School and Kentucky Advanced Technology Center, both located in Bowling Green; and the Allen County Area Vocational Center, in Scottsville, and the Russellville Area Vocational Education Center in Russellville offer training in numerous course areas.



UNEMPLOYMENT RATES 1991





AVERAGE PLACEMENT WAGES



RECENT INDUSTRIAL DEVELOPMENTS

The Bowling Green community recently announced three new manufacturing facilities which will locate in the city. James River (Dixie Division) will manufacture paper plates and cups; Motor Wheel will produce wheels for the auto industry; and American Oak Products will make oak furniture. These new developments will represent a total investment of \$61 million and create approximately 550 new jobs.

TRANSPORTATION

Highways

Bowling Green is served by an excellent highway system. Interstate 65, a major north-south highway, serves Bowling Green with three interchanges. The Green River Parkway, a multi-lane toll road, directly serves the city with three interchanges and provides access to major east-west routes, including the Western Kentucky Parkway, 37 miles northwest of Bowling Green. Access to the Cumberland Parkway, another multi-lane toll road, is 20 miles northeast of Bowling Green via Interstate 65.

Other major highways serving Bowling Green are U.S. Highways 31W, 68 (and Kentucky Highway 80), and 231, all "AAA"-rated (80,000-pound gross load limit) trucking highways.

Plans are under way for the construction of a four-lane highway extending from Bowling Green west to Cadiz which would connect Interstates 65 and 64.



LOCAL GOVERNMENT

Structure

The City of Bowling Green is governed by a mayor, four commissioners, and a full-time city manager. The mayor is elected to a four-year term while the commissioners each serve two-year terms. Warren County is governed by a county judge/executive and six magistrates. Each county official serves a four-year term.

Local Fees and Licenses

The City of Bowling Green levies a one and one-half percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses within the city.

The Warren County School District levies a one-half of one percent occupational license tax on wages, salaries, and commissions of individuals employed within the school district and on net profits of businesses within the district. Non-residents employed within the school district are exempt from this tax.

PROPERTY TAXES

The Kentucky Constitution requires the state to tax all classes of taxable property, and state statutes allow local jurisdictions to tax only a few classes. All locally taxed property is subject to county taxes and school district taxes (either a county school district or an independent school district). Property located inside of city limits may also be subject to city property taxes.

Special local taxing jurisdictions (fire protection districts, watershed districts, and sanitation districts) levy taxes within their operating areas (usually a small portion of community or county).

Property assessments in Kentucky are at 100% fair cash value. A 15% reduction is automatically granted for accounts receivable.

Western Kentucky University

Located on a hill overlooking the city of Bowling Green, the Western Kentucky University campus is acclaimed as one of the most beautiful in the nation. There are 66 major buildings on the approximately 200-acre main campus, with another 800 acres on the University Farm.

Western's undergraduate division provides four-year programs leading to the Bachelor of Arts, the Bachelor of Fine Arts, the Bachelor of Science, the Bachelor of Science in Nursing, and the Bachelor of Music degrees. Eighty-nine academic majors, 65 academic minors, and various pre-professional programs are available. Twenty-one associate degree programs are offered leading to the Associate of Arts degree, Associate of Science degree and Associate of Liberal Studies degree.

The Graduate College offers the Master of Arts, Master of Arts in Education, Master of Public Administration, Master of Science, Master of Music, and Master of Public Service. Western also offers the Specialist Degree in Rank I and Rank II programs. Joint doctoral degree programs are offered in cooperation with the University of Kentucky and with the University of Louisville.

The Department of Industrial Technology at Western Kentucky has an option under the Industrial Technology major in Computer Integrated Manufacturing Technology. The program encompasses the aspects of computer integration currently in progress in industry with a special emphasis on production techniques.

The University is in the process of constructing a new student health and activities center, and two new dormitories. The \$18 million projects are scheduled for completion by Fall 1992.

Draughons Junior College

Draughons Junior College, Bowling Green campus, offers Associate Degree and Diploma programs in Accounting, Business Management, Computer Science and Secretarial Science.

Draughons Junior College, Nashville, Tennessee, established in 1884, opened the Bowling Green branch campus in 1989.

Davidson Technical College

Davidson Technical College in Bowling Green is a branch campus of Davidson Technical College, Nashville, Tennessee. Opened in 1989, the Bowling Green campus of Davidson Technical College offers a Diploma Program in Medical Assisting.

Vocational Training

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Bluegrass State Skills Corporation is the primary source for skills training assistance for a new or existing company. The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

The City of Bowling Green and Warren County each maintain full-time recreation departments which provide 700 acres of public parks and facilities. Both parks' departments provide various leagues, tournaments, instructional programs, crafts and other activities.

The Bowling Green Parks and Recreation Department maintains 17 parks consisting of 535 acres, which include an 18-hole golf course and two nine-hole golf courses, tennis courts, soccer/football/softball/baseball fields, volleyball courts, basketball courts, swimming pool, plus picnic and playground facilities and two community centers. In the next four to eight years the park system will build one community center, a 50-meter swimming pool and obtain property for two additional park sites for the citizens.

The Warren County Parks and Recreation Department oversees 165 acres of parks, 45 acres of which are community parks maintained by the county. Facilities include softball/baseball fields, tennis courts, football/soccer field, BMX track, junior archery range, junior rifle range, picnic areas, playgrounds and a community center.

The Capitol Arts Center presents live theatre, dance and music by professional touring companies and local art groups. The renovated movie theatre has an 850-seat capacity plus is home of the Houchens Art Gallery. Public Theatre of Kentucky offers performances by a professional theatrical group. Other facilities open to the public include 14 movie theatres, two bowling alleys, and the Beech Bend International Raceway. The Raceway is an NHRA sanctioned track which hosts several national drag racing championships.

Places of historical interest in Bowling Green are Mariah Moore House, built in 1818 by the city's founding father, Robert Moore; Fountain Square Park, the original hub of community activities; and Hobson House, used as a Confederate munitions magazine during the Civil War.

Two private country clubs are located in Bowling Green. Each has an 18-hole golf course, swimming pools, and tennis courts. Other private facilities include a nine-hole golf course, two private swim clubs, a racquetball club, an indoor tennis club and several spas.

Western Kentucky University is the focal point for many cultural, sporting, and educational activities. Hardin Planetarium, the largest in the state, is located at the university. The Kentucky Museum houses an outstanding collection of materials on the history of Kentucky. Lecture series and university drama and music productions are popular attractions. The art gallery in the Ivan Wilson Center for Fine Arts has outstanding revolving exhibits.

COMMUNITY IMPROVEMENTS

Bowling Green re-certified as a "Kentucky Certified City" in 1991, and is distinguished as a gold award winner recognizing nine consecutive years of certification. Re-certification is based on achievement in the following areas: existing industry assistance, small business assistance, educational resources, and community development factors of health care, public safety, arts and culture, recreation, governmental awareness and resources. In addition to receiving the 1991 Gold Award, Bowling Green was recognized as a Hall of Fame community. This newly created category not only demonstrates that a community is adequately prepared for immediate growth, but also that the community has analyzed emerging economic trends, and has set about planning for the future. The Certified Cities Program is sponsored by the Kentucky Chamber of Commerce.

Recent

Cello Bag, which manufactures printed polyethylene roll stock and printed bags, recently located operations in Bowling Green employing 52 persons. Woodwork of Mid-America also initiated operations in Bowling Green. The plant employs 220 persons and manufactures architectural woodwork and retail store fixtures. Total combined investment approximated \$22 million.

The Bowling Green community recently announced three new manufacturing facilities which will locate in the city. James River (Dixie Division) will manufacture paper plates and cups; Motor Wheel will produce wheels for the auto industry; and American Oak Products will make oak furniture. These projects will represent a total investment of \$61 million and create approximately 550 new jobs.

Approximately six manufacturing firms expanded its existing facilities from 1990 to 1992, representing a total investment of \$10 million.

The Warren County Water District completed a \$2,550,000 systems improvement project which included construction of three new tanks with a total combined storage capacity of 1.5 million gallons, 65 miles of new water lines ranging from 4-inch to 8-inch, and two new pumping stations.

Recent improvements at the Warren County School System include: construction of Greenwood High School and Natcher Elementary School, and a renovation and expansion of Warren East High School. Total combined cost of projects were \$21 million.

The Bowling Green Independent School System recently constructed a new academic and athletic building at the high school at a cost of \$3,370,000.

Greenview Hospital recently completed several improvements including: the opening of a new outpatient emergency department, a renovation of the radiology/imaging department, a new cardiac catheterization lab, an open heart surgery program, lithotripsy service for kidney stone treatment, and national accreditation for both mammography service and sleep diagnostic service.

Recent improvement projects at The Medical Center at Bowling Green include: a renovation and 49,000-square-foot expansion of the outpatient services center and the addition of a second cardiac catheterization laboratory.

Under Way

Bowling Green Municipal Utilities is in the process of expanding its existing wastewater treatment plant and renovating the sewerage system. The expansion project will increase capacity from 8.4 million gallons per day to 10.6 million gallons per day. The renovation project will consist of line repairs and replacement of existing lines and extension to unserved areas. The \$9.5 million project is scheduled for completion in May 1993.

Construction at the 300-acre Hartland development is under way. The project includes an Embassy Suites Hotel and convention center, and an 18-hole golf course. The \$23 million development is scheduled for completion in 1994.

Western Kentucky University is in the process of constructing a new student health and activities center, and two new dormitories. The \$18 million projects are scheduled for completion by Fall 1992.

Construction of a \$5 million building which will house the Kentucky Advanced Technology Center, is under way.

Planned

Bowling Green Municipal Utilities plans to construct a one million-gallon elevated storage tank, a new transmission main, and a pumping station during fiscal year 1994 at a cost of \$2,500,000.

Warren County Water District-Sewer Division plans to extend sewer service to the city of Smiths Grove and its industrial area. An application is pending for financing the project.

Plans are under way for the construction of a four-lane highway extending from Bowling Green west to Cadiz which would connect Interstates 65 and 24.

The Bowling Green-Warren County Airport will receive \$1 million for construction of a full instrument landing system and \$700,000 for acquisition of land. In addition, the airport will be designated as an auxiliary flight station effective late 1992.

The City of Bowling Green plans to construct a new 13,000-square-foot police station. The facility is scheduled for construction during the summer of 1993 at an approximate cost of \$1.5 million.

Plans for the National Corvette Museum have been announced. Construction will start in June 1992 and be completed by Summer 1993 at an approximate cost of \$12 million.
