



HARRODSBURG, KENTUCKY - A RESOURCE PROFILE

Harrodsburg, the county seat of Mercer County, is the oldest permanent English settlement west of the Allegheny Mountains. The city is located 33 miles southwest of Lexington, Kentucky; 74 miles southeast of Louisville, Kentucky; and 111 miles south of Cincinnati, Ohio. In 1986, Harrodsburg had an estimated population of 8,790 persons.

Mercer County, with a land area of 250 square miles, is located in the Bluegrass Region of central Kentucky. The topography of the county is gently rolling to hilly. The 1987 estimated population of Mercer County was 20,000 persons.


The Economic Framework - The total number of Mercer County residents employed in 1988 averaged 8,270. Manufacturing firms in the county reported 1,474 employees; wholesale and retail trade provided 1,149 jobs; 835 people were employed in service occupations; state and local government accounted for 620 employees; and contract construction firms provided 182 jobs.

Labor Supply - There is a current estimated labor supply of 13,943 persons available for industrial jobs in the labor market area. In addition, from 1989 through 1993, 9,710 young persons in the area will become 18 years of age and potentially available for industrial jobs.

Transportation - Highways serving Harrodsburg include U.S. 68, U.S. 127, and Kentucky 152. The Bluegrass Parkway can be accessed sixteen miles north of Harrodsburg near Lawrenceburg, Kentucky, via U.S. 127, and I-64 is accessible 29 miles north of Harrodsburg via U.S. 127. Twenty-seven trucking firms provide intrastate and/or interstate service to Harrodsburg. Rail service is provided by Southern Railway System. The nearest local air service is available at Danville-Boyle County Airport near Danville, 13 miles southwest of Harrodsburg. Scheduled commercial air service is available near Lexington at Bluegrass Airport, 32 miles northeast of Harrodsburg.

Power and Fuel - Electric power is provided to Harrodsburg and parts of Mercer County by the Kentucky Utilities Company. The remainder of Mercer County is served by the Fox Creek Rural Electric Cooperative Corporation and the Inter-County Rural Electric Cooperative Corporation. Natural gas service is provided by the Western Kentucky Gas Company.

Education - Primary and secondary education is provided to the Harrodsburg area by the Harrodsburg Independent School System and the Mercer County School System. The Harrodsburg Independent School System is accredited by the Southern Association of Colleges and Schools. Eleven colleges and universities are located within 50 miles of Harrodsburg. Vocational training is available locally at the Harrodsburg Area Vocational Education Center and the Central Kentucky State Vocational-Technical School in Lexington, 33 miles northeast.



LABOR MARKET STATISTICS

The Harrodsburg Labor Market Area includes Mercer County and the adjoining Kentucky counties of Anderson, Boyle, Garrard, Jessamine, Washington, and Woodford.



UNEMPLOYMENT RATES 1988





PER CAPITA PERSONAL INCOME 1987




AVERAGE PLACEMENT WAGES

Mercer County is served by the Danville local office of the Kentucky Department for Employment Services. The focus of the following data is on job placements made by the Danville local office and may therefore be used as an indicator of the wages which employers in the area pay new employees. During the twelve months which ended on June 30, 1988, the local employment office filled 1,535 job openings in various occupational categories. TRANSPORTATION

Highways

U.S. Highways 68 and 127 are "AAA"-rated (80,000-pound gross load limit) highways serving Harrodsburg. U.S. 127 has an excellent multilane segment extending from the Blue Grass Parkway, 16 miles north of Harrodsburg, to Danville, 9 miles southeast of Harrodsburg. Kentucky Route 152, a "AA"-rated (62,000-pound gross limit) highway, also serves Harrodsburg.

Access to Interstate Highway 64 is available 29 miles north of Harrodsburg via U.S. 127, and 39 miles northeast near Lexington. Interstate 75 is also accessible near Lexington, as well as 47 miles southeast of Harrodsburg via U.S. 127 and U.S. 150, also a "AAA"-rated highway.



LOCAL GOVERNMENT

Structure

The City of Harrodsburg is served by a mayor and four council members. The mayor serves a four-year term and the council members serve two-year terms. Mercer County is served by a county judge/executive and six magistrates. The county judge/executive and magistrates are all elected to four-year terms.

Planning and Zoning

Local Fees and Licenses

The City of Harrodsburg levies a one percent occupational license tax on wages, salaries, and commissions of individuals and on net profits of businesses operating within the city. The city also levies a business license fee of \$25 per year for businesses operating within the city. A seven percent insurance license fee is also charged.

State and Local Property Taxes

All property in Kentucky, except items exempted by the state constitution, is taxed by the state. Property which also may be taxed by local jurisdictions includes land and buildings, finished goods inventories, automobiles, trucks, office furniture and office equipment. Local taxing jurisdictions in Kentucky include counties, cities, and school districts.

All property in Kentucky is assessed at 100 percent of fair cash value.

Vocational Training

Vocational training is available at both the state vocational-technical schools and the area vocational education centers. The state vocational-technical schools are post-secondary institutions. The area vocational education centers are designed to supplement the curriculum of high school students. Both the state vocational-technical schools and the area vocational education centers offer evening courses to enable working adults to upgrade current job skills.

Arrangements can be made to provide training in the specific production skills required by an industrial plant. Instruction may be conducted either in the vocational school or in the industrial plant, depending upon the desired arrangement and the availability of special equipment.

Bluegrass State Skills Corporation

The Bluegrass State Skills Corporation, an independent public corporation created and funded by the Kentucky General Assembly, provides programs of skills training to meet the needs of business and industry from entry level to advanced training, and from upgrading present employees to retraining experienced workers.

The Corporation works in partnership with other employment and job training resources and programs, as well as Kentucky's economic development activities, to package a program customized to meet the specific needs of a company.

RECREATION

Local

The citizens of Harrodsburg and Mercer County have access to a wide variety of recreational opportunities. The local YMCA manages the five city parks in addition to its own facility, which houses a gymnasium, a co-ed weight room, and offices.

Facilities at Lions Park include the Harrodsburg Community Center, with conference and meeting room areas designed to accommodate over 300 people, and three lighted tennis courts.

Young's Park features a picnic area with tables and grills, a large shelter house that can be rented for group activities, and a playground. The Salt River Park contains a shelter house and picnic areas.

Sportleigh Field offers baseball and football fields for use by Little League and Babe Ruth teams, and West Lane Park has a soccer field, a lighted softball field, and community meeting rooms. Other public recreational facilities in Harrodsburg include a municipal swimming pool, several tot lots, two tennis courts and three baseball diamonds located at the public schools. Private recreational offerings include several swimming pools and a golf course. A driving range has been recently constructed in Harrodsburg.

The Beaumont Inn is one of Harrodsburg's most famous attractions. The antebellum structure serves as a historic country inn with antique furnishings, modern recreational facilities, a dining room specializing in southern delicacies, and a gift shop.

The Bright Leaf Resort, also a noted local attraction, features a modern 36-hole golf course, a new lighted par-three course, and a health spa on the premises.

Old Fort Harrod State Park is a 28-acre park in Harrodsburg that features a full-scale reproduction of the original Fort Harrod. The park also contains the log cabin where Abraham Lincoln's parents were wed, the Mansion Museum which houses mementos associated with the great periods of Kentucky history, a pioneer cemetery, and a federal monument dedicated to pioneers. The "Legend of Daniel Boone" is an excellent outdoor drama which is performed at the Old Fort Amphitheater during the summer months.

Herrington Lake, near Harrodsburg, was developed by the Kentucky Utilities Company in 1925. Dix River Dam near Pleasant Hill is located on the 3,600-acre lake. Fishing, boating, and swimming can all be enjoyed on the lake. Camping and fishing facilities are available near Harrodsburg.

Pleasant Hill, a restored Shaker Village located 7 miles northeast of Harrodsburg, is a National Historic Landmark. Over 20 buildings and grounds have been restored to display unique Shaker skills in furniture making, crafts, and architecture. Dining rooms, lodging, craft shops, and seasonal festivals and plays are offered. Pleasant Hill recently acquired an additional 16,000 acres which will be developed into a recreated Shaker farm.

COMMUNITY IMPROVEMENTS

Recent

Harrodsburg was chosen as a "Kentucky Certified City" in 1987. The award is based on achievement in the following categories: economic development, transportation, public affairs, utilities, health, commercial development, housing, education and recreation. The Certified Cities Program is sponsored by the Kentucky Chamber of Commerce.

A pumping station was built in the fall of 1987 to service the new industrial park and to eliminate another pumping station.

United Sign and Awning Manufacturing, Inc., has opened in Mercer County.

The Mercer County School System added two additional classrooms to the elementary school this year.

Under Way

Harrodsburg has applied for a \$390,000 Community Development Block Grant. This grant, in addition to private contributions is being used to fund a Main Street Program. Currently several downtown buildings are being renovated. A major Main Street renovation project is the Old Blue Front Building which will be used for retail stores. The projected completion date for this project is spring 1990.

There are two housing projects currently under way in Harrodsburg. The first, known as the "West Side Project", began in 1987 with a \$750,000 Community Development Block Grant to upgrade existing housing. The project is expected to be completed in the near future. The second housing project involves renovating existing housing in the Davistown community. A \$107,100.00 Community Development Block Grant is being used to fund the project.

The Mercer County Public Library is undergoing a major renovation and expansion which will add addition seating, increase the size of the collection by 15,000 volumes, add a small conference room, and enlarge work space. The estimated cost of the project is \$640,000.

The Planning and Zoning Commission is in the process of developing a comprehensive plan. Implementation should begin by fall of 1991. Burgin will enforce planning and zoning when the plan is complete.

Harrodsburg Industrial Warehousing, Inc. is currently under construction in the old industrial park. Projected employment will be five.

A 32,400-square-foot addition is currently being constructed at the Harlow Elementary School. The addition will house a kitchen/cafeteria, physical education facility, and four classrooms. The cost estimate for the project is \$1.43 million and is scheduled for completion in mid-December 1989.

Planned

The Harrodsburg Independent School system is planning a construction project which will add an additional eight to twelve classrooms to the Harlow Elementary School. This will enable the district to convert to a K-6 and 7-12 instructional configuration with Harlow Elementary serving as the elementary center. A major renovation project is planned to convert the city's present elementary/junior high to a facility which houses grades 7-12. The construction and renovation is scheduled to begin in the summer of 1991 or early spring 1992.

Mercer County School System plans to build an additional middle school or high school.
