The article which follows is another of the many newspaper sketches written years ago by Mr. R. T. Martin over one of his several pen-names, the most common, as in this case, being "Rondo." The family here delineated was mostly in Christian County, but it had many ties with Muhlenberg County, so should be of interest to many of our members. A few minor alterations have been made in punctuation, etc., but no changes in names or facts. The article originally appeared in The Muhlenberg Sentinel, for Aug. 19, 1910.

THE FAMILY OF PUNNINGTON

A Skatch of a Family Wall Known Throughout This Saction.

As time moves on and people are born to live and die, each generation makes a history of acts and deeds wrought out by every individual that lies and moves in life. The acts and deeds of some become historic and pass down the ages in shining letters, while the character and conduct of others are left to life's vague tradition and are finally lost to the memory of those that live amid the hurly burly of time and the waste of years.

Some days ago we noticed a book written by one James Weir, born and reared in Greenville, Ky. The title of the book was "Lonz Powers." This book is a romance based upon the family of Frank Pennington; although it is full of fiction and fancy, it contains some facts and occurrences of the lives of that family. The book was published in 1850, but for some cause it was withheld from the market and distribution, and now there are very few volumes extant. James Weir, the author of this book, was born about 1820, and if he had devoted his time and talent to the writing of the history of the conditions of the early settlement of the county and the proceedure of the pioneers, the occurrences and adventures of their lives, such a book would now be valuable and highly appreciated. Weir lived in an age that he could have easily gathered sufficient traditional knowledge as to have constituted a valuable volume of historic information in regard to the lives, habits and conduct of the pioneers of this section of the country; but unfortunately, no one sible and at best those now living can only know in part the truth of what was once realized and took place.

People have lived and died who once had noted lives that are entirely lost to tradition.

Now, in our comment upon the family of Frank Pennington we shall have to depend upon our memory of their tradition. And tradition is sometimes conflicting and exaggerating. However, we find that the family of Frank Pennington came to Christian county during the first quarter of the nineteenth century and settled in the northern part of that county on a fine tract of land, on the waters of Pond River, the border line of Christian and Muhlenberg Counties. There were some rough characters found on that border line, being some distance from the county seats; but there were many good citizens that settled in these parts. Now Frank Pennington was at one time a prosperous farmer, a man that was honest and law abiding, was respected by his neighbors and all those who knew him. He was a man of some means and well to do for one of the times; he owned a number of negroes and gave to each of his children two negroes. But in the run of years, when his family had grown up, his girls were high strung, his boys had every advantage to have prospered and done well, but they were indolent and extravagant; they became associated with the rough characters located on the borderland of Muhlenberg and Christian counties. They engaged in horse racing, drinking, gambling and other immoral conduct which clouded Pennington's home and brought reproach upon his name. Virtue gave place to vice; honesty to dishonesty, and the name of Pennington received a stain that marked its tradition which could never be erased. Frank Pennington died during the latter part of the girls were named Dora, Bettie, Marcella and Angeline. His boys were Elonzo and Morton. The girls all married well to do men.

Dora Pennington, the oldest daughter, married Harvey Harrellson, a man of prominence and one that stood high. He settled in the northern part of Christian county, was a progressive farmer and conducted a tan yard that was noted and did extensive business. They had four children, two girls and two boys. Byron and William were the boys. And after Harrallson died, during the 1850's, Byron succeeded him in his business and became a man of prominence; he was afterwards elected sheriff of Christian county and he then moved to Hopkinsville and later on went south and there died. William Harrellson, the second son of Harvey, joined the southern army and died during the war. The Harrellson family were respectable people.

Bettie Pennington married Biger Stuart; he was a respectable man and well to do; he settled in the northern part of Christian county on the west fork of Pond river; he ran a mill and a farm for years. They had two boys and two girls; the boys were Frank and Jake. When Stuart died, Frank, his oldest son, assumed the business and became a well to do, respectable citizen. Jack was somewhat dissapating and of a wild disposition; he went to Illinois and died there. Frank remained in Christian county until some time after the war, then went south where he died.

Marcella Pennington married Samuel Clark, a well to do, respectable man; they moved

to Missouri. They had three sons, Alonzo, Frank and Jonathan. After some years Clark died and his wife married Harris Coleman. Alonzo and Frank remained in Missouri; Jonathan came back to Kentucky and located in Greenville, where he went to schoo; he afterwards married Jane Luckett. Jonathan lived and died in Muhlenberg county. No children.

Angeline Pennington married John Gray. No children. They located in the southern part of Christian county. Gray was a great horse man; he followed horse racing and gambling.

We now come to Alonzo and Morton Pennington. Alonzo married Emiline Oates, a daughter of Jethro Oates, a respectable farmer. Jethro Oates was a son of Jesse Oates, a pioneer settler of Muhlenberg County. Jesse Oates was married twice. He was the father of eighteen children, fifteen of whom reached their years of maturity. Jesse Oates was the ancestor of all the Oates in Muhlenberg, Hopkins and Christian counties.

Morton Pennington married twice, his first wife was Jackie Wells, a daughter of Micajah Wells, of Muhlenberg county. He was a respectable man and was at one time sheriff of the county, and represented the county in the legislature. Morton's second wife was a Goad, a sister of Peter Goad, once a prominent farmer of Hopkins county.

Now we shall attempt to give a general detail concerning the lives and conduct of these Pennington boys, but only a brief reference.

Alonzo Pennington was a more intelligent man than Morton, neither of them were educated above backwoods culture. Their education was limited to the disadvantages of pioneer life. Alonzo Pennington was above the ordinary intelligence in many respects; and if he had not been governed by certain damaging traits of character and had been better educated, he might have made a brilliant man of his day; but unfortunately, his brightness and his virtue became his weakness in life. His evil propensities and tendensies were his master and led him into disaster. Alonzo had an attractive appearance, magnetic and a prepossessing demeanor and could easily gain the confidence of all those with whom he might associate that were not conversant with his evil disposition; his deportment was gentle and polite; his conversation was smoothe and attractive with strangers. He was a good discerner and manipulator and became the leader in the perpetration of crime and led the way to the violation of law. It was during his day the regulators were in full force in Muhlenberg and Christian counties. But for years Alonzo Pennington out generaled them. He laid his plans of mischief that were hard to detect; although many of his confederates were severely whipped by the regulators, he always had an avenue to escape their clutches. He also succeeded in out generaling the courts by always having witnesses to prove his innocence and to establish all necessary alibies, and his success in evading the penalties of the law made him bold and daring.

The Pennington boys did much of their mischief abroad. It is said they would take trips and be gone for weeks and months, and when they would return full handed, often bringing back fine race horses with which they would win money from the horse men of Muhlenberg county and of Christian county.

Without following the course and character of the Penningtons further, would say that the boldness and entrepidity of Alonzo led him to be charged with murder, which was well planned, but was detected. There was a man by the name of Davis that was missing in Christian county. Inquiry was made as to his whereabouts and no one seemed to know. Alonzo Pennington, with some others, were last seen with Davis. Pennington reported that he had bought Davis out, his farm and all he possessed, except a bald face horse which Davis rode to Illinois. It seemed that Davis was unmarried and had no family. It is said that Pennington made some different statements as to the whereabouts of Davis. He had a deed to Davis' property; but the regulators were not satisfied with Pennington's report and believed him guilty of the murder of Davis, and they began a search. They found the bald face horse in a pen in the woods, near the home of Frank Cisney, who was considered a confederate of Pennington. The regulators whipped him severely and made him divulge enough to implicate Pennington in the murder of Davis and put them on the track. Cisney, by some means, escaped from the regulators and made his way to Michigan, where he reformed and made a good citizen and prosperous living. Frank Cisney was an orphan, his parents dying when he was small; he was a nephew of Bob Cisney, a pioneer settler of Muhlenberg county and the ancestor of the Cisneys about Rosewood. Upon search, the body of Davis was found hidden in a cave in Christian county, and steps were at once taken to capture Alonzo Pennington. Pennington was away from home, but on returning home, he learned that the body of Davis had been found, and when he reached his home he found the regulators assembled about it. He slipped in the back way to his stable and got his best horse and rode off, leaving the regulators to conjecture as to his whereabouts. He continued to travel until he reached the border line of Texas and the Indian Territory, where he made a halt. A reward was offered, and a man by name of Bowland, followed his track and captured him while playing the violin for the Indians. Alonzo was said to have been a mater violinist and could charm an audience with his music. Pennington was brought back to Hopkinsville, tried, convicted, and executed, principally upon circumstancial evidence. Others that were suspected of being guilty and confederates escaped are left the state. Morton Pennington was severely whipped and drove from the state. Pennington's trial created much interest and excitement; every effort was made by the defense and prosecution. He was convicted of murder and sentenced to hang. Pennington claimed to be innocent of the killing of Davis until the last. And it is said that a confederate of Pennington, dying in Illinois, afterwards confessed that he did the actual killing of Davis.

Thus ended the career of a man in the prime of life and vigor of his years, a man whose brain and genius was above the average. And if his intelligence and talent had been well directed, he might have been useful to his country and generation and he could have written his name upon the scroll of honor and fame, which would have been a solace and consolation to his posterity. Being reared upon the lap of luxury and had every advantage of his day to have made himself notable and noted, alas, he became a subject for the perpetration of crime and cruelty upon his fellowman, and at last wrote his name in ignominy and shame upon the gallows of disgrace, and placing a reproach upon his partner in life and his young family, shadowing their lives with conduct that cast a gloom over their future. Was this occurrence the result of fate, or was Pennington a creature of circumstances, of the conditions and surroundings. If he had been born at another time and in another place, might not his name today be a star in the constellation of the illustrious and renowned.

Naver before or since in this section of the state has there been a hanging of so wide spread interest manifested as was in the hanging of Alonzo Pennington, which happened sixty-five years ago at Hopkinsville. Not many are living now that witnessed that scene. People from Greenville and from the county and from other counties went to Hopkinsville. A large crowd was gathered, eager and anxious to see the sight of a man dangling between the heaven and the earth. A wonderful lesson could have been learned from that tragis scene. As the surging crowd saw the dying man hanging by a rope, could they have thought that the unfortunate criminal was not always vile and was not born a fiend, but once a bright eyed boy with a heart full of love, devotion and sympathy, chaste and untrammeled with the vices of time, a boy whose hopes and desires were to be great and good; but alas, step by step he was gently led by the evil genius of time very gates of misery and forced to sacrifice his life on the altars of degradation and crime and to be lifted up before the public gaze of his fellow man, an object of scorn and villification. Was there any sympathy for him in that large crowd witnessing the last scene of his eventful life? Although dying an ignominious death, perhaps there were some friends who stood off with sympathetic hearts and when they saw him struggling for his life and breath, through pity and mercy dropped for him a tear.

It was a sad and unfortunate scene, and while the great crown of people were frenzied with excitement and curiosity, as if to witness a circus show, at a disconsolate home, far from the scene of the dying father, husband and son, were grouped together, with broken hearts and bleeding, in tears and gloom, an aged mother, a devoted wife and helpless children, without hope. How many of the unfortunate since that day have followed the footsteps of Pennington in the battle of life and have been caught upon the evil snare of time.

The families of Alonzo and Morton Pennington remained in Christian and Hopkins counties and proved to be good citizens and respectable people. They have died and scattered until the Pennington name is about extince.

The obituary which follows should be of considerable interest to a number of people who have sought it for some time. It appeared in THE RECORD, Greenville, Ky., Sept. 30, 1909:

Death of Uncle Obe Strader

On September 25, one of the oldest and most respected citizens of Muhlenberg county passed away in the person of 0. W. Strader, familiarly known as "Uncle Obe." He died at the residence of his youngest son, Wash Strader, where he had made his home since the death of his wife some twenty-five years ago. Mr. Strader was born in North Carolina about 1805 and married Miss Polly Carver about 1828. The next year he emigrated to Muhlenberg county and located near Sulphur Spring. He was the father of nine children, three girls and six boys. Three of these boys, David, James and Wash are still living, eminently respected and influential citizens. David Strader is a citizen of Logan county, the other two being citizens of the county of their birth.

The family which "Uncle Obe" founded is one of the most numerous in the State. From the nine children he has thirty-eight grandchildren, one hundred great-grandchildren, and five great-grandchildren now living. Few men are permitted to live to see their offspring so numerous as this.

Mr. Strader was very fond of out door sports, especially fishing and hunting and was regarded as an expert at these two arts up until a few years ago. He remained hale and vigorous until a short time before his death. He had a strong mind as well as a strong body and retained full possession of all his faculties to a remarkable degree. He was one of those men whose heart never grew old. He had a bright, genial disposition and always looked upon the sunny side of life. He was a true and loyal friend, beloved by all who knew him. He was a devout Christian and lived for many years a consistent and active member of the Christian church.

Few funerals in this county have been so largely attended as was his, and few men have been laid away with the deep regret of so many people. His body rests in the quiet little burying ground known as McPherson grave yard, and his memory will not only be perpetuated by his numerous progeny, but will be kept alive by the mighty host that knew him and loved him for his sterling worth of character.

John Caldwell's company; that his original declaration was made on the 2nd of June, 1818, as appears by his certificate of pension dated 24 April, 1820. And I do solumnly swear I was a resident citizen of the United States on the 18 day of March, 1818. I have not by gift, sale or any other manner disposed of my property so as to diminish it, to bring myself within the provisions of Act of Congress to provide "for certain persons engaged in the land & naval services of the United States in the Revolutionary War" passed on the 18th day of March, 1818; that I have not nor has any person in trust for me any property or securities, contracts or debts due to me, nor do I have any income other than what is contained in the skedule hereto annexed and by me subscribed.
